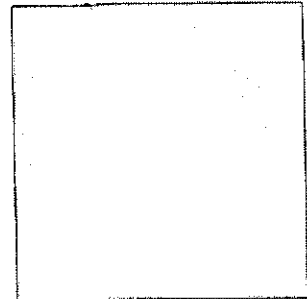


Your Affiant is Trooper Brian V. NOLL of the Pennsylvania State Police, Troop N Criminal Investigation Assessment Officer. I have been employed with the Pennsylvania State Police since 2008 and assigned as a Criminal Investigator since 2012. I have been assigned as the Criminal Investigation Assessment Officer since 2019. Throughout my career, I have conducted hundreds of criminal investigations, including numerous homicide investigations.

On Thursday, December 30, 2022, the Pennsylvania State Police were assisting the Moscow Police Department (Moscow, Idaho), Idaho State Police, and Federal Bureau of Investigation with a criminal homicide investigation. On the same date, Bryan C. KOHBERGER was taken into custody in Chestnuthill Township, Monroe County, Pennsylvania, based upon an active arrest warrant for murder in the first degree, issued through the Moscow Police Department and Latah County Prosecutor's Office (Idaho).


The arrest warrant was confirmed through NCIC with NIC: W601158522.

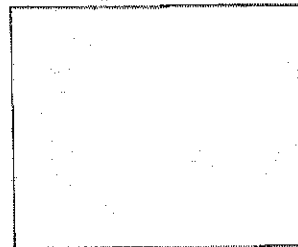
