





Median Number of Days to Disposition for Appeals Concluded in 2013



Appeals Docketed by Case Type (7,969)



Appeals Docketed by County (7,969)










Dispositions in 2013 Type (7,807)





Superior Court Disposition of Filed Decisions (5,315)



Superior Court Disposition of Filed Decisions (5,315) by Percentage of Each Category








Supreme Court Treatment of Superior Court Cases

Disposition of Appeals from Superior Court Cases (76)


