



Appeals by District in 2018








Cases by Docket Type in 2018




Wiretap Docket by Docketing District in 2018







Miscellaneous Docket Applications (Applications unrelated to active docketed appeals)




Wiretap Applications by Docketing District





Share of Published Decisions Among Filed Decisions










Median Number of Days to Disposition for Appeals Concluded in 2018















Certified Record Filing Date to Filed Decision









Supreme Court Disposition of Allowed Appeals from Superior Court Decisions in 2018


