ADDITIONAL JOINT STIPULATIONS OF FACT PURSUANT TO C.J.D.R.P. NO. 502(D)(2) AND IDENTIFICATION OF BOARD AND RESPONDENT TRIAL EXHIBITS

AND NOW, this 3rd day of September, 2021, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board), and Magisterial District Judge Andrew T. LeFever (Respondent), by and through their undersigned counsel, and file these Additional Joint Stipulations Of Fact Pursuant To C.J.D.R.P. No. 502(D)(2), and identify the Board and Respondent Trial Exhibits as follows:

ADDITIONAL JOINT STIPULATIONS OF FACT

- 61. At his March 12, 2020 deposition before Board counsel, Respondent testified that, as a LCDC Committee Person at the February 11, 2019 public LCDC meeting, he believed that he voted for the LCDC to endorse the five candidates for school director.
- 62. At his March 12, 2020 deposition before Board counsel, Respondent testified that, as a LCDC Committee Person at the February 11, 2019 public LCDC meeting, he voted for the LCDC to endorse candidates for Lancaster City Council.
- 63. Lauren Edgell was present at the February 11, 2019 public LCDC meeting and she would testify that Respondent did not vote to endorse candidates for either school director or Lancaster City Council.
- 64. Subject to the Board's pending Motion in Limine, Alan Silverman was present at the February 11, 2019 public LCDC meeting and he would testify that he does not remember if Respondent voted to endorse a candidate for either school director or Lancaster City Council.

65. Subject to the Board's pending Motion in Limine, Lauren Slesser was present at the February 11, 2019 public LCDC meeting and she would testify that she cannot recall whether Respondent voted to endorse candidates for either school director or Lancaster City Council.

By submitting these Additional Joint Stipulations of Fact, the Board and Respondent agree they shall be bound by them as facts of the case upon which the Court of Judicial Discipline, in conjunction with any facts produced at trial, may render a decision.
