Dear Prothonotary Krimmel:

The Democratic National Committee and the Pennsylvania Democratic Party were permitted to intervene in these actions before the Commonwealth Court in support of the Commonwealth Department of State and the Acting Secretary. On January 28, 2022, the Commonwealth filed a Notice of Appeal of this Court's Memorandum Opinions and Orders to the Pennsylvania Supreme Court. In accordance with Pennsylvania Rules of Appellate Procedure 1731 and 1736, this Court's orders are thus automatically stayed, pending the Supreme Court's expedited consideration of the appeal.

Pursuant to Rule of Appellate Procedure 123(b), the Democratic National Committee and the Pennsylvania Democratic Party provide this letter stating that they will not submit an answer to the Application to Terminate and concur with the Commonwealth's Answer in Opposition to that Application.
