PETITION TO SET ASIDE NOMINATION PETITION

Petitioners Theresa Donnelly, John Donnelly, and Scott Armstrong, by and through counsel, respectfully aver as follows:

1. The Petitioners are duly qualified electors registered as Republicans in the 26th Legislative District.
2. The Respondent is the above referenced Republican Candidate for the General Assembly in the 26th Legislative District.
3. On or before February 13, 2024, the Candidate filed a Candidate Affidavit and Nomination Petitions with the Department of State. A copy is attached as Exhibit A.
4. For the reasons set forth in greater detail in the attached Exhibit B, the Candidate’s Nomination Petition fails to contain the required number of properly ascribed signatures.
5. The candidate has submitted **328** signature lines; **71** of these lines are challenged for not being in compliance with the requirements of the Election Code.
6. The Nomination Petition therefore fails to conform to the requirements of the Election Code, 25 P.S. §2867 et seq., and must be set aside and the Candidate’s name not be placed on, or stricken from, the ballot. Candidate has not submitted the requisite 300 valid signatures from registered Republicans in the district.
7. Section 977 of the Election Code, 25 P.S. §2937, provides that a court shall set aside nomination petitions which are defective.
8. Petitioners respectfully reserve the right to add such additional objections as are appropriate at the time of hearing.


