PETITION TO SET ASIDE NOMINATION PETITION

Petitioners, John Quinn and Corey Hepler, by and through their undersigned counsel, hereby petition this Honorable Court to set aside the Nomination Petition of Penelope J. Murphy, a candidate for the Republican nomination for Representative in the General Assembly from the 107th Legislative District in the Republican Primary of May 17, 2022.

In support of this Petition, the following is averred:

- 1) Petitioner John Quinn is an adult individual and a duly qualified Republican elector in the 107th Legislative District who resides at 131 Beech Drive, Kulpmont, PA 17834.

2) Petitioner Corey Hepler is an adult individual and a duly qualified Republican elector in the 107th Legislative District who resides at 125 Beech Drive, Kulpmont, PA 17834.

3) Respondent is the candidate, Penelope J. Murphy, an adult individual residing at 205 Johns Estate Road, Coal Township, PA 17866.

4) This Petition is brought pursuant to the Pennsylvania Election Code, at 25 P.S. § 2937.

5) This Court has original jurisdiction of this matter pursuant to 42 Pa. C.S. § 764.

6) On or about March 28, 2022, the Candidate filed a Nomination Petition and related documents to file as a candidate for the Republican nomination for Representative in the General Assembly from the 107th Legislative District in the Republican Primary of May 17, 2022 (Attached hereto as **Exhibit A**).

7) The number of valid signatures of registered and enrolled members of the Republican Party for Representative in the General Assembly from the 107th Legislative District is 300. 25 P.S. § 2872.1(14).

I. INSUFFICIENT NUMBER OF VALID SIGNATURES

8) Candidate filed 14 petition pages purported to contain 313 signatures.

9) The Department of State invalidated two incomplete entries, leaving Candidate with 311 signatures.

10) Petitioners hereby challenge 44 individual signatures contained on Candidate's Nomination Petition. The signatures challenged and the reasons therefore are detailed in **Exhibit B** attached hereto and incorporated herein by reference.

11) Due to the number of invalid signatures contained in Candidate's Nomination Petition, Candidate's Nomination Petition does not contain enough valid signatures for Candidate to appear on the May 17, 2022 ballot as a candidate for the Republican nomination for Representative in the General Assembly from the 107th Legislative District.

II. FALSE STATEMENT OF CIRCULATOR/ IMPERMISSIBLE CIRCULATOR– GLOBAL CHALLENGE TO PAGE 8

12) Petitioners aver that the "Statement of Circulator" contained on Page 8 of the Nomination Petition is materially false, and as such, the signatures on that page should be stricken in their entirety.

13) Pursuant to Section 909(a) of the Election Code, only registered and enrolled members of the same political party as the candidate may circulate that candidate's nomination petition. 25 P.S. § 2869; *see also In re Nomination Petitions of Smith*, 182 A.3d 12 (Pa. Commw. Ct. 2018) (upholding constitutionality of same-party requirement of circulators contained in 25 P.S. § 2869).

14) Circulators of a Nomination Petition must sign a "Statement of Circulator", which includes declaring that the information in the Statement is true

and correct subject to the criminal penalties of 18 Pa. C.S. § 4904. The text of the Statement of Circulator, *inter alia*, includes the circulator’s statement that the circulator is “duly registered and enrolled as a member of the political party designated in this nomination petition . . .”

15) Upon information and belief, Circulator Jenny Berry is not enrolled as a member of the Republican Party.

16) Accordingly, the Statement of Circulator signed by Jenny Berry on Page 8 of Candidate’s Nomination Petition is materially false, in that Jenny Berry cannot truthfully attest that she is a member of the political party designated in the nomination petition, and therefore Page 8 of the Nomination Petition is in violation of 25 P.S. § 2869.

17) As such, the 13 signatures obtained by Jenny Berry on Page 8 of the Nomination Petition “**must** be stricken pursuant to the plain language of Section 909(a).” *In re Nomination Petitions of Smith*, 182 A.3d 12, 23 (Pa. Commw. Ct. 2018) (emphasis added).

18) Between the individual signature challenges and the global challenge to Page 8, Candidate does not have 300 valid signatures from registered and enrolled members of the Republican Party for Representative in the General Assembly from the 107th Legislative District.

WHEREFORE, Petitioners respectfully request that this Court grant their Petition to Set Aside Nomination Petition and enter an Order:

- (1) To set aside the Nomination Petition of Penelope J. Murphy as a candidate for nomination of the Republican Party for the office of Representative in the General Assembly from the 107th Legislative District to be voted on in the May 17, 2022 Primary Election for failure to satisfy the requirement of the Election Code, 25 P.S. § 2601 *et seq.*, as aforesaid;
- (2) Removing Candidate's name from the Republican Primary ballot for the May 17, 2022 Primary Election;
- (3) Directing the Candidate to pay for the cost of the proceeding including witness fees; and
- (4) Providing for such other relief and sanctions against the Candidate as the Court may deem appropriate.


