<u>Supreme Court of Pennsylvania</u>	
Allocatur Docket	The docket for petitions seeking the grant of appellate review of a decision by an intermediate appellate court (i.e. the Commonwealth Court or Superior Court).
Ancillary Petition	A petition filed on an open docket seeking relief apart from the requested relief. On the merits, e.g. a petition for an extension of time to file a response.
Capital Case	A case wherein a sentence of death has been imposed by a court of common pleas.
Direct Appeal	A case under review as a result of a statutory or constitutional right of appeal.
Disciplinary Matter	Involves attorney disciplinary cases as prosecuted by the Office of Disciplinary Counsel.
Full Opinion	The Court's disposition of a case containing a written explanation of its rationale.
King's Bench Review	Discretionary review undertaken by the Supreme Court of a matter pending in a lower tribunal. Such review can be by way of petition or by the Court's own initiative.
Per Curiam	Translates as "By the Court" and refers to actions of the whole court as opposed opinion or orders by an individual Justice or Justices.
Petition for Review	Petition brought under Chapter 15 of the Pennsylvania Rules of Appellate Procedure.
Summary Disposition	The Court's disposition of a case without seeking brief or argument; occurs when right of applicant is clear and the Court's decision needs little or no explanation.
Supreme Court Original Jurisdiction	The limited jurisdiction described in the Judicial Code at 42 Pa C.S. Section 721, which includes habeas corpus, actions in mandamus and prohibition directed to courts of inferior jurisdiction, and actions in quo warranto.
<u>Common Pleas Criminal</u>	
Age of Pending Cases	A breakdown of active criminal caseload by the interval of time elapsed from the date the case is filed in the clerk of court's office to the end of the year. Note that age as defined here does not include lower court time elapsed from complaint or arrest until filing at the common pleas level.

ARD (Accelerated Rehabilitative Disposition)	A disposition classification for cases in which the defendant is accepted into a state or county ARD program, which is a pre-trial diversionary program similar to probation. Upon successful completion of all conditions of the program, the defendant may petition the court to dismiss the charges against him.
Case (Common Pleas Criminal)	A Misdemeanor or Felony case held for or waived to common pleas court after a Preliminary Hearing, waiver of a preliminary hearing or a transfer from juvenile court. The unit of count is the individually numbered docket transcript (OTN). Cases are counted as New Cases Received at the date of filing in the clerk of court's office. Cases Reopened refers to the number of cases previously counted as disposed which have been reactivated at the common pleas level, such as those involving fugitives returned. Cases Pending refers to the number of active cases at the common pleas level which have not been adjudicated. Cases Disposed refers to the number of terminations of cases pending at the common pleas level; counted when the judge accepts a guilty plea, renders a verdict, the jury returns a verdict, or the case is otherwise adjudicated, transferred out of common pleas criminal court, or placed in inactive status. A common pleas disposition is counted at the time of adjudication and not at the time of sentencing. Cases Awaiting Sentence refers to those cases in which a guilty verdict has been rendered or a guilty plea accepted, but for which the penalty has not yet been imposed upon the accused.
Dismissals Nol Pros, Etc.	A disposition classification for cases in which <ol style="list-style-type: none"> 1) (Dismissal) the jurisdiction of the court is terminated by the court, or 2) (Nol Pros, Nolle Prosequi) a formal notice upon the record that the prosecution will not proceed with the case that has been accepted by the court, or 3) a demurrer is sustained, the case is quashed, etc.
Felony	A statutory class of crime generally more serious than a Misdemeanor. For Reporting purposes, murder of the first degree is counted with felonies.
Guilty Plea	A disposition classification for cases in which the defendant admits having Committed an offense for which he is charged, or admits to a lesser felony, misdemeanor or summary offense.
Inactive Case	A disposition classification for cases in which the defendant has been unavailable for court processing for a minimum of 45 days; including defendants declared fugitive, those in the military, those in the custody of another jurisdiction, etc.
Jury Trial	A disposition classification for cases adjudicated following verdict of a jury.
Misdemeanor	A statutory class of crime generally more serious than a summary offense and less serious than a Felony. The maximum term of imprisonment for a misdemeanor may not exceed five years. For a summary offense, the maximum term of imprisonment may not exceed 90 days.
New Cases Received	See Case.
Non-Jury Trial	A disposition classification for cases adjudicated by verdict of a judge.
Other (Disposition)	A disposition classification for cases terminated by means that cannot accurately be classified in the other dispositional categories; including transfers to juvenile court, cases abated by death of defendant, etc.
Preliminary Hearing	Hearing by a judicial officer to determine whether a person charged with a crime Should be held for trial in common pleas court.

Rule 1100	A disposition classification for cases dismissed under Pennsylvania Rule of Criminal Procedure 1100 (Prompt Trial).
 <u>Common Pleas Civil</u>	
Age of Pending Trial-Ready Cases	A breakdown of Trial-Ready caseload by the interval of time elapsed from the date the case is certified or Praeciped for Trial or otherwise determined to be Trial-Ready to year-end.
Arbitrated Cases	A classification for those Cases Docketed which are Civil Actions disposed by a Board of Arbitrators following an evidentiary hearing. Note that these cases are Counted at disposition, not at referral to arbitration.
Arbitration Appeal	A classification for those civil cases appealed de novo from an arbitration award; counted when the case is determined to be Trial-Ready.
Cases Docketed	The number of Civil Actions or actions in Equity which have been filed in the prothonotary's office and which are intended to be litigated. At this initial point, cases are not yet Trial-Ready.
Cases Pending	The number of civil Trial-Ready Cases which are not yet disposed.
Civil Action	A category of civil cases in which an action is brought to enforce, redress or protect private rights. It is an action heretofore asserted in assumpsit or trespass (see Rule of Civil Procedure 1001).
Disposition	(1) Of an arbitration case: the decision by a Board of Arbitrators following an evidentiary hearing; (2) Of a Trial-Ready Case: termination of the case by a verdict reached by a judge or a jury, a settlement reached by the litigants, the striking of the case from the trial-ready list, or other action which resolve the issues of the case.
Equity	A category of civil cases in which an action is brought whereby the plaintiff generally seeks equitable relief (e.g., specific performance, injunctions).
Jury Trial	A disposition classification for Trial-Ready Cases resolved following the verdict of a jury.
New Cases Filed	The number of cases in which counsel has indicated to the court during the year That the case is ready to go to trial; or, for those counties which do not certify or praecipe for trial or for pre-trial, the number of cases placed on the trial list during the year.
Non-Jury Trial	A disposition classification for Trial-Ready Cases resolved following verdict of a judge.
Other (Civil Case)	A residual category of civil cases which are neither Civil Actions nor Equity cases. This classification includes mandamus, replevin, mortgage foreclosure, paternity, etc.; but does not include support, custody, visitation, or divorce cases, which are included in the Family Court section.
Other (Disposition)	A disposition classification for Trial-Ready Cases by transfer to arbitration, transfer to inactive status, or other means that cannot accurately be classified under the other dispositional categories.
Praecipe for Trial	A form indicating to the prothonotary that a civil case should be placed on a trial list. See New Cases Filed, Trial-Ready Case.

Restored Cases	A category of civil cases which have been restored (re-certified or re-praeciped) to a trial list after having been Stricken from the list.
Settlements	A disposition classification for Trial-Ready Cases in which the litigants in the Dispute come to an agreement over the issues at stake.
Stricken	A disposition classification for cases removed from the trial-ready list.
Trial-Ready Case	A Civil Action, Equity, or Other civil case which is certified or praecipied for trial or for pre-trial; or, for those counties which do not certify or praecipie, a Civil Action, Equity, or Other civil case which has been placed on the trial list.
<u>Family Court</u>	
AFDC	A classification of Support cases for those cases in which a wage earner is absent from the home and the children are recipients of public welfare in the category of Aid to Families with Dependent Children (AFDC).
Cases Filed	The number of cases initiated during the year. See Support, Custody/Partial Custody/Visitation, Divorce, Dependency, and Delinquency for a definition of Cases Filed by category.
Cases Processed	The number of cases adjudicated during the year. Cases adjudicated following a conference or hearing before a conference officer, hearing officer, or master are counted as processed by a Non-Judicial Officer. Cases heard before a judge are counted as processed by a Judge. Cases processed by Other means include cases settled or withdrawn before a conference or hearing is held. See Support, Custody/Partial Custody/Visitation, Divorce, Dependency, and Delinquency for definition of Cases Processed by category.
Custody/ Partial Custody/ Visitation	A category of cases which are legal proceedings to determine the right: <ol style="list-style-type: none"> 1) (Custody) to keep, control, guard, care for and preserve a child; 2) (Partial Custody) to take possession of a child from the custodial person for a specified length of time; 3) (Visitation) to visit a child, without the right to remove a child from custodial person's control. <p>Cases Filed are counted when a complaint or petition to modify an existing order is filed. Cases Processed are counted when a final order (or equivalent) has been issued adjudicating the complaint or petition.</p>
Delinquency	A type of juvenile case which involves an act by an individual under the age of 18 which has been designated as a crime under Pennsylvania law or under local ordinances. (See 42 Pa. C.S.A. Section 6302 for a more extensive definition of "delinquency.") Cases Filed are counted at referral to a juvenile intake officer. Cases Processed are counted when the juvenile intake officer informally adjusts the case, or when a master or judge adjudicates the case after the filing of a petition by the juvenile intake officer.
Dependency	A type of juvenile case which involves the absence of the proper parental care or supervision necessary for the physical, mental, emotional or moral health of an individual under 18 years of age. (See 42 Pa. C.S.A. Section 6302 for a more extensive definition of "dependency.") Cases Filed are counted when a petition is filed. Cases Processed are counted when an order adjudicates the petition.
Divorce	A legal proceeding to dissolve a marriage. Cases Filed are counted when a complaint is filed. Cases Processed are counted when a decree or order is issued granting or denying the divorce.
Judge (Disposition)	See Cases Processed.

NON-AFDC	A classification of Support cases which includes those cases not classified under AFDC.
Non-Judicial Officer (Disposition)	See Cases Processed.
Other (Disposition)	See Cases Processed.
Support	Those cases in which a complaint has been filed requesting the court to require maintenance of a spouse or child by a person required by law to provide such maintenance. Cases Filed are counted at the filing of a complaint or petition, and include local and incoming reciprocal cases, petitions for modification or termination, and alimony pendente lite. Cases Processed are counted when an order has been issued adjudicating the complaint or petition.
 <u>Orphans' Court</u>	
Account	A statement prepared by a Fiduciary at the close of his or her administration of an estate to reflect transactions that have occurred. The statement is presented to the court as part of the process whereby the fiduciary seeks discharge from liability for the events disclosed. Cases Filed refers to the number of these statements filed with the Orphans' Court Clerk during the year. Cases Disposed refers to the number of accounts confirmed; i.e., a confirmation is a judicial determination that the account filed is in proper order.
Adoption	A legal proceeding in which a child's rights and duties toward his or her birth parents are terminated and similar rights and duties toward his or her adoptive parents are substituted. Cases Filed refers to the number of petitions for adoption filed during the year. Cases Disposed refers to the number of final decrees entered either granting or denying a petition.
Appointment of Guardians	A proceeding through which a determination is made regarding an individual's capacity to make or communicate a responsible decision that concerns his or her person or property (see Incapacitated Person). Cases Filed refers to the number of petitions for the appointment of a guardian (see Fiduciary) for a person or estate filed during the year. NOT included are petitions for the appointment of a guardian for the person or estate of a minor; petitions to appoint a guardian ad litem; petitions to adjudicate a person competent who was previously adjudged incompetent; petitions for the sale, exchange, mortgage or lease of real property, and so on. Cases Disposed refers to the number of orders issued adjudicating pending petitions.
Auditor, Master or Examiner (Contested)	A category of dispositions referring to the number of cases in which disputed issues of fact were resolved before a quasi-judicial officer (auditor, master or examiner).
Cases Filed	See specific classifications (Account, Adoption, Relinquishment/Termination, Appointment of Guardians).
Cases Disposed	See specific classifications (Account, Adoption, Relinquishment/Termination, Appointment of Guardians).
Fiduciary	A person or institution with a legal responsibility for the money or property of another. The term includes executors, administrators, guardians, and trustees subject to the jurisdiction of the Orphans' Court Division.

Incapacitated Person	An adult whose ability to receive and evaluate information effectively and communicate decisions in any way is impaired to such a significant extent that he or she is partially or totally unable to manage financial resources or meet essential requirements for physical health and safety.
Judge (Contested)	A category of dispositions referring to the number of cases in which disputed issues of fact were resolved in a hearing before a judge. Includes single cases with multiple hearings, at least one of which was held before a judge.
Relinquishment/ Termination	Relinquishment is the voluntary ending of the rights of a parent with respect to his or her child. Termination is the involuntary ending of the rights of a parent with respect to his or her child. Cases Filed refers to the number of petitions filed either to relinquish or to terminate parental rights during the year. Cases Disposed refers to the number of final decrees entered either granting or denying the petition.
Uncontested	A category of dispositions referring to the number of cases disposed in which there were no evidentiary hearings.
 <u>Jury Utilization</u>	
Average Jury Fees Per Trial	An overall measure of juror usage calculated by dividing Juror Fees Incurred by the number of Jury Trials Begun.
Juror Days	The number of prospective jurors reporting to the courthouse in anticipation of voir dire. If a juror reported more than once, each day is counted.
Juror Days Per Voir Dire Starts	The average number of prospective jurors needed for one voir dire, calculated by dividing Juror Days by Voir Dires Begun.
Jury Fees Incurred	Juror fees incurred by the county and the state this year.
Jury Trials Begun	Number of jury trials begun this year.
Number Sent To Voir Dire	The number of prospective jurors sent to voir dire. If a juror was sent more than once, each voir dire attended is counted.
Percent Zero Panel Days	The percentage of Pool Days in which prospective jurors reported to the courthouse but no voir dire was begun, calculated by dividing Zero Panel Days by Pool Days and multiplying by 100.
Pool Days	The number of days prospective jurors reported to the courthouse in anticipation of voir dire.
Sworn Jurors	The number of jurors sworn for trial. If a juror was sworn more than once, each swearing-in is counted.
Trial Attendance Rate	The percentage of jurors in voir dire selected to serve on a jury, calculated by dividing Sworn Jurors by the Number Sent To Voir Dire and multiplying by 100.
Voir Dire Attendance Rate	The percentage of prospective jurors sent to voir dire, calculated by dividing the Number Sent To Voir Dire by Juror Days and multiplying by 100.
Voir Dires Begun	The number of voir dires begun this year.

Zero Panel Days	The number of days prospective jurors reported to the courthouse in which no Voir dires were begun.
<u>District Justice</u>	
Bound To Court	A disposition category for Criminal referring to the number of cases for which a prima facie was established and the defendant was held for court.
Civil Complaint	A civil action involving a claim of \$8,000 or less.
Cases Disposed	The number of cases in which a district justice renders a decision, a guilty plea is entered, or some other final decision is made. A case is counted as disposed even though all fines and costs may not have been collected.
Complaint Withdrawn	A disposition category for Civil Complaints and Landlord/Tenant Actions, referring to the number of cases in which a plaintiff withdrew the complaint.
Criminal Case	The set of Felony, Misdemeanor or Escalating Summary charges arising from a single criminal incident. When an incident involves co-defendants, the prosecution of each defendant is counted separately (i.e., only one defendant per case).
Default Judgment	A disposition category for Civil Complaints, and Landlord/Tenant Actions, referring to the number of cases in which a judgment was entered for the plaintiff because the defendant did not appear.
Dismissal	A disposition category for Criminal, Private Criminal Complaints, Traffic Citations and Non-Traffic Citations, referring to the number of cases dismissed or discharged by the district justice.
Dismissal With Prejudice	A disposition category for Civil Complaints and Landlord/Tenant Actions. An adjudication on the merits, and final disposition, barring the right to bring or maintain an action on the same claim or cause.
Dismissal Without Prejudice	A disposition category for Civil Complaints and Landlord/Tenant Actions which does not bar complainant from bringing suit again on the same cause of action.
Felony/Misdemeanor/	A Felony is a statutory class of crime Escalating Summary generally more serious than a misdemeanor; murder of the first degree is also counted with felonies. A Misdemeanor is a statutory class of crime generally more serious than a summary offense and less serious than a felony. The maximum term of imprisonment for a misdemeanor may not exceed five years. For a summary offense, the maximum term of imprisonment may not exceed 90 days. An Escalating Summary is a charge (e.g., retail or library theft) for which the grading as a summary or misdemeanor/felony is determined by the defendant's criminal history.
Guilty Plea	A disposition category for Criminal, Private Criminal Complaints, Traffic and Non-Traffic Citations referring to the number of cases in which the defendant admits having committed an offense for which he is charged. For Traffic and Non-Traffic Citations, guilty pleas include defendants submitting payment of fines and costs without pleading guilty on the citation forms.
Landlord/Tenant Action	Action of landlord/lessor against a tenant/lessee for the recovery of real property. The complaint may include a claim for rent due unpaid. Also included in this category are defendant claims against the plaintiff arising from occupancy of the premise.

New Cases Filed	The number of cases initiated during the year. Traffic and Non-Traffic cases are initiated by a citation. Civil Complaint, Landlord/Tenant Action, and Private Criminal Complaint cases are initiated by a complaint. The individually numbered docket transcript (OTN) is the unit of count for Criminal cases.
Non-Traffic Citation	Summary offense charges initiated by a police officer, other than those classified under Traffic Citation.
Order of Execution	The enforcement of a civil money judgment. The defendant's property is sold to satisfy the judgment.
Order of Possession	The enforcement of a Landlord/Tenant Action for possession of property.
Other (Disposition)	A disposition category for cases terminated by means that cannot accurately be classified in any of the other dispositional categories; e.g., death of a defendant.
Private Criminal	Summary offense charges initiated by a Complaint private citizen.
Prosecution Withdrawn	A disposition category for Criminal, Private Criminal Complaints, Traffic and Non-Traffic Citations referring to cases in which the prosecutor formally withdraws the charges.
Settled	A disposition category referring to cases in which the parties resolve the issues of the dispute.
Traffic Citation	Traffic Citations initiate summary proceedings for offenses under the Pennsylvania Vehicle Code, or for violations of local parking ordinances not covered by the Vehicle Code.
Trial	A disposition category referring to cases adjudicated by a district justice following an evidentiary hearing.
Waiver of Preliminary Hearing	A disposition category for Criminal Preliminary Hearing referring to cases forwarded to common pleas court after a preliminary hearing has been waived.
