## VEHICLE TYPE CODES

In an effort to standardize vehicle type codes for the electronic exchange of information with other state and federal agencies, the traffic entry screen has new vehicle codes. The new two digit codes shown below can also be displayed by pressing F4 on the Type field on the Traffic Entry screen. This change takes effect today.

These codes are recognized as the standard by the National Crime Information Center (NCIC) and will provide the necessary uniformity among the other state and federal agencies and databases when information is shared, including JNET functions. This change is also required in preparation for the electronic docketing initiative.
