***RE: Implementation of New Docketing System for Insurance Insolvency Cases; Notice of New Caption and Docket Numbers for the Reliance Insurance Company Insolvency Case and Related Ancillary Matters; Ancillary Matter Cover Sheet***

**ADMINISTRATIVE ORDER**

AND NOW, this 19<sup>th</sup> day of May, 2011, it is hereby ORDERED that effective June 1, 2011:

1. In order to more effectively manage insurance insolvency cases, the Commonwealth Court of Pennsylvania will implement a new docketing system for insurance insolvency cases. The new docketing system initially will be applied only to the above-captioned liquidation of the Reliance Insurance Company. Other pending insurance insolvency cases will be converted to the new docketing system in the future as directed by the Court.

2. In order to implement the new docketing system, the above-captioned matter, currently entitled *Michael F. Consedine, Insurance Commissioner of the*

*Commonwealth of Pennsylvania, as Statutory Liquidator of Reliance Insurance Company, Plaintiff v. Reliance Insurance Company, Defendant* and docketed at No. 269 M.D. 2001, shall be entitled *In Re: Reliance Insurance Company In Liquidation* and shall be docketed at No. 1 REL 2001. Effective June 1, 2011, all filings relating to the administration of the main Reliance Insurance Company estate in liquidation shall be filed with the new caption and docket number.

3. In addition, active ancillary matters previously docketed at No. 269 M.D. 2001 or given other miscellaneous docket numbers, including objections to notices of determination, applications by third parties seeking to file actions other than objections to notices of determination (heretofore often designated as petitions to intervene) and actions brought by the Liquidator against third parties, shall be assigned separate docket numbers in the “Reliance” (REL) docket. Active ancillary matters are hereby assigned new docket numbers as reflected on the list attached hereto as Exhibit 1, and effective June 1, 2011, all filings relating to these active ancillary matters shall be filed at the new docket number. The Chief Clerk is directed to give written notice of the new docket numbers to all parties in the active ancillary matters reflected in Exhibit 1. Upon review, if a party notices an omission or error in the docket entries listed in the new ancillary docket, these should be brought to the attention of the Court by sending a letter to the Chief Clerk.

4. New ancillary matters filed after the date of this Order shall be assigned a new REL docket number, and the Chief Clerk shall notify the parties of the new docket number.

5. Ancillary matters not relating to the administration of the main Reliance Insurance Company estate in liquidation and not docketed to No. 1 REL 2001, must contain a caption substantially in compliance with the example attached hereto as Exhibit 2. Insofar as prior case management orders prescribe a different caption format, the prior orders are superceded.

6. At the commencement of any ancillary matter not relating to the administration of the main Reliance Insurance Company estate in liquidation and not docketed to No. 1 REL 2001, the party initiating the ancillary matter shall complete a cover sheet substantially in the form set forth in Exhibit 3 and file it with the Chief Clerk. The Chief Clerk is directed to design a downloadable version of the ancillary matter cover sheet and to post it on the Commonwealth Court page of the Unified Judicial System website ([www.aopc.org](http://www.aopc.org)), and shall cause it to be posted on the Reliance Documents website ([www.reliancedocuments.com](http://www.reliancedocuments.com)).

7. The Liquidator is directed to serve this Order on the Master Service List. The Chief Clerk shall post this Order on the Commonwealth Court page of the Unified Judicial System website and shall cause it to be posted on the Reliance

Documents website. In addition, the Chief Clerk shall cause a copy of this Order to be published in the *Legal Intelligencer* and the *Pennsylvania Bar News*.
