

Pennsylvania's Unified Judicial System

Overview of the Pennsylvania Judicial System The Administrative Office of Pennsylvania Courts, also called the Administrative Office and the AOPC, is the administrative arm of the Pennsylvania Supreme Court. It was established in January 1969 following the Constitutional Convention of 1967–68, which defined the Supreme Court's authority for supervision and administration of all state courts.

The Court Administrator of Pennsylvania has been empowered to carry out the Supreme Court's administrative duties and is responsible for assuring that the business of the courts is promptly and properly disposed.

The Administrative Office conducts business from offices in Philadelphia and the Harrisburg area. In addition to the court administrator's office, the departments in Philadelphia include Research and Statistics and Judicial Services. The deputy court administrator's office is located in Harrisburg and includes Communications/Legislative Affairs and Administrative Services. Also found in Harrisburg are the Finance, Human Resources, Judicial Education and Judicial Security departments. Judicial Automation is in Mechanicsburg. Legal and Judicial Programs have offices in both Harrisburg and Philadelphia.

The Administrative Office's supervisory, administrative and longrange planning duties include:

- reviewing practices, procedures and efficiency at all levels of the court system and in all related offices
- developing recommendations to the Supreme Court regarding improvement of the system and related offices
- representing the judicial system before legislative bodies

- examining administrative and business methods used by offices in or related to the court system
- collecting statistical data
- examining the state of the dockets and making recommendations for expediting litigation
- managing fiscal affairs, including budget preparation, disbursements approval and goods and services procurement
- overseeing the security of court facilities
- supervising all administrative matters relating to offices engaged in clerical functions
- maintaining personnel records
- conducting education programs for system personnel
- receiving and responding to comments from the public
- providing legal services to system personnel
- publishing an annual report

A brief description of each unit of the AOPC and its functions follows.

Research and Statistics Department

The Administrative Office's Research and Statistics Department analyzes and evaluates the operations of the Unified Judicial System's (UJS) various components. During any given year, the department conducts a variety of studies, ranging from caseflow management reviews of individual trial courts to statewide evaluations of the safety and security of court facilities.

A core function of the department is to systematically assemble data on the caseloads of county and local courts, including the numbers and types of new, disposed and pending cases, and, for certain case types, the ages of the cases awaiting adjudication. The statistical information is reviewed and periodically verified through audits of county dockets. The Administrative Office annually publishes the data in the Caseload Statistics of the Unified Judicial System of Pennsylvania. This report is available from the AOPC page on the UJS website at www.pacourts.us.

The Administrative Office uses the statistical information gathered for many purposes, including the monitoring of county court system operations and development of policy initiatives consistent with its mandate under the Rules of Judicial Administration.

Among the departmental projects recently completed or now in progress are:

- a study of fees charged to litigants in domestic relations matters

- following the implementation of standardized civil cover sheets, ongoing technical assistance to counties to improve the quality and accuracy of the civil data
- development of new data products that expand the use and circulation of caseload data, such as county-specific executive summaries with time trend information, protection from abuse summary reports, dependency summary reports and civil case type summary reports
- a county-by-county assessment of civil court case management programs and procedures
- annual data collection cycles in the areas of medical malpractice filings and jury verdicts, guardianships and other specific case types
- annual submission of statewide data to the Pennsylvania Data Center, the National Center for State Courts Court Statistics Project and other data clearinghouses

Legal Department

AOPC Legal Department lawyers provide advice and counsel to the state court administrator, state court judges and personnel of the Unified Judicial System on legal, administrative and policy matters.

Litigation Counsel

Legal Department litigators represent Pennsylvania court entities, judges and state-paid court personnel in litigation matters, predominately in federal court, including civil rights and constitutional issues, employment cases, petitions for review of governmental actions and to establish the rights and duties of public officials. AOPC representation is not provided in criminal or disciplinary actions. Sample cases in defense of the judiciary include

Judicial Programs Department

The mission of the Judicial Programs Department is twofold: to assist court administrators, judges and staff throughout Pennsylvania to ensure the efficient operation of Pennsylvania's minor and trial courts and to promote equitable access to and administration of justice.

In addition to providing support to judicial districts on issues related to their administrative functions, the department works closely with the Supreme Court and other departments

within the AOPC to assist with implementation of policies, procedures, rule changes and reporting standards. This assistance includes:

- reviewing and assessing local court requests for state-level court administration personnel and other related human resources needs
- collecting, analyzing and disseminating data and information regarding court operations
- establishing standards and procedures for program performance, audits and evaluations
- developing and conducting training and continuing education programs for local court staff
- analyzing the impact of legislation related to judicial operations and devising solutions for implementation of new statutes and statutory changes
- overseeing senior judge requests, assignments for change of venue/venire and AOPC communication with judicial districts concerning president judge elections
- overseeing training, testing and certification of court interpreters

In 2012 the department was involved in several noteworthy endeavors as follows.

Magisterial Disrict Realignment

The statutorily mandated magisterial district review that follows each decennial federal census took place in 2012. The president judge of each judicial district was provided with the results of a weighted caseload study conducted in 2011, detailed caseload statistics, and census and demographic information for the magisterial district courts in their respective districts. The judges analyzed the data to determine if any courts could be eliminated without affecting the administration of justice and to assure that the caseload was distributed amongst the courts as equitably as possible. Recommendations were submitted, reviewed and analyzed by the Judicial Programs Department and then forwarded to the Supreme Court for disposition.

Office of Children and Families in the Courts

The Office of Children and Families in the Courts (OCFC) continued its mission to protect children, promote strong families and child well-being, and provide timely permanency through a variety of programs and initiatives.

The State Roundtable, a group consisting of representatives from various counties as well as other state and national leaders who have specific expertise in dependency matters, establishes workgroups to research and address statewide areas of concern for the Pennsylvania dependency system. Current workgroups addressing issues include

- Father Engagement Workgroup
- Visitation Workgroup
- Educational Success and Truancy Prevention Workgroup
- Psychotropic Medication Workgroup
- Transitional Youth Workgroup
- Dependent Children of Incarcerated Parents Workgroup
- Training for Legal Representation Workgroup
- Hearing Officer Education Workgroup
- Common Pleas Case Management System Users Group

The Fourth Annual Children's Welfare Summit was held in September 2012. Nearly 400 judges, county child welfare directors and other officials from 51 counties met for three days to hear from international experts in child welfare and child development. The focus of the summit was on transformative change, an essential element in the ongoing efforts to decrease the number of children in foster care in Pennsylvania and shorten the length of time children must wait for safe and permanent homes.

Problem-Solving Courts

The Judicial Programs Department continued its efforts in 2012 to assist judicial districts in the creation, expansion or maintenance of problem-solving courts, such as drug courts, DUI courts and mental health courts. By the end of 2012, 94 problem-solving courts existed in 36 counties in Pennsylvania.

The fastest growing type of problem-solving court in 2012 continued to be veterans courts, increasing to 15 courts throughout the state. Pennsylvania has become a national leader in providing services and support to our veterans.

A new court program for veterans was launched in 2012 that enables participating counties to divert veterans who have service-related issues that caused them to have cases in the magisterial district court system, out of the criminal justice system and into the appropriate treatment.

In 2012 the first four problem-solving courts achieved accreditation under the Supreme Court's program of assessing the functioning of courts to ensure they are complying with core principles and best practices of operation. The four courts are Lancaster (January), Wyoming (March), York (July) and Luzerne (August).

A vendor was selected and work was begun in 2012 to create a management information system for problem-solving courts throughout the Commonwealth. This system, when completed in 2013, will enable problem-solving courts to manage all aspects of their cases, from

intake through treatment and graduation, and also produce courtwide and statewide statistics on the effectiveness of these courts.

Court Interpreters

The Judicial Programs Department's Interpreter Certification Program in 2012 continued its mission, as mandated by Act 172 of 2006, of ensuring that foreign language and sign language interpreters working in the courts of the Commonwealth are certified by the AOPC.

To become certified, interpreters must first complete a training session, then pass a two-part written test and a three-part oral test. For more information please see the Unified Judicial System's website at www.pacourts.us.

As of the end of 2012, the interpreter roster had 163 qualified interpreters in 27 languages. Of this number 120 are certified interpreters, and 43 are listed as qualified, of whom 25 speak languages for which there is no certifying exam but have demonstrated the necessary knowledge and skills.

Statistics for 2012 are as follows:

- 154 interpreter candidates attended orientation sessions to learn about the Pennsylvania court system and the Interpreter Certification Program
- 21 interpreters became certified
- 4 interpreters certified in other states were granted certification in Pennsylvania through reciprocity
- 17 foreign language interpreters passed all phases of the examination
- 225 candidates took various parts of the certification examinations, of whom 127 passed at least one part.

An important initiative concluded in 2012 was the translation of protection from abuse forms into the ten most commonly spoken foreign languages in Pennsylvania. Funded by a grant from the Pennsylvania Commission on Crime and Delinquency, 15 different forms, orders and instructions were translated and posted on the Supreme Court's website for use throughout the state.

Judicial Automation Department

The AOPC's Judicial Automation Department is responsible for developing and maintaining statewide case management systems and other software applications for courts and administrative staff in the Unified Judicial System. This department also provides general technology support to the Supreme Court justices, their staffs and the administrative court staff in Pennsylvania. It is funded by court fees rather than tax dollars. Pennsylvania's first statewide case management system, the Magisterial District Judge System (MDJS), came online in 1992. The Pennsylvania Appellate Court Management System (PACMS) and Common Pleas Criminal Case Management System (CPCMS), followed in 2000 and 2006, respectively. The ultimate goal is to implement statewide case and financial management systems for all levels and divisions of Pennsylvania's Unified Judicial System.

Statewide case management systems provide uniform administration of justice through integration and standardization of business practices between county courts. Using a statewide system, local court officials are able to access information about parties related to cases anywhere in the state. The MDJS, CPCMS and PACMS are all linked, allowing for data sharing and uniform exchange of data on cases as they move through the court system. For example, in 2012, 205,470 cases were electronically transferred from the MDJS to the Common Pleas system, saving county court staff countless hours by eliminating the need for redundant data entry.

In 2012 more than 12,000 individuals were direct criminal case management system users. Another 8,000 court staff, criminal justice partners and law enforcement officials depended on the case management system to perform their daily duties. Through direct court system information exchanges and the state's Criminal Justice Network (JNET), the systems share information with more than 20 agencies.

System users, justice partners and the public have access to tens of millions of cases through the Unified Judicial System's Web portal at http://ujsportal.pacourts.us. In 2012 these cases were viewed more than 54 million times, free of charge.

The statewide approach to court management also saves staff resources and equipment costs at both the state and county level, and makes it easier to accommodate changes in law, both statutory and rules-based.

The highlights of several important projects undertaken by this department in 2012 are described below.

Common Pleas Case Management System (CPCMS)

CPCMS is a statewide case management system for Pennsylvania's criminal and dependency trial courts that includes docketing, accounting and other important case management functions. In 2012 more than 315,700 criminal cases were docketed in Pennsylvania's Common Pleas Courts.

Groups that use the CPCMS for daily operations include judges, clerks of courts, court administration and county fiscal offices. Probation departments, district attorneys, sheriffs and prison offices have limited access. The system's 12,000 users docket cases; track party filings submitted on each case and complete administrative functions, including courtroom scheduling and accounting, necessary to adjudicate all cases.

An important function of the CPCMS is its ability to provide case information to criminal justice agencies through JNET. Most critical to public safety is the timely, automated transfer of statewide warrant information to FBI and State Police criminal databases — a process

that helps protect law enforcement officials and increases the likelihood of apprehending fugitives.

In 2012 a CPCMS refresh project began with a pilot in Adams County. The system's original software was several years old, and upgrading it was needed to make it consistent with new technology. These upgrades will enhance the system's overall performance and allow it to provide additional services in the future, such as document management and e-filing.

CPCMS produces approximately 580 forms and reports, including master account reports that completely automate the disbursement of funds collected by the courts to the correct entities through the Department of Revenue. The system is capable of exporting report data to other applications such as Microsoft Excel and Access so that county court officials can customize the presentation of information as desired. In 2012 approximately 14,000 reports were run daily by county court staff.

Table 2.1 shows the moneys collected and disbursed by the CPCMS in 2012.

2012 CPCMS Collections

Through the CPCMS money is collected for fees, fines, costs and restitution assessed to criminal cases, using numerous methods including, but not limited to, payments made at court offices, payment plans, online payments (e-pay) and collection agencies. In 2012 a record \$211 million-plus was collected and disbursed through Pennsylvania's Common Pleas Courts.

CPCMS System Users and Support

As in previous years, in 2012 Judicial Automation staff held many regional training sessions for both new and existing Common Pleas system users. The sessions focused on enhancements to the system and provided advanced training in complex areas such as accounting.

Also in 2012 the CPCMS help desk fielded more than 46,400 calls, more than 27,600 of which were resolved at the first level of contact.

CPCMS Dependency Case Module

Working with the Office of Children and Families in the Courts (OCFC), in 2012 Judicial Automation staff completed installation of a dependency case module of CPCMS. This module generates local and statewide statistical information based on national performance measures. It allows court officials to assess their efficiency in handling dependency matters.

The dependency case data is available on the UJS website at www.pacourts.us, through an interactive website dashboard. It gives judges, child care professionals and the public a

comprehensive look at the demographics of the state's abused and neglected children who are under court supervision. The dashboard presents statewide and county-specific data and includes items such as child age, gender, race and length of court supervision.

Magisterial District Judge System (MDJS)

The Magisterial District Judge System provides case management and accounting functions to all magisterial district judges and their staffs. Approximately 3,500 users throughout the state depend on the system to manage traffic, nontraffic, landlord/tenant, civil and miscellaneous docket cases; private complaints (summary and court cases) and police criminal complaints.

The system tracks cases throughout their life cycles. It also

The AOPC's statewide court case management systems share critical data with 13 agencies, and officials in those agencies have come to depend on this data to improve efficiency of their daily operations. The systems, for example, provide real time information on cases where the defendant has a warrant issued. This is used heavily by law enforcement officers to track defendants and also during routine traffic stops. In 2012 more than one million warrants were issued in Pennsylvania.

has a sophisticated event management system that, for example, prompts court users to issue documents such as warrants and license suspension requests when expected responses or payments do not occur.

The MDJS also disburses all fines, costs, fees and public restitution, based on applicable law. In addition, private restitution, bail, collateral and server fees are processed through the system.

In 2012, 2,452,085 cases were docketed in the MDJS.

Table 2.2 on page 16 shows the moneys collected and disbursed by the MDJS in 2012.

MDJS System Users and Support

The MDJS training was ongoing in 2012. MDJS trainers develop and write all training program material for all classes and presentations, which also includes staging cases in the MDJS training environment for class activity and independent learning.

In addition, the training department wrote a comprehensive online MDJS manual.

The MDJS user help desk, available during court working hours, fielded more than 82,000 calls or email queries in 2012.

E-Filing

E-filing saves court staff time by eliminating the need for manual data entry.

Judicial Automation staff continued to work with local courts developing e-filing services at several levels. For example, Allegheny and Philadelphia courts began e-filing dependency

and delinquency cases, and some local police departments began e-filing traffic citations.

The Pennsylvania State Police have been electronically filing traffic citations since 2010. With this process, no paper is filed in the courts, eliminating the need for officers to deliver the traffic citations to the district courts and for court staff to enter citation information manually into the judiciary's computer system. This system is estimated to save court staff 77,000 hours annually.

Allegheny County continued filing criminal complaints electronically. More than 31,600 cases had been accepted in 2012. While the paper complaints still need to be filed, this program has saved considerable data entry time for district court staff.

Web Portal

The Unified Judicial System Web portal provides a host of services for the public, including access to case information through docket sheets; court calendars and an online payment application. Local rules of court and

Over the last five years, more than \$1.3 billion was collected by magisterial district courts.

financial records, including judicial expenditures and contracts, are also available.

The portal also provides secure services to court-related personnel and law enforcement agencies. These include secure docket sheets and calendar schedules, disposition look-up and warrants. Secure docket sheets, generated millions of times per month, provide additional information to help identify and track court cases. Disposition look-up is a service provided to law enforcement agencies to follow a particular case as it moves through the courts.

The Web portal also provides services for attorneys and *pro se* litigants. These include PAC-File, attorney registration and DA Link.

PACFile is an online application that allows attorneys and *pro se* litigants to electronically submit case filings and supporting documents in the Supreme Court and pay any associated filing fees through e-pay.

DA Link is an electronic bill of information filing system used by the district attorneys' offices. This service, provided by the AOPC, sends the bill of information — the formal accusation of a crime — to the Court of Common Pleas and updates the court's case management system. The attorney registration application is a service provided to the Disciplinary Board of the Supreme Court to collect annual dues. Attorneys register online and pay through the e-pay system.

Web portal activity of note in 2012:

- the AOPC added civil and landlord-tenant docket sheets for the magisterial district courts to the public docket sheets
- over 4.5 million docket sheets were generated per month
- approximately \$4 million was collected on a monthly basis using the e-pay application. This includes payments on cases at the magisterial district courts and the Courts of Common Pleas. E-pay has significantly increased collections by the courts and disbursements.
- in 2012 Chester County successfully tested the new statewide e-pay bail service. Under this system bail payments are being made using Visa, MasterCard, Discover, American Express or a debit card. A county prison portal was developed to provide access to court case bail information by prison personnel. The service will reduce county prison commitments and transportation costs.

Website

In 2012 the Judicial Automation staff assisted in the extensive redesign of the UJS website. The site will be released in January 2013, and will provide a completely new look and feel for users. The AOPC and its vendor conducted extensive research with both external and internal site users to determine what areas of the site were of most value to different groups and tailored the website to meet those needs. The new site will highlight important judiciary news and issues as well as continue to provide practical information on Pennsylvania's judiciary to the public.

Administrative Support Application Project (ASAP)

ASAP is a software application that was developed in-house to support the administrative functions of the appellate courts, AOPC and First Judicial District (Philadelphia). The system includes payroll, human resources and finance modules. The ASAP team also supports applications developed for the Board of Law Examiners (BLE).

The ASAP team also supports a system that allows financial disclosure statements from jurists and staff to be filed online. In 2012, 77 percent of judicial officers filed their statements online, a 7 percent increase over the previous year.

An online payment feature was added to the BLE's Online Bar Application system in 2012, allowing bar applicants to pay their bar examination fees electronically. This project includes features such as electronic signature capability and online authorization and release.

Deputy Court Administrator's Office

Communications/Legislative Affairs

In its role as both legislative and media liaison, the Office of Communications and Legislative Affairs represents the AOPC before the state's executive and legislative branches of government as well as to the media. As media liaison, staff

Legislative affairs staff

- compile and publish a legislative summary when the General Assembly is in session
- when appropriate, comment on the effect legislation may have on the fiscal and administrative operations of the judicial system
- monitor and report on legislation that may necessitate changes to the Magisterial District Judge and Common Pleas Case Management systems.

Administrative Services

The Office of Administrative Services is responsible for a variety of administrative-related tasks, including procurement for the Administrative Office, issues relating to facility management, fixed asset control, disaster recovery planning, mail and messenger services, fleet vehicle management, employee and visitor parking and oversight of the conference center in the Pennsylvania Judicial Center.

Judicial Security

The goal of Judicial Security is to support efforts to ensure that Common Pleas and magisterial district courts in Pennsylvania are safe places in which to work and to conduct business for jurists and their staff, litigants, jurors, witnesses, victims of crime and their families, and the general public.

In 2012 the AOPC continued its project to reimburse counties for the purchase of security equipment for Common Pleas and magisterial district courts. Funds are used for security cameras, exterior lighting, access control systems and other physical security measures.

Also in 2012 the AOPC began implementation of its project to provide for the electronic capture, storage and retrieval of county court records. The majority of courts were without such a system while other courts had insufficient capacity to handle this process. Full implementation of this project will enable courts to carry on essential court functions during and in the immediate aftermath of a natural or manmade disaster.

In the fall the eighth round of regional workshops was conducted for all local court security committees throughout the Commonwealth. These committees, comprised primarily of president judges, sheriffs, court administrators and county executives, are encouraged to meet regularly to formulate and execute plans to respond to security incidents and emergency situations that occur in their courts. The 2012 workshop focused on court emergency plans and continuity of operations plans. In addition, judges and other committee members were briefed on various threat groups active in the state.

Judicial Education

The Judicial Education Department was formed in 2005 to provide continuing education to Pennsylvania's jurists. The department works closely with various planning committees to design programs that address new and emerging areas of law and issues of import and interest to judges.

Supreme Court, Superior Court and Commonwealth Court

Since 2004 jurists on Pennsylvania's three appellate court jurists have attended an annual appellate courts conference. The conference addresses the needs specific to jurists serving

appellate duties. In addition to educational programs, members of each court hold administrative sessions at these conferences.

Common Pleas Courts

During 2012 more than 85 percent of all trial judges in the Commonwealth attended state-sponsored continuing education programs. Primarily, these programs were held at conferences of the Pennsylvania Conference of State Trial Judges, which meets twice a year.

Staff of the Judicial Education Department worked closely with the Education Committee of the conference to plan, develop and deliver more than 35 hours of continuing judicial education.

Each three-day conference provided state-of-the-art educational programs and allowed judges to discuss issues of common interest and concern.

New Product Development

The *President Judge Reference Manual* was presented to the 60 Common Pleas president judges at the annual meeting of the Pennsylvania Conference of State Trial Judges in July. The 1,000-plus page document, distributed on CD, was the culmination of many years work by York County Judge Richard K. Renn and members of the Judicial Education Department.

Human Resources

The Department of Human Resources

- monitors and ensures UJS compliance with state and federal employment statutes
- maintains all UJS fringe benefit programs and counsels judiciary personnel regarding the programs' provisions and utilization
- administers the UJS employee leave accounting program and the UJS Unemployment Compensation and Workers Compensation programs
- formulates and administers the personnel policies and procedures that govern the personnel operations of the UJS
- assists managers in the recruiting, interviewing and hiring of new staff and develops and administers AOPC hiring procedures
- formulates and administers position classification and pay plans for the UJS
- monitors and administers the UJS performance management system
- develops training curriculum, policies and procedures for judiciary personnel

Finance

The Finance Department is responsible for managing the budget, accounting and payroll systems for the Unified Judicial System. It serves as the primary resource for the various components comprising the UJS regarding financial matters. It fulfills its responsibility through the following activities:

- developing necessary policies and procedures on accounting and budget issues, and training staff at all levels in their use
- monitoring and preparing the budget for some 34 UJS line items in the Commonwealth's annual budget. These line-item appropriations include funding for the Administrative Office, state-funded courts, most Supreme Court advisory procedural rules committees, juror cost reimbursements and county court grants.
- managing \$363.6 million in annual appropriations, including \$35.8 million in grants to counties
- participating in the annual financial audit of the UJS
- performing the controller functions for the judiciary
- performing payroll functions for the judiciary

- responding to public access requests for financial and personnel information, and providing expenditure and salary information to the judiciary's website in accordance with Rule of Judicial Administration 509
- assisting in the management of the finances of the First Judicial District/AOPC Procurement Unit, including recommending investment and banking strategy

The following recommendations were published for comment in 2012:

- statewide uniformity in the setting of hearing dates in civil actions and elimination of the common practice of setting a fictional hearing date until a defendant enters a notice of intention to defend
- clarification of a defendant's options when a plaintiff cannot be located or otherwise served with a request for entry of satisfaction of judgment and the status of a judgment when a plaintiff has not executed upon it or entered it at a Court of Common Pleas within the five-year period
- clarification of the appeal periods for all civil and landlord-tenant judgments and incorporation of the additional appeal time provided to a victim of domestic violence when a judgment arises out of a residential lease and contains an award of possession



About the Board

The Pennsylvania Board of Law Examiners holds the responsibility for recommending the admission of persons to the bar and thus the practice of law in Pennsylvania. Such responsibility includes reviewing admission applications, both for those wishing to sit for the bar examination and for those practicing attorneys from other states seeking admittance to the bar without sitting for the exam; administering the bar exam itself; and recommending rules pertaining to admission to the bar and the practice of law.

Members are appointed to three-year terms, and each member may serve two consecutive terms. Board office staff includes the executive director, deputy executive director, counsel to the board/ supervising law examiner, director of testing, and five administrative support staff. The board also employs seven examiners, who are responsible for writing and grading the Pennsylvania Bar Essay Examination, and 14 readers, who assist the examiners in grading the essay answers. Additionally, many proctors are employed temporarily to assist in the administration of the bar exam. Board

The court approved changes to streamline the board's review of criminal records examined in the course of character and fitness reviews.

The Computer-Based Testing Program (CBT) continued to gain in popularity. The program allows applicants to use their personal laptops to answer the essay and performance test questions during the bar exam. For the July 2012 exam, 84 percent of applicants registered for CBT.

In August the board restructured its semi-annual meeting and calibration process. Additional reporting created through the in-house-developed grading program facilitated the refinements to calibration. The board also implemented initiatives to improve security at the examination.

The board continues to be well-regarded by other jurisdictions for its use of technology. In November at the request of the Conference of Bar Admission Administrators, Dmitry Rasolko, lead IT developer, spoke at the National Conference on Technology Security. Additionally, Executive Director Gicine Brignola served on the National Conference of Bar Examiners Technology Committee.

In December board staff worked with the Administrative Office of Pennsylvania Courts' Audio-Video Department to produce a bar exam proctor training video. The video will be available in January 2013.

In late 2012 the board laid the groundwork for developing technology to enhance communications with applicants and to permit electronic submission of supplemental materials related to the character and fitness review of applicants. The board's lead developer will work with developers from the Administrative Office of Pennsylvania Courts.

Filing Fees

Effective August 1, 2012, the Supreme Court approved a rate increase for filing fees for processing applications for admission to the Pennsylvania bar. In addition to the rate increases, the board no longer maintains a separate fee schedule for reapplicants. The new fees are as follows:





Committee Activities

Civil Instructions

In 2012 the subcommittee continued its mission of updating the *Pennsylvania Suggested Standard Civil Jury Instructions*, Fourth Edition. This reference includes a searchable, companion CD-ROM, a derivation table and a subject matter index.

The subcommittee continues to incorporate revisions based on case law developments, new Pennsylvania Rules of Civil Procedure and new legislation as well as comments from lawyers and judges.

It also continues its plain English objective to make the instructions more understandable to lay jurors.

The subcommittee is committed to updating the instructions every 18 to 24 months.

Criminal Instructions

In 2012 the subcommittee released a supplement to the *Pennsylvania Suggested Standard Criminal Jury Instructions*, Second Edition (2005). This supplement includes revisions to 88 of the standard instructions and/or subcommittee notes as well as 27 new instructions, which are listed in the table on page 55.

This reference contains hundreds of criminal instructions keyed numerically to the Crimes Code, with many offering alternative language depending on the case facts.

Subcommittee members continually monitor pertinent case law to update the subcommittee notes, which explain the appropriate instruction application, identify relevant case law citations and offer practical guidance.

The subcommittee's ongoing goal is to improve the language of the instructions to ensure both a proper statement of law is conveyed and the instructions are accessible to the jurors applying them. The subcommittee is committed to updating the instructions every 18 to 24 months.

Purchasing/Commenting on the Instructions

Since 1979 the Pennsylvania Bar Institute (PBI) has provided both administrative and publishing support for the committee as well as funding.

Project costs are underwritten through the sale of the published suggested standard instructions to the legal community. The instructions may be purchased by visiting the PBI's website at www.pbi.org.

Members of the bench and bar are urged to provide their comments and suggestions to the committee. Such comments are of great assistance to the reporters and subcommittee members in their ongoing efforts to ensure that the instructions reflect the current state of the law in Pennsylvania. 2012 Board Actions and Operations Highlights

The board held three meetings in 2012.

A total of 32,565 accredited courses were offered by more than 1,800 providers.

Distance Learning

Lawyers have the option to complete up to four credits per compliance period via distance learning. Currently, 78 providers are approved to offer such programs. Approximately 17,000 programs are available.

Thirty-one percent of attorneys participated in distance learning in 2012, accounting for 8.4 percent of the total credits reported.

Criminal Procedure Rule 801

Pennsylvania Rule of Criminal Procedure 801 requires that defense attorneys who wish to participate in capital cases complete 18 hours of training relevant to capital representation. To this end, in 2012 the board accredited 79 capital counsel training programs. It also maintained online mechanisms to promote course availability and identify counsel who satisfied the educational requirement.

In 2012, 450 lawyers met the requirement.

Bridge the Gap Program

The Bridge the Gap program assists newly admitted lawyers in making the transition from law student to practitioner. The board coordinates with accredited providers to ensure program availability and low cost. In 2012, 65 presentations were conducted, and 2,043 lawyers completed the program.

PA CLE Providers Conference

The 2012 Providers Conference was held June 8, 2012. Supreme Court Chief Justice Ronald D. Castille and Justice J. Michael Eakin attended.

Welcoming remarks by Daniel Levering acknowledged 20 years of Pennsylvania's mandatory continuing legal education program. Chief Justice Castille extended appreciation to CLE course providers and offered views on the importance of continuing legal education. Guest Speaker Professor Michael Schwartz from Washburn University School of Law offered an insightful presentation on "Maximizing Learning in a Multi-Generational Setting."

The conference also featured a panel of Pennsylvania CLE representatives engaging audience members in, "An Open Forum on CLE in Pennsylvania." Representing the CLE Board were board members Ken Argentieri, Elizabeth Simcox, Patricia Daly and Associate Administrator Katey Buggy.

Electronic Compliance Notifications

The board expanded automated preliminary transcript reports in 2012. This electronic compliance notification system replaces the paper transcripts previously sent to attorneys. It has accelerated the board's ability to communicate compliance with lawyers and reduced preliminary transcript-related expenses by 25 percent.

Online Payment Features

The CLE Board allows education providers to file payments and lawyers to pay late fees online via Automated Clearing House (ACH). Use of this system has increased the speed with which lawyers can review their credits online as well as remedy noncompliance situations.

In 2012, 67 percent of compliance payments were made in this manner, an increase of 7 percent from 2011. Over 150 providers filed payments through ACH.

Automated System for Accredited Providers (ASAP)

The board continued to provide training and technical support to over 300 accredited providers who use the Automated System for Accredited Providers (ASAP). This internally developed Internet software allows for the paperless reporting of provider courses, course attendance and course evaluations. In 2012, 83 percent of credit hours were reported electronically.

Contingency Planning

The board took measures in 2012 to ensure the safety and continuity of its data, should an emergency arise. A disaster recovery plan, back-up system and data replication process were maintained and tested to help minimize downtime and preserve operational continuity in the event of a disaster.

CLEreg: National Organization for Continuing Legal Education Regulators

Pennsylvania maintained a strong and active presence in the Organization for Continuing Legal Education Regulators (CLEreg). Dan Levering, a past president (2003) of the association, serves as chair of the Technology Committee and on the Management Committee. Associate Administrator Katey Buggy, also an association past president (2008), serves as chair of the Management Committee and on the Membership Committee.

Two meetings were held in 2012.

National Mandatory Continuing Legal Education (MCLE) Working Group

In 2011 a group was formed to consider possible methods for implementing recommendations made at a 2009 CLE and lawyer development institute. This group includes participants from across the country. Dan Levering is one of three participants from states that require CLE for attorneys.

The group is currently focusing efforts on developing accreditation standards for distance learning programs and on updating standards for live programs.

Attorney Compliance

Lawyer compliance rates with CLE requirements remain high. Table 4.3.1 on page 60 indicates the percentage of lawyers who met the requirements.

- any attorney from another jurisdiction specially admitted to the bar of the Supreme Court for a particular proceeding
- any disbarred, suspended or inactive attorney, with respect to violation of any rules committed prior to disbarment, suspension or transfer to inactivity
- any jurist with respect to any violation of rules committed prior to taking office, if the Judicial Conduct Board declines jurisdiction
- any attorney who resumes practice of law with respect to any nonjudicial acts performed while in office as a jurist.

Investigations may be initiated by the Disciplinary Board on its own motion or upon complaint from another person. (See Pa.R.D.E. Rules 103, 205(a) and 205 (c)(1)(2).)

Rules Committee

The following rules change became effective in 2012:

Pa.R.D.E. 219(a) and 502(b) and R.P.C. 1.15(u): Amendment to change the annual fee allocations to provide annual fees of \$130 for the Disciplinary Board, \$35 for the Pennsylvania Lawyers Fund for Client Security and \$35 for the Interest on Lawyers Trust Account Board. Adopted 4–9–12, effective with the 2011–12 assessment year.

Pa.R.D.E. 216 and 218: Amendments to include disability inactive status as a disposition which can be sought as reciprocal discipline from other jurisdictions and to include bar associations and disciplinary boards from other jurisdictions as agencies from which reciprocal discipline can be sought. Adopted 3-19-12, effective 4-18-12. **R.P.C. 1.6 and 1.19:** Amendments to include ordinances enacted by municipal governing bodies that regulate lawyer/lobbyists. Adopted 5-17-12, effective 6-16-12.

Pa.R.D.E. 214 and R.P.C. 8.3:

Amendments to define the term "crime" as an offense that is punishable by imprisonment in the jurisdiction of conviction, whether or not a sentence of imprisonment is actually imposed. It does not include parking violations or summary offenses (traffic and nontraffic), unless a term of imprisonment is actually imposed. In addition, the Comment to R.P.C. 8.3 was amended to ensure attorneys are aware that they must selfreport not only convictions of crimes, but also when transfers to disability inactive status, suspensions and disbarments are ordered in another jurisdiction. Adopted 3-19-12, effective 4-18-12.

Pa.R.D.E. 102, 203, 204, 205, 207, 208, 215 and 402:

Amendment to create a new type of discipline, "public reprimand," which the board could approve and administer without review or approval by the Supreme Court. Adopted 5–17–12, effective 6–16–12.

request no public access be granted to his/her registered address. An additional provision provides for automatic nonwaivable late payment penalties to be assessed on July 31 and again on August 31. Adopted 6-4-12, effective 7-4-12 for the majority of changes, effective with the 2013-14 assessment year for assessment of late fees.

Amendments to Board Rules of Organization and Procedure:

Conforming amendments consistent with amendments made to Pa.R.D.E. 216, 218, 214, 219, 102, 203, 204, 205, 207, 208, 215 and 402, respectively. Adopted effective 9–11–12.

Amendments to Board Rules of Organization and Procedure:

Conforming amendments consistent with amendments made to Pa.R.D.E. 204, 205, 212, 216, 217, 218 and 219, respectively. Adopted effective 11–3–12.

Education Committee

The Education Committee designed the program for the board's educational meeting in July 2012. The topics were "Enhancement Tools for Discipline" and "Social Media." The subject of discipline included an in-depth discussion about establishing an ethics school or implementing diversion programs for attorneys who have engaged in misconduct. The guest speakers for this topic were John T. Berry, director of the Legal Division of the Florida Bar Association, and Richard L. McCoy, executive director of the Pennsylvania Bar Institute.

Mr. Berry's knowledge, insight and suggestions, along with statistics showing the recidivism rate for those attorneys who go through a diversion program at around 8 percent, convinced the board to look further into developing such a program in Pennsylvania. Mr. McCoy agreed to assist the board in identifying courses already in place that meet the board's criteria and in putting together new courses that the board has identified as areas where attorneys need more education.

Disciplinary Board member R. Burke McLemore Jr. led a discussion on social media, distributing several articles and advisory opinions on the topic. The use of social media sites such as Facebook, Twitter, LinkedIn and Tumblr form the basis for proposed changes to the Model Rules of Professional Conduct currently under review by the American Bar Association Commission on Ethics 20/20. This topic will be covered in more detail as Pennsylvania considers these amendments in 2013.

The Education Committee also designed the program used at the training session and refresher

course for all Hearing Committee members, held in October 2012 in Hershey. Justice J. Michael Eakin spoke on the role the Supreme Court has in the disciplinary process. Ken Hagreen, executive director of Lawyers Concerned for Lawyers, and Workers' Compensation Judge Irving L. Bloom spoke about the effects depression and other psychological illnesses had on their abilities to practice law and about their roads to recovery.

Workshops were held to provide new members with information on the disciplinary system and the roll of hearing committees. Senior and experienced members offered tips on chairing hearing committees, presiding at hearings on subpoena issues and conducting prehearing conferences. Guest speakers Ellen C. Brotman, Esq. and Samuel C. Stretton, Esq. brought perspective from respondents' counsel.

The program was attended by 140 Hearing Committee members.

Good Cause Requests

With the amendments to Pa.R.D.E. 119 that allow attorneys to request that their contact information remain private information, Rules Committee Chair Stephan K. Todd took on the task of reviewing written requests from attorneys for such privacy. Through the end of 2012, Mr. Todd had reviewed ten requests, approving six and denying four.

Hearing Committee

Hearing Committee members are ranked based on their experience. Senior members are those who have served either as a member of the Disciplinary Board or a three-year term on a hearing committee that has conducted at least two hearings into formal charges of misconduct. Experienced members are those who have completed at least one full year of service and who have conducted at least one hearing into formal charges of misconduct. New members are those who are either still in their first year of service or have not yet had a full hearing.

A committee must be composed of at least one senior member and one senior or experienced member. A senior member chairs the committee. Only a senior or experienced member may conduct the mandatory prehearing conference.

As of December 31, 2012, 49 senior members, 46 experienced members and 55 new members were serving on a *pro bono* basis to conduct hearings.

Miscellaneous

In the Fall of 2012, the board launched a new mobile-friendly website, providing easier viewing for cellphone and tablet computer users.

In February 2012 then board chair Sal Cognetti Jr., board members Stewart L. Cohen and R. Burke McLemore, board secretary Elaine Bixler and assistant board secretary Marcee Sloan, attended the Ninth Annual Meeting of the National Council of Lawyer Disciplinary Boards in New Orleans, Louisiana.



About the Board

The Interest on Lawyers Trust Account (IOLTA) program was first established in 1988 as a voluntary means to raise money to provide civil legal services to the poor and disadvantaged of Pennsylvania. With the issue of Supreme Court Order 252, Disciplinary Docket No. 3 on July 17, 1996, this program became mandatory. It is the job of the IOLTA Board to administer the IOLTA and other programs authorized by the Supreme Court, collecting and managing the funds received and awarding grants to nonprofit organizations, law school clinical and internship programs, and pro bono programs.

The IOLTA Board is comprised of nine members appointed by the Supreme Court. Members serve terms of three years and may serve maximums of two consecutive terms.

Access to Justice Act

The Access to Justice Act (AJA), part of Act 122 of 2002, provides for a \$10 surcharge to be placed on all civil filings, the recordings of deeds and mortgages and their related filings and on criminal filings where a conviction or guilty plea is obtained. A percentage of this surcharge is placed into the Access to Justice Account for the IOLTA Board to provide grants to civil legal services provided by nonprofit legal aid organizations.

Act 49 of 2009 provides a supplemental filing fee of \$1 on the same courthouse filings as Act 122, excluding traffic citations.

Act 122 is scheduled to sunset on November 1, 2017, and Act 49 is scheduled to sunset on December 31, 2014.

Homeowner Assistance Settlement Act (HASA)

On June 22, 2012, Governor Tom Corbett signed into law Act 70 of 2012, the Homeowner Assistance Settlement Act (HASA). This law was brought about by the settlement agreement between Pennsylvania's attorney general and the nation's leading mortgage serving companies, over "robo-signing" and other foreclosure and mortgage servicing-abuses. The act allocates to the Access to Justice Account \$900,000 for fiscal year ended June 30, 2013, and \$600,000 for each of the next four years for civil legal assistance related to housing issues.

Loan Repayment Assistance Program

The Loan Repayment Assistance Program (LRAP) was begun by the Supreme Court in 2010 as a means of helping IOLTA-funded legal services organizations recruit and retain the best and brightest attorneys to serve the civil legal needs of poor Pennsylvanians. It provides student loan forgiveness to attorneys employed by agencies that help people who cannot afford legal representation.

The program is administered by the IOLTA Board and the Pennsylvania Bar Foundation, a charitable affiliate of the Pennsylvania Bar Association. Begun with an initial three-year, \$1,074,430 grant from the IOLTA Board to the foundation, it is funded by *pro hac vice* admission fees paid by out-of-state attorneys.

Since the inception of the program, 229 legal aid attorneys -72 in the first year, 80 in the second year and 77 in the third year - have received or will receive loans.

Class Action Residuals

In May 2012 the Supreme Court amended the Pennsylvania Rules of Civil Procedure to provide for the dispensation of funds left over from class action lawsuits. The new rules provide that not less than 50 percent of the funds remaining after plaintiffs, attorney fees and expenses have been paid will be allocated to the IOLTA Board to help fund civil legal aid.

The rule took effect July 1, 2012. Through June 30, 2013, four class action residuals disbursements totaling \$78,010 had been transferred to the IOLTA fund.

Assessment of Telephone-Based Legal Assistance

In 2012 the IOLTA Board authorized a study of the use of telephone-based legal assistance provided by Pennsylvania legal aid programs. The study compared the outcomes of tele-phone-based assistance with in-person assistance for those who used "brief services," or services requiring limited action, (for example, a letter written or a document prepared). It also assessed the alignment of practices and procedures used by Pennsylvania's programs with the best practices that have been developed over the past decade in which telephone helplines have been in place across the United States.

Key findings of the study are:

- advice and brief services are not only effective; they are essential. Services delivered by telephone provide more convenient access to services and enable vastly more people to obtain legal aid than would be possible in-person with the same resources.
- Pennsylvania's programs in this study are achieving the primary goal of telephone-based legal assistance, which is to make legal assistance accessible to every eligible person without sacrificing the quality and effectiveness of services
- the best practices assessment supports efforts by legal aid agencies to work to optimize results for clients going forward

Economic Benefits of Funding Legal Aid

The results of an independent study commissioned by the board and conducted by the Resource for Great Programs for the year 2011 were released in 2012. Entitled "The Economic Impact of Outcomes Obtained for Legal Aid Clients Benefits Everyone in Pennsylvania," the study found a greater than eleven-fold return on investment for each dollar spent on legal aid in Pennsylvania in 2011. Benefits included

- \$546 million in direct economic impact for local communities through Social Security benefits and Supplemental Security Income attained for low-income residents; federal share of Medicaid benefits attained for low-income and disabled residents; federal grant funds received from the Legal Services Corporation; increased spending and income via the economic multiplier effect
- more than 2,600 jobs created for Pennsylvania workers
- \$48 million additional cost savings for Pennsylvania communities when low-income families successfully avoided the need for emergency shelter and when families received protection from domestic violence
- savings linked to crime prevention and a lessened need for law enforcement assistance
- keeping in school children who would otherwise miss classes because of homelessness or domestic violence
- health care providers receiving reimbursements from Medicaid for services they would otherwise have had to write off
- increased efficiency in Pennsylvania courts when legal aid agencies assist clients and *pro se* litigants in learning how to follow court procedures
- additional tax revenues realized from jobs that are preserved when legal aid agencies assist in employment cases



About the Board

Article V, §12 of the Pennsylvania Constitution requires that magisterial district judges (MDJs) and judges of the Philadelphia Traffic Court either be members of the bar of the Supreme Court or, before taking office, complete a course and pass an examination in the duties of their respective offices. It is the responsibility of the Minor Judiciary Education Board (MJEB) to instruct and certify individuals wishing to become magisterial district judges, Philadelphia Traffic Court judges or Philadelphia arraignment court magistrates. The board approves the curriculum, appoints and evaluates instructors, establishes course content, reviews all tests and issues certificates to successful program participants.

In addition, the board conducts one-week continuing education classes for magisterial district judges, Philadelphia Traffic Court judges, Philadelphia arraignment court magistrates and for those individuals who wish to maintain a current certification in one or more of these areas. It also conducts a one-week practicum, or orientation course, for newly elected or appointed magisterial district judges.

The board has seven members, who are appointed by the Supreme Court to three-year terms. Each may serve a maximum of two full terms.

About the Board

The Pennsylvania Lawyers Fund for Client Security was established by the Pennsylvania Supreme Court in 1982 as a means of helping clients recover some or all losses of money and/or property stolen from them by their attorneys. It is funded by a special annual assessment (\$35 for 2012-13) paid by any attorney admitted to practice law in Pennsylvania. Clients may receive up to \$100,000 for a claim.

The fund is supervised by the Pennsylvania Lawyers Fund for Client Security Board. This board includes five members of the bar of the Supreme Court and two non-lawyer public members. Each member's term is three years in length, and a member may serve a maximum of two consecutive terms. Pennsylvania

Claims Categories

Fiduciary Funds – Theft of estate funds and trust/escrow funds consistently tops the list of claims filed against attorneys. During FY 2012–13 the fund awarded \$3,067,922 in this category, 88.55 percent of its total award dollars, settling 47 claims. Approximately 88.4 percent of these funds went to former clients of one attorney.

Real Estate Proceeds Embezzlement – Claims of misappropriation of real estate closing funds typically occur when an attorney acting as the settlement agent for a real estate transaction receives funds to close the transaction and then fails to disburse all of the funds to the appropriate parties. FY 2012–13 awards totaled \$149,818.

Nonperformance* – The acceptance of unearned fees or retainers represented the third largest category in which funds were awarded in FY 2012–13 with claimants receiving \$124,430.

*Since the fund does not arbitrate fee disputes, for an award to be considered when the attorney performed any services of value, the claimant typically must first file a complaint with the local bar association's fee dispute committee. If the committee determines that all or a portion of the fees or retainer paid were not earned, and the attorney does not return the fee, the board will consider this type of claim and categorize the award as nonperformance by the attorney.

Lawsuit Settlement Proceeds – Claims of misappropriation of settlement proceeds often occur when an attorney settles a lawsuit without the knowledge or consent of the client. The attorney receives the funds and fails to remit them to the client. Also included in this category are claims involving attorneys who withhold funds from settlement proceeds to pay clients' medical providers and fail to make the payment/s. Claims of \$95,361 were paid in FY 2012–13.

Fraud – Fraud claims occur when an attorney requests a loan from a client or agrees to hold and invest settlement funds on behalf of the client, then converts the funds for personal use. The types of claims that typically fall into this category are those where a longstanding attorney/client relationship has existed. They tend to be the most difficult to evaluate. Claimants received \$27,049 in FY 2012-13.

Notwithstanding the award amounts reported, it should be noted that claims are filed against fewer than one percent of all Pennsylvania licensed attorneys.

2012-13 Activities

County Bench, Bar Meetings

The board met in Hershey, Philadelphia and Pittsburgh in FY 2012-13.

As part of its ongoing mission to educate the legal community and Pennsylvania's citizens about the fund, the board holds informational dinners on the eves of its triannual meetings. Invitations are extended to the judiciary, bar leaders and prominent local citizens from the respective counties where the board meets as well as from the surrounding counties.

Restitution and Subrogation Efforts

All fund claimants are required to execute a subrogation agreement prior to the receipt of any award. This agreement assigns the fund the right to collect the award amount. The fund may receive restitution through civil collection efforts or through criminal restitution payments. During FY 2012-13, the fund recovered \$128,916 through restitution payments.

Mandatory Overdraft Notification

Pennsylvania Rule of Disciplinary Enforcement 221 requires financial institutions to report to the fund all checks drawn on attorney fiduciary accounts which contain insufficient funds. In 2012-13 the fund received 247 overdraft notices. One notice was pending. Of the 248 notices, 205 were reviewed and dismissed, and 28 were referred to the Office of Disciplinary Counsel. Fifteen notices remained pending at the end of the fiscal year.

Lawyers Concerned for Lawyers

With prior approval of the Supreme Court, the Pennsylvania Lawyers Fund for Client Security may provide funding to nonprofit organizations that assist Pennsylvania lawyers and judges who are impaired by alcohol or drugs. In accordance with this rule, during FY 2012-13 \$328,745 of funding was given to the organization known as Lawyers Concerned for Lawyers. Such assistance complements the fund's mission to ameliorate losses resulting from attorney dishonesty as oftentimes when an attorney converts client funds, the conduct is related to substance abuse or a gambling addiction. The financial support for Lawyers Concerned for Lawyers helps to mitigate the losses by providing a resource for impaired attorneys.







Of the total state government expenditures for fiscal year 2012-13 administrative costs for the judiciary amounted to approximately one-half of one percent. Table 5.1 on page 89 shows the distribution of expenditures across the three branches of government. (With the county reimbursement grants discussed below, the judiciary accounts for approximately 0.6 percent of total state government expenditures.)

Funding for the Unified Judicial System derives from both state and county appropriations. The federal government provides limited funding for specific programs of federal interest, notably the on-going Court Improvement Program. The state pays the salaries for all judicial officers as well as the personnel and operating costs of the entire appellate court system, including the committees of the Supreme Court and the Administrative Office of Pennsylvania Courts. Beginning January 1, 2000, in accordance with Act 12 of 1999, the Commonwealth also funds the salaries and benefits for district court administrators transferred to state service effective that date. Table 5.2 on page 90 provides a breakdown of the state appropriations for fiscal year 2012–13.

In fiscal year (FY) 2012–13, the judiciary saved more than \$8 million through a variety of measures, including the suspension of a staff COLA through the first quarter of the year, continuation of a 20 percent reduction in merit increments, not making appointments — at the request of the chief justice — to fill judge vacancies, a reduction of twelve magisterial district judge offices to date, and attrition.

County Reimbursement Program

The Commonwealth also provides reimbursement to the counties for costs incurred in support of the Common Pleas Courts. Counties are reimbursed for a percentage of juror costs incurred when a trial or grand jury proceeding lasts longer than three days.

In addition, counties have traditionally been reimbursed for personnel and operating costs associated with the administration of Court Finances -Fiscal Year 2012-2013 the Courts of Common Pleas. Reimbursement is based on a statutory rate of \$70,000 for each authorized Common Pleas judge position, which, in the case of insufficient funding, must be reduced in order to adjust to the appropriated amount.

The General Assembly also requires that counties spend an amount at least equal to the flat reimbursement rate per judge. Funding provided in FY 2012–13 allowed payment of the grant at the rate of \$66,819.

Counties also receive partial reimbursement for expenses they incur to provide support – facilities and staff services – to assigned Common Pleas senior judges in accordance with Pennsylvania Rule of Judicial Administration (R.J.A.) 701(F). Act 88 of 2001 served as the initial enabling legislation for the Senior Judge Support Reimbursement Grant and was succeeded by Act 37 of 2007. This grant has been provided each year since its inception in FY 2001-02.

Table 5.3 on page 93 identifies the amounts of reimbursement provided to each county, by grant program, for FY 2012–13.

Although not requested by the judiciary, \$1.1 million was appropriated in FY 2012–13 for a court consolidation grant for Allegheny County for legislative reasons.

Local, State Government Revenue

The Unified Judicial System is a source of considerable revenue to local and state government. An example of this revenue can be found in Table 5.4 on page 96, which lists fees collected by the appellate courts, the Minor Judiciary Education Board and the Pennsylvania Board of Law Examiners. Appropriated by the General Assembly, these fees are used to support state-funded court operations.

Included in the table are revenues from a fee created during FY 2009-10 to supplement and help close shortfalls in state funding. Act 49 of 2009 imposed a temporary, 25-month surcharge beginning December 8, 2009; Act 30 of 2011 extended the fee through December 31, 2014. Of the total \$13.50 surcharge imposed on court filings and recordings of deeds, \$10.25 was earmarked for use by the Supreme Court in closing deficits within the various judiciary appropriations. The surcharge generated \$16.308 million in FY 2012-13, which was used to supplement judiciary state appropriations.

Although exact figures are not available, the court system raises millions of dollars in revenue for local municipalities. Depending on the police department (local or state) from which a citation is issued, a portion of fines collected is disbursed to local political subdivisions after adjudication within the Unified Judicial System. Some examples of these fines include traffic violations under the vehicle code, violations of local ordinances and certain violations of summary offenses.

Counties also receive court-collected fines, fees and costs. Fees are generated in connection with the commencement of actions or the filing of liens, appeals and accounts, etc. On an annual basis, the collections amount to tens of millions of dollars. The monies are collected by courts at all levels of the system.

Finally, a portion of the revenues collected by the courts is earmarked for the state. Some of these funds are program specific, e.g., Pennsylvania's Emergency Medical Fund and the Crime Victims' Compensation Board. Others are used, through Act 64 of 1987 and Act 59 of 1990, as amended by Act 122 of 2002, to provide funding for the statewide Judicial Computer System. Still other monies collected, such as motor vehicle fines, revert to state general use.

Judicial Conduct Board/Court of Judicial Discipline

As part of the reform of the judicial discipline process, the Judicial Conduct Board and the Court of Judicial Discipline were established as independent organizations responsible for their own affairs, including financial matters. Pursuant to Act 56 of 1993, however, their annual budget requests are made as separate line items in the Supreme Court's request to the General Assembly on behalf of the judicial branch.

County Reimbursements for Courts, continued FY 2012-13

FUNDING METHODOLOGIES:

Juror Cost - The grant reimburses counties for 80 percent of the amounts they expend for compensation and travel allowances to jurors participating in a trial or grand jury proceedings after the first three days of service.

County Court - The grant provides reimbursement for costs associated with the administration and operation of the Courts of Common Pleas. For FY 2012-13 the reimbursement was paid at a rate of \$66,819 per authorized Common Pleas position whether filled or vacant, which represents the proportional reduction made to each county's grant as required by Act 37 of 2007 in order to adjust to insufficient funding to pay at the statutory \$70,000 reimbursement rate. In order for counties to receive the full reimbursement, they must provide a level of support at least equal to the reimbursement rate per authorized position. Nevertheless, except when required by Act 37 in the case of insufficient funding, no county will receive less than 77.5 percent of the actual reimbursement for court costs provided to it from state funds appropriated for the fiscal year July 1, 1980, to June 30, 1981.

Senior Judge - The grant provides partial reimbursement for expenses counties incur to provide support - facilities and staff services - to assigned Common Pleas Court senior judges in accordance with Rule of Judicial Administration 701. Facilities include the use of judicial chambers, office equipment and supplies. Staff services include the services of law clerks and secretaries. The use of facilities is reimbursed at the current statutory rate of \$60 per day, billable in half-day increments. Services of a secretary are reimbursed at \$12 per hour and the services of a law clerk at \$20 per hour. Imposition of the Act 37 cap limiting any county's payment to 20 percent of the total appropriation reduced Philadelphia's FY 2012-13 reimbursement from \$417,108 to \$267,000. All other counties received 100 percent of their reimbursement request.

Court Accounts (Court Consolidation Grant) - \$1.1 million was appropriated to the Court Consolidation Grant in FY 2012-13. This funding was not requested by the judiciary, but was provided for legislative reasons.
