REALIGNMENT OF MAGISTERIAL DISTRICT COURTS FOR THE 44TH JUDICIAL DISTRICT CONSISTING OF WYOMING AND SULLIVAN COUNTIES

1. INTRODUCTION:

During the last several years the Pennsylvania Judiciary has experienced tens of millions of dollars in budget cutbacks. Due to these cutbacks the Judiciary has experienced significant budget shortfalls.

In response to these shortfalls, the Supreme Court has enacted several cost cutting measures. Regarding the number of Magisterial District Judge (MDJ) offices, the Supreme Court has set a goal of reducing the number of MDJ courts across the state by ten (10%) percent over the next two (2) to six (6) years.

In October of 2011, the 44th Judicial District, Wyoming and Sullivan Counties was notified by the Administrative Office of Pennsylvania Courts (AOPC) of its requirement under 42 Pa. C.S.A. § 1503, to participate in the re-establishment of Magisterial District Courts. The following factors were taken into consideration during the development of this plan. AOPC guidelines as set forth by the AOPC (a copy being attached to this report), case filing statistics and workload statistics for criminal, non-traffic private complaints, traffic, civil, landlord/tenant and miscellaneous filings for the Magisterial District Courts in the 44th Judicial District as well as census reports for Wyoming and Sullivan Counties.

2. EVALUATION PROCESS:

The Supreme Court through the AOPC has provided each county with the number of case filings for each MDJ Court for the last six (6) years and estimated workload with respect to those filings. In addition the countywide and statewide averages and census figures for 2000 and 2010 were provided.

The case filing data provides the total number of all cases filed with each MDJ office. These cases include all criminal, civil, traffic, non-traffic, landlord/tenant, arraignments for other courts, search warrants, writs of execution and marriages. The "workload data" is a weighted system which evaluated each type of filing based on the time involved in resolving a typical case of that nature. The AOPC developed this formula to present a more accurate basis for comparison of the amount of work each office performs.

3. SULLIVAN COUNTY STATISTICS:

Sullivan County is an 8th class county. There are currently six (6) 8th class counties consisting of Cameron, Forest, Fulton, Montour, Potter and Sullivan. District Court 44-3-03 is the only Magisterial District Court in Sullivan County located in the Sullivan County Courthouse. The 2005-2010 average caseload for this office is 2,175 cases per year and the average 2005-2010 workload for this office is 11,932. The average caseload for that period for 8th class counties is 2,209 and workload is 12,778.

In summary, this office handles 100% of the caseload and workload in Sullivan County. The caseload is 2% below the average for all 8th class counties and is on the average for workload. Based upon the 8th class county averages, this office is well balanced and is the only office within the confines of Sullivan County and therefore no re-establishment is recommended.

4. WYOMING COUNTY STATISTICS:

Wyoming County is currently a 7th class county. There are five (5) 7th class counties which include Juniata, Perry, Snyder, Union and Wyoming.

The average Wyoming County caseload for the period of 2005-2010 is 2,484 cases. The average Wyoming County workload for that period is 17,776. In comparison, all 7th class counties the average caseload is 3,139 and workload is 24,334.

In summary the Wyoming County caseload and workload averages are significantly lower than the state averages for 7th class counties. Specifically, of the three Wyoming County offices, Magisterial District Court 44-3-01 was 55% below the state workload average, Magisterial District Court 44-3-02 was 38% below the state workload average and Magisterial District Court 44-3-04 was 7% above the state average. Wyoming County was last in caseload and second to last for workload for 7th class counties.

5. DISCUSSION AND RECOMMENDATIONS FOR WYOMING COUNTY MAGISTERIAL DISTRICT COURTS 44-3-01, 44-3-02 AND 44-3-04:

In review of the 2000 and 2010 census information, Wyoming County had a slight population increase of approximately seven tenths of one percent which equates to 196 residents. Population as of the 2010 census was 28,276.

It should be noted that Wyoming County is experiencing a great influx of workers due to marcellus shale being discovered in abundance. In Wyoming County, numerous gas wells have been drilled with many proposed and underway. In conjunction with the gas wells, there are numerous gathering pipelines being constructed. This marcellus shale boom as in neighboring counties has brought an increase in crime. This has also been the case for Wyoming County. It is anticipated that the majority of the associated drilling industry workers will not remain in Wyoming County after the drilling operations are completed.

Based upon the AOPC re-establishment guidelines, the preference is to eliminate Magisterial Districts through attrition from two to six years in the future.

To this end the next Magisterial District Judge to reach mandatory retirement in Wyoming County is the presiding judge for 44-3-04. He must retire on December 31, 2015. This would leave that office vacant as of January 1, 2016.

It is significant to note that based upon the pending Marcellus shale "boom" in Wyoming County, the ability to maintain the three offices until the retirement of the judge in 44-3-04 is advisable and prudent. At that time the bulk of drilling and pipeline construction should be completed.

6. RECOMMENDATIONS:

Based upon the AOPC Magisterial District re-establishment guidelines and the caseload and workload calculations, Wyoming County is significantly behind state averages.

It is the recommendation of this court that Sullivan County Magisterial District Court 44-3-03 remain as the sole Magisterial District Court in Sullivan County.

It is the recommendation of this court that Wyoming County Magisterial District Court

44-3-04 be eliminated, effective January 1, 2016 and the remaining District Courts be re-aligned in order to absorb the additional workload evenly between the remaining two Magisterial Districts.

Based upon this recommendation, Wyoming County would be reduced from three to two Magisterial District Courts, effective January 1, 2016. Those courts would be comprised of the following

- Magisterial District Court 44-3-01, Clinton Township, Lemon Township, Nicholson Borough, Nicholson Township, Overfield Township, Factoryville Borough, Falls Township, Exeter Township, Tunkhannock Township and Washington Township.
- 2. **Magisterial District Court 44-3-02**, Eaton Township, Monroe Township, Northmoreland Township, Noxen Township, Tunkhannock Borough, Mehoopany Township, North Branch Township, Meshoppen Township, Meshoppen Borough, Forkston Township, Windham Township, Braintrim Township and Laceyville Borough

In making this recommendation the court has taken into consideration the following factors:

- 1. This elimination and realignment does not conflict with current judge's residences or office locations.
- 2. The increase in court activity due to marcellus shale drilling.
- 3. The retirement dates of all active magisterial judges.
- 4. The travel time for Wyoming and Sullivan County residents.
- 5. No office staff reduction, since case and workload would remain.
- 6. Magisterial District Judge election years.
- 7. Wyoming and Sullivan County census figures.
- 8. Continued improvements in modern technology, such as E-filing which will enable more efficient operation of offices.

- 9. The workload of the remaining offices will not exceed ten (10%) percent of the county average.
- 10. Participation of Magisterial District Judges in specialty courts.

7. CONCLUSION:

The elimination of Magisterial District Court 44-3-04 and realignment of all Wyoming County municipalities into two Magisterial Districts would comply with all requirements of the Supreme Court which provide:

- 1. All municipalities in the Magisterial District must be contiguous.
- 2. Each physical office must be located in the Magisterial District.
- The Magisterial District Judge must sit in the district in which the judge resides.
- 4. Municipalities are not divided.
- No Wyoming or Sullivan County Districts should deviate more than 15% of the county average workload. Both workload and caseload would be within ten (10%) percent of the 7th and 8th county averages respectively.

The above plan is being submitted for public comment, effective February 29, 2012 and shall be accepted through March 29, 2012 and such comments shall be included in the final report to be submitted to the Pennsylvania Supreme Court. All public comment shall be in writing and shall contain the name and address of the party making such comment. WHAT YOUR PACKET OF INFORMATION CONTAINS

- Case filings statistics by case type for the last six years (2005-2010) for each magisterial district within your judicial district. While we can provide a breakdown of filings by municipality for criminal, traffic, non-traffic and private complaints, we are not able to provide a breakdown by ward within a municipality. Civil, landlord-tenant and miscellaneous docket statistics are available by magisterial district.
- 2. For comparison purposes, average filings are provided by case type for each county and class of county statewide.
- 3. In addition to case filing statistics, a new measure was developed earlier this year to differentiate among case types and the resulting judicial workload that arises from those filings. This measure was developed by a committee of approximately twenty magisterial district judges (MDJs) from districts of varying size and demographics, representative of the Commonwealth; and is based upon empirical studies of the amount of judge time required to process each case type. Actual case filings are then adjusted by the relative case type weights derived from the study. We call this measurement workload since it measures not just the volume of filings within a magisterial district, but the relative amount of work required by the judge.
- 4. 2000 and 2010 United States Census Bureau population statistics and population density calculations for each county.
- 5. Magisterial district judge term expiration and birthdate data for each judge within your judicial district.

ANALYSIS OF POSSIBLE ELIMINATION OF DISTRICTS

The Chief Justice established a goal of reducing the number of magisterial districts statewide by 10%. This does not mean that each judicial district must reduce the number of MDJs by 10%; or that any elimination must occur immediately. The goal of the Supreme Court is that by the end of the process there will be 10% fewer magisterial districts statewide. Each president judge, therefore, is being asked to assess whether it is feasible to eliminate any of the magisterial districts in your county. Elimination of magisterial districts should include both an analysis of the data and consideration of additional relevant circumstances; and should ensure any modifications do not compromise the effective and efficient administration of justice.

- The strong preference is to eliminate magisterial districts through attrition. Whenever
 practicable, reductions should occur by eliminating a district which is vacant or in which the
 incumbent is retiring or not planning to seek reelection. As a result, elimination of districts
 may occur anywhere from two to six years in the future, depending upon retirement dates.
 There might be circumstances, however, where elimination of a district needs to occur but
 no vacancies are in the offing. In that instance, care should be taken to ensure that the
 elimination of the district occurs at the conclusion of the incumbent judge's term.
- 2. When it is not feasible to eliminate a magisterial district based on attrition, average caseload should be used to evaluate whether to eliminate one or more magisterial districts.

EXHIBIT A

MAGISTERIAL DISTRICT REESTABLISHMENT GUIDELINES

Using the data provided, begin by reviewing the average caseloads of the offices within your judicial district; and further compare your judicial district's average caseload with the average caseload for your class of county and judicial districts within your class of county. When a magisterial district falls at the lower end of this range, and absent a projected significant increase in filings, or other factors not reflected in the caseload statistics that may justify the continued existence of the smaller offices, serious consideration should be given to their elimination.

- 3. If the average caseload of the magisterial districts is not more than 10% above the average caseload for your class of county and you are not recommending the elimination of any districts, you <u>must</u> provide an explanation why no districts are being proposed for elimination.
- 4. Average caseload comparisons will guide the process in one of the following directions: eliminate one or more magisterial districts and realign the affected magisterial districts; or reestablish the magisterial district(s) and provide a rationale, if required.
- 5. To ensure effective court operations when confronted with eliminating one or more district courts, evaluate the workload within your judicial district. The workload calculation differentiates between treating all case types the same and acknowledging that a different level of effort is required for different types of cases. It is an impartial method to determine if the existing mix of case types and filings and the resulting workload is effective, or if there are areas within your judicial district where workload is concentrated. Realignment is helpful in alleviating imbalances.
- 6. No magisterial district should have a total workload which is 15% higher or lower than the workload of any other district in the judicial district. If a departure of that degree exists, an explanation must be provided that describes why this does not result in an inequity among the judges in the judicial district. Such explanation could include factors such as projected caseload growth, reduction in the effected districts, or the use of a central court or other mechanism that would redirect caseload.
- 7. In addition to assessing caseload and workload, the following factors should also be considered:
 - a. Every magisterial district court must be located within the magisterial district boundaries.
 - b. All portions of the magisterial district must be contiguous.
 - c. No district can be eliminated during the term of an incumbent MDJ.
 - d. District boundaries cannot be redrawn in such a way that would move an incumbent district judge's residence into another magisterial district.
 - e. Voting districts cannot be split.
 - f. Any planned development in the county such as a mall, highway expansion or gas drilling that will likely cause an increase in the case filings of the effected district should be discussed.

- g. Note any special programs in your county that will entail effort by MDJs, such as truancy programs or drug, veteran, or mental health diversion programs.
- h. Unlike the previous reestablishment guidelines, there is no hard and fast rule that no one within a district should have to travel more than one half hour to reach the MDJ office. Instead, public convenience and safety is a factor that should be considered and weighed along with all others.

- 1. In preparing your reestablishment plan, it is recommended that you begin by conferring with the MDJs in your county. While you obviously have the final say in making a recommendation to the Supreme Court, the input of the MDJs can provide invaluable information, such as retirement plans of judges and trends they have seen in their districts.
- 2. Proposed reestablishment plans must be posted for public comment before submission to AOPC. Interested parties should have at least thirty days from the publishing date to submit comments. Posting can be done by electronic posting of the proposal on the court or county website and/or by placing a physical copy at various public locations such as public libraries and court offices. Media outlets in your county should be alerted to the posting of the proposal. A copy of the posting and any public comments received should be submitted along with your final proposal.
- 3. Complete a worksheet detailing the specific proposal for your judicial district and each magisterial district (sample attached).
- 4. Certify that the office and residence of the MDJ are within the district boundaries.
- 5. All complete plans must be submitted to the AOPC by February 15, 2012.





REALIGNMENT OF MAGISTERIAL DISTRICT COURTS FOR THE 44TH JUDICIAL DISTRICT CONSISTING OF WYOMING AND SULLIVAN COUNTIES

1. INTRODUCTION:

During the last several years the Pennsylvania Judiciary has experienced tens of millions of dollars in budget cutbacks. Due to these cutbacks the Judiciary has experienced significant budget shortfalls.

In response to these shortfalls, the Supreme Court has enacted several cost cutting measures. Regarding the number of Magisterial District Judge (MDJ) offices, the Supreme Court has set a goal of reducing the number of MDJ courts across the state by ten (10%) percent over the next two (2) to six (6) years.

In October of 2011, the 44th Judicial District, Wyoming and Sullivan Counties was notified by the Administrative Office of Pennsylvania Courts (AOPC) of its requirement under 42 Pa. C.S.A. § 1503, to participate in the re-establishment of Magisterial District Courts. The following factors were taken into consideration during the development of this plan. AOPC guidelines as set forth by the AOPC (a copy being attached to this report), case filing statistics and workload statistics for criminal, non-traffic private complaints, traffic, civil, landlord/tenant and miscellaneous filings for the Magisterial District Courts in the 44th Judicial District as well as census reports for Wyoming and Sullivan Counties.

2. EVALUATION PROCESS:

The Supreme Court through the AOPC has provided each county with the number of case filings for each MDJ Court for the last six (6) years and estimated workload with respect to those filings. In addition the countywide and statewide averages and census figures for 2000 and 2010 were provided.

The case filing data provides the total number of all cases filed with each MDJ office. These cases include all criminal, civil, traffic, non-traffic, landlord/tenant, arraignments for other courts, search warrants, writs of execution and marriages. The "workload data" is a weighted system which evaluated each type of filing based on the time involved in resolving a typical case of that nature. The AOPC developed this formula to present a more accurate basis for comparison of the amount of work each office performs.

3. SULLIVAN COUNTY STATISTICS:

Sullivan County is an 8th class county. There are currently six (6) 8th class counties consisting of Cameron, Forest, Fulton, Montour, Potter and Sullivan. District Court 44-3-03 is the only Magisterial District Court in Sullivan County located in the Sullivan County Courthouse. The 2005-2010 average caseload for this office is 2,175 cases per year and the average 2005-2010 workload for this office is 11,932. The average caseload for that period for 8th class counties is 2,209 and workload is 12,778.

In summary, this office handles 100% of the caseload and workload in Sullivan County. The caseload is 2% below the average for all 8th class counties and is on the average for workload. Based upon the 8th class county averages, this office is well balanced and is the only office within the confines of Sullivan County and therefore no re-establishment is recommended.

4. WYOMING COUNTY STATISTICS:

Wyoming County is currently a 7th class county. There are five (5) 7th class counties which include Juniata, Perry, Snyder, Union and Wyoming.

The average Wyoming County caseload for the period of 2005-2010 is 2,484 cases. The average Wyoming County workload for that period is 17,776. In comparison, all 7th class counties the average caseload is 3,139 and workload is 24,334.

In summary the Wyoming County caseload and workload averages are significantly lower than the state averages for 7th class counties. Specifically, of the three Wyoming County offices, Magisterial District Court 44-3-01 was 55% below the state workload average, Magisterial District Court 44-3-02 was 38% below the state workload average and Magisterial District Court 44-3-04 was 7% above the state average. Wyoming County was last in caseload and second to last for workload for 7th class counties.

5. DISCUSSION AND RECOMMENDATIONS FOR WYOMING COUNTY MAGISTERIAL DISTRICT COURTS 44-3-01, 44-3-02 AND 44-3-04:

In review of the 2000 and 2010 census information, Wyoming County had a slight population increase of approximately seven tenths of one percent which equates to 196 residents. Population as of the 2010 census was 28,276.

It should be noted that Wyoming County is experiencing a great influx of workers due to marcellus shale being discovered in abundance. In Wyoming County, numerous gas wells have been drilled with many proposed and underway. In conjunction with the gas wells, there are numerous gathering pipelines being constructed. This marcellus shale boom as in neighboring counties has brought an increase in crime. This has also been the case for Wyoming County. It is anticipated that the majority of the associated drilling industry workers will not remain in Wyoming County after the drilling operations are completed.

Based upon the AOPC re-establishment guidelines, the preference is to eliminate Magisterial Districts through attrition from two to six years in the future.

To this end the next Magisterial District Judge to reach mandatory retirement in Wyoming County is the presiding judge for 44-3-04. He must retire on December 31, 2015. This would leave that office vacant as of January 1, 2016.

It is significant to note that based upon the pending Marcellus shale "boom" in Wyoming County, the ability to maintain the three offices until the retirement of the judge in 44-3-04 is advisable and prudent. At that time the bulk of drilling and pipeline construction should be completed.

6. RECOMMENDATIONS:

Based upon the AOPC Magisterial District re-establishment guidelines and the caseload and workload calculations, Wyoming County is significantly behind state averages.

It is the recommendation of this court that Sullivan County Magisterial District Court 44-3-03 remain as the sole Magisterial District Court in Sullivan County.

It is the recommendation of this court that Wyoming County Magisterial District Court

44-3-04 be eliminated, effective January 1, 2016 and the remaining District Courts be re-aligned in order to absorb the additional workload evenly between the remaining two Magisterial Districts.

Based upon this recommendation, Wyoming County would be reduced from three to two Magisterial District Courts, effective January 1, 2016. Those courts would be comprised of the following

- Magisterial District Court 44-3-01, Clinton Township, Lemon Township, Nicholson Borough, Nicholson Township, Overfield Township, Factoryville Borough, Falls Township, Exeter Township, Tunkhannock Township and Washington Township.
- 2. **Magisterial District Court 44-3-02**, Eaton Township, Monroe Township, Northmoreland Township, Noxen Township, Tunkhannock Borough, Mehoopany Township, North Branch Township, Meshoppen Township, Meshoppen Borough, Forkston Township, Windham Township, Braintrim Township and Laceyville Borough

In making this recommendation the court has taken into consideration the following factors:

- 1. This elimination and realignment does not conflict with current judge's residences or office locations.
- 2. The increase in court activity due to marcellus shale drilling.
- 3. The retirement dates of all active magisterial judges.
- 4. The travel time for Wyoming and Sullivan County residents.
- 5. No office staff reduction, since case and workload would remain.
- 6. Magisterial District Judge election years.
- 7. Wyoming and Sullivan County census figures.
- 8. Continued improvements in modern technology, such as E-filing which will enable more efficient operation of offices.

- 9. The workload of the remaining offices will not exceed ten (10%) percent of the county average.
- 10. Participation of Magisterial District Judges in specialty courts.

7. CONCLUSION:

The elimination of Magisterial District Court 44-3-04 and realignment of all Wyoming County municipalities into two Magisterial Districts would comply with all requirements of the Supreme Court which provide:

- 1. All municipalities in the Magisterial District must be contiguous.
- 2. Each physical office must be located in the Magisterial District.
- The Magisterial District Judge must sit in the district in which the judge resides.
- 4. Municipalities are not divided.
- No Wyoming or Sullivan County Districts should deviate more than 15% of the county average workload. Both workload and caseload would be within ten (10%) percent of the 7th and 8th county averages respectively.

The above plan is being submitted for public comment, effective February 29, 2012 and shall be accepted through March 29, 2012 and such comments shall be included in the final report to be submitted to the Pennsylvania Supreme Court. All public comment shall be in writing and shall contain the name and address of the party making such comment. WHAT YOUR PACKET OF INFORMATION CONTAINS

- Case filings statistics by case type for the last six years (2005-2010) for each magisterial district within your judicial district. While we can provide a breakdown of filings by municipality for criminal, traffic, non-traffic and private complaints, we are not able to provide a breakdown by ward within a municipality. Civil, landlord-tenant and miscellaneous docket statistics are available by magisterial district.
- 2. For comparison purposes, average filings are provided by case type for each county and class of county statewide.
- 3. In addition to case filing statistics, a new measure was developed earlier this year to differentiate among case types and the resulting judicial workload that arises from those filings. This measure was developed by a committee of approximately twenty magisterial district judges (MDJs) from districts of varying size and demographics, representative of the Commonwealth; and is based upon empirical studies of the amount of judge time required to process each case type. Actual case filings are then adjusted by the relative case type weights derived from the study. We call this measurement workload since it measures not just the volume of filings within a magisterial district, but the relative amount of work required by the judge.
- 4. 2000 and 2010 United States Census Bureau population statistics and population density calculations for each county.
- 5. Magisterial district judge term expiration and birthdate data for each judge within your judicial district.

ANALYSIS OF POSSIBLE ELIMINATION OF DISTRICTS

The Chief Justice established a goal of reducing the number of magisterial districts statewide by 10%. This does not mean that each judicial district must reduce the number of MDJs by 10%; or that any elimination must occur immediately. The goal of the Supreme Court is that by the end of the process there will be 10% fewer magisterial districts statewide. Each president judge, therefore, is being asked to assess whether it is feasible to eliminate any of the magisterial districts in your county. Elimination of magisterial districts should include both an analysis of the data and consideration of additional relevant circumstances; and should ensure any modifications do not compromise the effective and efficient administration of justice.

- The strong preference is to eliminate magisterial districts through attrition. Whenever
 practicable, reductions should occur by eliminating a district which is vacant or in which the
 incumbent is retiring or not planning to seek reelection. As a result, elimination of districts
 may occur anywhere from two to six years in the future, depending upon retirement dates.
 There might be circumstances, however, where elimination of a district needs to occur but
 no vacancies are in the offing. In that instance, care should be taken to ensure that the
 elimination of the district occurs at the conclusion of the incumbent judge's term.
- 2. When it is not feasible to eliminate a magisterial district based on attrition, average caseload should be used to evaluate whether to eliminate one or more magisterial districts.

EXHIBIT A

MAGISTERIAL DISTRICT REESTABLISHMENT GUIDELINES

OCTOBER 2011

Using the data provided, begin by reviewing the average caseloads of the offices within your judicial district; and further compare your judicial district's average caseload with the average caseload for your class of county and judicial districts within your class of county. When a magisterial district falls at the lower end of this range, and absent a projected significant increase in filings, or other factors not reflected in the caseload statistics that may justify the continued existence of the smaller offices, serious consideration should be given to their elimination.

- 3. If the average caseload of the magisterial districts is not more than 10% above the average caseload for your class of county and you are not recommending the elimination of any districts, you <u>must</u> provide an explanation why no districts are being proposed for elimination.
- 4. Average caseload comparisons will guide the process in one of the following directions: eliminate one or more magisterial districts and realign the affected magisterial districts; or reestablish the magisterial district(s) and provide a rationale, if required.
- 5. To ensure effective court operations when confronted with eliminating one or more district courts, evaluate the workload within your judicial district. The workload calculation differentiates between treating all case types the same and acknowledging that a different level of effort is required for different types of cases. It is an impartial method to determine if the existing mix of case types and filings and the resulting workload is effective, or if there are areas within your judicial district where workload is concentrated. Realignment is helpful in alleviating imbalances.
- 6. No magisterial district should have a total workload which is 15% higher or lower than the workload of any other district in the judicial district. If a departure of that degree exists, an explanation must be provided that describes why this does not result in an inequity among the judges in the judicial district. Such explanation could include factors such as projected caseload growth, reduction in the effected districts, or the use of a central court or other mechanism that would redirect caseload.
- 7. In addition to assessing caseload and workload, the following factors should also be considered:
 - a. Every magisterial district court must be located within the magisterial district boundaries.
 - b. All portions of the magisterial district must be contiguous.
 - c. No district can be eliminated during the term of an incumbent MDJ.
 - d. District boundaries cannot be redrawn in such a way that would move an incumbent district judge's residence into another magisterial district.
 - e. Voting districts cannot be split.
 - f. Any planned development in the county such as a mall, highway expansion or gas drilling that will likely cause an increase in the case filings of the effected district should be discussed.

- g. Note any special programs in your county that will entail effort by MDJs, such as truancy programs or drug, veteran, or mental health diversion programs.
- h. Unlike the previous reestablishment guidelines, there is no hard and fast rule that no one within a district should have to travel more than one half hour to reach the MDJ office. Instead, public convenience and safety is a factor that should be considered and weighed along with all others.

- 1. In preparing your reestablishment plan, it is recommended that you begin by conferring with the MDJs in your county. While you obviously have the final say in making a recommendation to the Supreme Court, the input of the MDJs can provide invaluable information, such as retirement plans of judges and trends they have seen in their districts.
- 2. Proposed reestablishment plans must be posted for public comment before submission to AOPC. Interested parties should have at least thirty days from the publishing date to submit comments. Posting can be done by electronic posting of the proposal on the court or county website and/or by placing a physical copy at various public locations such as public libraries and court offices. Media outlets in your county should be alerted to the posting of the proposal. A copy of the posting and any public comments received should be submitted along with your final proposal.
- 3. Complete a worksheet detailing the specific proposal for your judicial district and each magisterial district (sample attached).
- 4. Certify that the office and residence of the MDJ are within the district boundaries.
- 5. All complete plans must be submitted to the AOPC by February 15, 2012.




