PETITION TO SET ASIDE NOMINATION PETITION

The Petitioner, by and through counsel, respectfully avers that:

- 1. The Petitioners, Sean M. Kilkenny and Daniel J Collins III, are duly qualified electors who reside at 3406 Chippendale Avenue, Philadelphia, PA 19136, and 3440 Oakmont Street, Philadelphia, PA 19136, respectively and are registered in the above Legislative District in the same party as the Candidate.
- 2. The Respondent, Patrick L Gallagher, whose address is stated as 7301 Keystone St., Unit 315, Philadelphia, PA 19136, is the above referenced Candidate for the office of State Representative for the Democratic Party in the 173rd Legislative District.
- 3. On or before March 28, 2022, the above Candidate filed a Nomination Petiton as Candidate for the Democratic Nomination for the office of State Representative for the 173rd Legislative District. A copy of the Candidate's Nomination Petition is attached hereto and incorporated herein as Exhibit "A".
- 4.On or before March 28, 2022, the above Candidate filed a required Candidate's Affidavit for the Democratic Nomination for the office of State Representative of the 173rd Legislative District. A copy of the Candidate's Affidavit is attached and incorporated herein as Exhibit "B".
- 4. For the reasons set forth below the Candidate's Nomination Petition or other required filing is improperly drawn and was improperly filed.
- 5. The Nomination Petition or other required filing is defective as a matter of law and fails to conform to the requirements of the Pennsylvania Constitution and the Election Code. Specifically: Article 2, §5 of the Pennsylvania Constitution, which states:

"QUALIFICATIONS OF MEMBERS." "Senators shall be at least 25 years of age and Representatives 21 years of age. They shall have been citizens and inhabitants of the State for four years, and inhabitants of their districts one year next before their election "...,

- 6. Because the candidates affidavit accompanying his petition contained a false statement, that he was an inhabitant of the 173rd Legislative District one year next before the election. He is not a qualified candidate.
- 7. The Nomination Petition therefore fails to conform to the requirements of Election Code, 25 P.S. §2867 et seq., and must be set aside and the Candidate's name not be placed on, or stricken from, the ballot.
- 8. Petitioner respectfully reserves the right to add such additional objections as are appropriate at the time of the hearing.

WHEREFORE, Petitioner(s)/Objector(s) above-named, request this Honorable Court to GRANT this Petition and set aside the Nomination Petition of Respondent as a Democratic Candidate for the Office of State Representative for the 173rd District for the Primary Election to be held on May 17, 2022.
