PETITION TO SET ASIDE NOMINATING PETITIONS OF STEPHEN KINSEY

AND NOW, come Petitioners, by their counsel, Steve Masters, Esquire, and file the within Objections to the Nomination Petitions of Stephen Kinsey and, in support thereof avers as follows:

- 1. Exclusive jurisdiction over the subject matter of this Petition is vested in the Commonwealth Court of Pennsylvania by the provisions of the Pennsylvania Election Code, 25 P. S. § 2937, and the provisions of the Judicial Code, 42 Pa. C. S. A. § 764.
- 2. One Petitioner is Tonya Diane Bah who resides at 1456 West Chew Avenue, Philadelphia PA 19141 and is a duly registered and enrolled Democratic elector of the Commonwealth of Pennsylvania who votes and resides in the 201st Legislative District.
- 3. Another Petitioner is Bernadette Corbin who resides at 6115 N Beechwood Street, Philadelphia PA 19138 and is a duly registered and enrolled Democratic elector of the Commonwealth of Pennsylvania who votes and resides in the 201st Legislative District.
  - 4. Another Petitioner is Sherrie Joyce Cohen who resides at 5635 N 16th

Street, Philadelphia, PA 19141 and is a duly registered and enrolled Democratic elector of the Commonwealth of Pennsylvania who votes and resides in the 201st Legislative District.

- 5. Another Petitioner is Laura S. Richlin who resides at 5430 Laurens Street, Philadelphia, PA 19144 and is a duly registered and enrolled Democratic elector of the Commonwealth of Pennsylvania who votes and resides in the 201st Legislative District.
- 6. One Respondent is Stephen Kinsey, a candidate for State
  Representative in the 201st Legislative District, who allegedly resides at 813 E
  Haines Street, Philadelphia PA 19138.
- 7. Another Respondent is Leigh M. Chapman, the acting Secretary of the Commonwealth, whose office is located at 305 North Office Building, Harrisburg, Pennsylvania.
- 8. At various times between March 23, 2022 and March 28, 2022,
  Nominating Petitions and Papers were filed with the Pennsylvania Department of
  State, Bureau of Elections, nominating Respondent, Stephen Kinsey, as a
  Democratic candidate for State Representative in the 201st Legislative District.
- 9. Eligibility to serve as a Representative in the General Assembly is governed by Article II, Section 5 of the Pennsylvania Constitution. It states as follows:

Senators shall be at least twenty-five years of age and Representatives twenty-one years of age. They shall have been citizens and inhabitants of the State four years, and inhabitants of their respective districts one year next before their election (unless absent on the public business of the United States or of this State), and shall reside in their respective districts during their terms of service.

Pa. Const. Art. II §5 (emphasis added).

- 10. Section 910 of the Pennsylvania Election Code entitled "Affidavits of Candidates" requires each candidate to file an affidavit along with his nomination petition which states (a) his residence, with street and number, if any, and his post-office address; (b) his election district, giving city, borough, town or township; (c) the name of the office for which he consents to be a candidate; (d) that he is eligible for such office; and (e) that he will not knowingly violate any provision of this act, or of any law regulating and limiting nomination and election expenses and prohibiting corrupt practices in connection therewith. 25 P.S. §2870.
- 11. In his candidate affidavit filed along with his nomination petitions, Respondent Kinsey falsely swore that he resides at 813 E Haines Street, Philadelphia PA 19138, which is located within the 201st Legislative District. A copy of the candidate affidavit is attached hereto as Exhibit "A".
- 12. Respondent Kinsey also falsely stated that he resides at 813 E Haines Street, Philadelphia PA 19138 in the preamble on his nomination petition and on line 12 of page 2 side one of his nomination petitions, where he added his false residence address alongside his signature on his own petition. A copy of the nomination petition with Kinsey's signature is attached hereto as Exhibit "B".
  - 13. In fact, Respondent Kinsey has never lived at 813 E Haines Street,

which is a single family home owned and occupied by a married couple, Laverne Bosiac Jackson and James A. Jackson.

- 14. On information and belief, Respondent Kinsey is the single custodial parent of his minor daughter, and the residence where he lives together with his minor daughter at 1403 Cardeza Street, Philadelphia PA 19150 constitutes his family residence under the holding of *In re Nomination Petition of Driscoll*, 577 Pa. 501, 847 A.2d 44 (Pa. 2004).
- 15. Respondent Kinsey also falsely swore in his candidate affidavit that he is eligible to serve as the Representative in the General Assembly for the 201st Legislative District. The family residence where Respondent Kinsey actually lives together with his minor daughter, Myla Kinsey, 1403 Cardeza Street, Philadelphia PA 19150, is not now nor has it ever been located within the 201st Legislative District.
- 16. Not only is Respondent Kinsey ineligible to serve for the term he now seeks with these nominating petitions, he is in fact not currently eligible to serve as the Representative of the 201st Legislative District for the current term to which he was previously elected.
- 17. A false candidate's affidavit is a fatal defect that cannot be amended. In re Beyer, 115 A.3d 835 (Pa. 2015); Petition of Pippy, 711 A.2d 1048 (Pa. Cmwlth.), aff'd, 709 A.2d 905 (Pa. 1998); In re Nomination Petition of Cianfrani, 359 A.2d 383 (Pa. 1976).
  - 18. Pursuant to 25 P.S. §2937, Objectors hereby object to the nominating

petitions of Respondent Stephen Kinsey, are prepared to substantiate these objections via testimony and evidence presented at a prompt hearing as mandated by 25 P.S. § 2937, and seek to have the Respondent Kinsey's nomination petitions set aside in accordance with the governing law and Kinsey removed from the May 17, 2022 primary ballot as a Democratic Party candidate for the Pennsylvania State House for the 201st Legislative District, in addition to all other relief in law and equity which may be deemed just, including costs.




