The Petitioner, Rafael Roque ("Petitioner"), files this Petition to Set Aside the Nomination Petition of DAVID RODRIGUEZ ("Rodriguez" or "Candidate") for Democratic Nomination for State Committee, Philadelphia County, 3rd Senatorial District, District 503 ("Nomination"), in the Commonwealth of Pennsylvania, in the Primary Election to be held on May 17, 2022. Petitioner seeks this relief after having thoroughly reviewed the Nomination Petition and finding that said Nomination Petition does not contain a sufficient number of verifiable signatures from qualified electors eligible to vote in the May 17, 2022 primary election.

Accordingly, Petitioner hereby petitions this Honorable Court to remove Rodriguez from the May 17, 2022 primary election ballot for having failed to gather the required number of valid signatures in support thereof aver as follows:

#### PARTIES, JURISDICTION, AND VENUE

- 1. This Honorable Court has jurisdiction of this matter pursuant to 25 Pa. C.S. §§2913(a), 296-2937(2012) of the Pennsylvania Election Code.
- 2. Mr. Rodriguez purports to live at 4544 Palethorp Street, Philadelphia, PA 19140.
- 3. Petitioner, Rafael Roque, resides at 3852 North Fairhill Street, Philadelphia, PA, 19140, is a duly qualified elector and is a registered Democrat in Philadelphia County, 3rd Senatorial District, District 503.
- 4. Petitioner, as a registered and enrolled elector of the Democratic Party,
  Philadelphia County, 3rd Senatorial District, District 503, has a direct and substantial
  interest in the 2022 Primary Election and in the success of this Petition. See generally, In
  re Barlip, 59 Pa. Commw. Ct. 178, 181, 428 A.2d 1058 (1981).
- 5. On or about March 28, 2022 a Nomination Petition along with a Candidate's Affidavit (attached hereto as Exhibit "A") was filed with the Office of the Secretary of the Commonwealth, purporting to nominate DAVID RODRIGUEZ as a Democratic Nominee for Member of the Democratic State Committee, Philadelphia County, 3rd Senatorial District, District 503. Challenges to such nomination petitions may be filed by any qualified elector under 25 Pa. C.S. §2937, which governs the procedures for such challenges.

#### FACTUAL BACKGROUND

- 6. To appear as a candidate on the 2022 primary election ballot, Mr. Rodriguez must present at least 100 valid signatures from Democratic, registered, and enrolled electors of the Philadelphia County, 3rd Senatorial District, District 503. See 25 Pa. C.S. §2911.
- 7. On or about March 28, 2022, Mr. Rodriguez filed a Nomination Petition (the "Nomination Petition"), with the Secretary of the Commonwealth seeking to have his name printed on the Primary Election Ballot (the "Ballot") as a Democratic Candidate for Member of the Democratic State Committee, Philadelphia County, 3rd Senatorial District, District 503.
- 8. The Nomination Petition consists of 5 pages, numbered 1-30 accompanied by a Candidate's Affidavit. The Commonwealth of Pennsylvania's official form for Nomination Petition contains two sides and has spaces for 30 signers, and are intended to be county-specific. The original Nomination Petition and Candidate's Affidavit remain in the custody of Secretary of the Commonwealth and are incorporated herein by reference.
- 9. The Nomination Petition purports to contain 119 signatures, addresses, and dates of signing of qualified, registered Democratic electors (the "Signers") as well as supporting affidavits of the circulator for each page of the Nomination Petition (the "Circulator").

## THE REQUIRED PROCESS TO QUALIFY AS A DEMOCRATIC CANDIDATE ON THE MAY PRIMARY ELECTION BALLOT

10. Section 908 of the Election Code, 26 Pa. C.S. §2868, lists the requirements for each signer of a Nomination Petition. Each signer must:

- a. Sign but one such petition for each office to be filled;
- b. Declare therein that he is registered and enrolled member of the party designed in such petition.
- c. Declare therein that he is a qualified elector of the county therein named, and in the case the nomination is not to be made or candidates are not to be electors of the State at large, of the political district therein named, in which the nomination is to be made or the election is to be held;
- d. Add his residence, given city, borough or township, with street and number, if any, and shall legibly print his name and add the date of signing, expressed in words or numbers. Provided, however, that if the said political district named in the petition lies within any city, borough, or township, or is coextensive with same, it shall not be necessary for any signer of the nomination petition to state therein the city, borough or township of his residence.
- 13. Pursuant to 25 Pa. C.S. §2911 of the Pennsylvania Election Code, Mr. Rodriguez was required to file a nomination petition with at least 100 signatures.
- 14. Therefore, unless the Nomination Petition has been validly signed, in strict accordance with the requirements of the Election Code, by 100 valid signatures of registered and enrolled members of the Democratic Party in Philadelphia County, 3rd Senatorial District, District 503. the name of Mr. Rodriguez may not be printed as a candidate on the Primary Election Ballot.

## THE NOMINATION PETITION DOES NOT CONTAIN 100 VALID SIGNATURES AND CANDIDATE MUST BE REMOVED FROM THE BALLOT

15. The Pennsylvania Election Code, 25 Pa C.S. §§ 2600 et seq., (the "Election Code", herein cited only to Purdon's Statutes) and cases decided thereunder govern the matters covered by this Petition.

- 16. The Election Code sets forth the procedure by which a nomination petition may be set aside. See 25 Pa. C.S. §2937.
- 17. Petitioners and their representatives have reviewed the Nomination Petition (attached hereto as Exhibit "A") and based upon such review, believe, and therefore aver, that the Nomination Petition is defective, does not contain a sufficient number of genuine signatures of registered and enrolled members of the Democratic Party in Philadelphia County, 3rd Senatorial District, District 503. entitled to sign the same under the Election Code, and otherwise fails to comply with the Election Code.

#### **The Line Challenges Of Petitioners**

18. Petitioners, their counsel, and/or the volunteers who supported their efforts checked the signature lines of each page of the Nomination Paper submitted herein according to the following criteria, which is incorporated by reference as if fully set forth:

- 19. Each challenge as to each signer to the Nomination Petition is contained in Individual Lines Challenges, which are attached hereto as Exhibit "B" and incorporated by reference as if fully set forth herein.
- 20. On the face of the Nomination Petition, there are 119 completed signature lines with some indicia of a signature or other mark purporting to represent a qualified elector petitioning the Secretary of the Commonwealth to place Rodriguez's name on the Primary ballot.
- 21. Petitioner is challenging 61 of the 119 signature lines of the Petition leaving Rodriguez with less than 100 valid signatures as required by the Election Code. Without the line entries challenged on Exhibit "B" the Candidate lacks the number of signatures required to qualify for the May 2022 Primary.
- 22. Petitioners respectfully reserve the right to add such additional objections as are appropriate at the time of the hearing.

WHEREFORE, the Petitioner prays that this Honorable Court enter an Order as follows:

- 1. Setting aside the Nomination Petition of David Rodriguez;
- 2. Sustaining the objections of the Petitioner to the Nomination Petition; and
- 3. Directing the appropriate officers of the Commonwealth of Pennsylvania to strike and set aside the Nomination Petition of DAVID RODRIGUEZ and further directing them not to place the name of DAVID RODRIGUEZ on the ballot as a

Candidate for Member of the Democratic State Committee, Philadelphia County, 3rd Senatorial District, District 503.




