PETITION TO SET ASIDE NOMINATION PETITION

Objectors Michael Quinonez and Yelitza Quinonez, by and through counsel, respectfully aver that:

- 1. This Court has original jurisdiction in cases relating to election challenges for candidate for a member of Democratic State Committee pursuant to 25 P.S. § 2937.
- 2. On March 28, 2022, Billy A. Cortes ("Candidate") filed a nomination petition seeking election to Democratic State Committee representing Philadelphia County from the Third Senatorial District, which is classified by the Department of State as District 503.
 - 3. A copy of Candidate's nominating petition is attached as Exhibit A.
- 4. Both Objectors are a duly qualified electors and is a Democratic voter residing in the Third Senatorial District.
- 5. Both Objectors reside at 3822 N. 7th Street, Philadelphia, Pennsylvania 19140.
- 6. The Nominating Petition consists of four pages, containing information on 106 lines, including lines identified as incomplete by the Department of State. Candidates for State Committee are required to file nominating petitions with 100 valid signature lines. 25 P.S. § 2867.

- 7. The Nominating Petition contains 60 lines which are invalid. These objections are set forth on the spreadsheet attached hereto as <u>Exhibit B</u>. The Nominating Petition contains only 46 valid lines.
- 8. Objectors respectfully reserve the right to add such additional objections as are appropriate at the time of the hearing, to the extent permitted by law.
- 9. Because the Candidate's nominating petition does not contain the required 100 valid signature lines it must be set aside.

WHEREFORE, Objectors prays to set aside the Nomination Petition, and the Candidate's name shall not appear on the 2022 ballot.
