Petitioner Stacia Deutz, by and through her undersigned counsel, file this Petition to Set Aside the Nomination Petition of Mark LaVelle for the Republican Party Nomination for Representative in the General Assembly from the 177th Legislative District in the May 17, 2022 Primary Election.

I. **PARTIES**

- 1. Petitioner Stacia Deutz is a qualified and validly registered and enrolled elector registered with the Republican Party in Pennsylvania's 177th Legislative District. Petitioner Deutz resides at 1004 Haworth Street, Philadelphia, Pennsylvania.
- 2. Respondent Leigh M. Chapman is the Acting Secretary of the Commonwealth, whose office address is 302 North Office Building, 401 North Street, Harrisburg, Pennsylvania.
- 3. Respondent Mark LaVelle ("Candidate LaVelle"), whose address is 4425 East Thompson Street, Philadelphia, Pennsylvania, filed on March 28, 2022 a Nomination Petition (the "Nomination Petition") seeking to be listed on the ballot for the Republican Party nomination for Representative in the General Assembly from the 177th Legislative District in the May 17, 2022

Primary Election.

II. JURISDICTION

- 4. This Court has original jurisdiction over this matter pursuant to 42 Pa. C.S. § 764 and 25 P.S. § 2937.
- 5. The Pennsylvania Election Code governs the matters at issue in this Petition. *See generally* 25 P.S. §§ 2600 *et seq.*

III. FACTUAL BACKGROUND

- 6. On May 17, 2022, the Commonwealth of Pennsylvania will hold a Primary Election, at which registered Republican voters in the 177th Legislative District will choose the Republican Party's nominee for Representative in the General Assembly.
- 7. Candidate LaVelle's Nomination Petition consists of 26 pages accompanied by a Candidate's Affidavit. Copies of the Nomination Petition are attached to this Petition to Set Aside as **Exhibit A**. Copies of Candidate LaVelle's Candidate's Affidavit are attached to this Petition as **Exhibit B**.
- 8. The Nomination Petition purportedly contains 519 signature lines (some lines have been stricken or are completely blank), but, as detailed below, there are numerous ineligible signature and defects in the signatures. Candidate LaVelle's Nomination Petition is fatally defective.

IV. OBJECTION TO NOMINATION PETITION

- 9. To qualify for the Republican Party ballot for Representative in the General Assembly, a candidate must file a nomination petition containing 300 valid signatures of registered and enrolled members of the Republican Party. 25 P.S. § 2872.1(14).
 - 10. In addition, the Election Code specifies the requirements for circulating and signing

a Nomination Petition in order for the Nomination to be valid. 25 P.S. §§ 2868, 2869.

- 11. The Election Code also sets for the basis upon which the voters can challenge and object to a Nomination Petition. 25 P.S. § 2937.
- 12. Petitioner has reviewed Candidate LaVelle's Nomination Petition and believe the Nomination Petition is invalid, does not comply with the Election Code, and should be set aside because Candidate LaVelle failed to obtain at least 300 valid signatures.
- 13. Challenges to Individual Signature Lines. Petitioner is challenging at least 366 invalid and ineligible signature lines out of the 519 signature lines in Candidate LaVelle's Nomination Petition. Reducing the total signature lines in the Nomination by 366 invalid signatures results in only 153 valid signatures, well below the 300 signatures required to be listed on the ballot for the Republican Party nomination for Representative in the General Assembly:

519	signature lines submitted

- 14. The spreadsheet chart required by this Court's February 14, 2020 Standing Order, which describes with particularity and page by page, line by line, the signature lines being challenged in the Nomination Petition as ineligible or invalid is attached as **Exhibit C**.
- 15. *Circulators Lack Personal Knowledge.* In addition to bases for concluding that individual signature lines are invalid, upon information and belief, Petitioner avers that the circulators of nomination petition pages 2, 7, 8, 9, 10, 11, 12, 13, and 26 did not circulate the pages to the voters who signed those pages, and those circulators therefore lack the personal knowledge required to validate those pages, which therefore must be stricken.

16. This Court should set aside Candidate LaVelle's Nomination Petition because

Candidate LaVelle failed to obtain at least 300 valid signatures of registered and enrolled members

of the Republican Party required to qualify for the Republican Party ballot for Representative in

the General Assembly.

WHEREFORE, the Petitioner prays this Honorable Court enter an Order as follows:

Sustaining the objections of the Petitioner to the Nomination Petition of Mark A.

LaVelle;

В. Declaring that Mark LaVelle does not have the requisite number of valid signatures

as required under the Election Code to have her name placed on the ballot for the Republican Party

nomination for Representative in the General Assembly from the 177th Legislative District;

C. Setting aside the Nomination Petition of Mark LaVelle;

D. Directing the Secretary of the Commonwealth to set aside the Nomination Petition

of Mark LaVelle and further directing them not to place Mark LaVelle's name on the Republican

ballot for the Primary Election for Representative in the General Assembly from the 177th

Legislative District;

E. Ordering Mark LaVelle to pay costs of the proceedings, including attorney fees, as

the Court deems just, pursuant to 42 Pa. C.S. § 2503; and

F. Granting such further relief as the Court deems necessary and just.

NR = Not Registered

NRDS = Not Registered on Date Signed

OC = Out of County

III = IIIegible

LIO = Line Information Omitted

DUP = Duplicate

IHA = Line Information in Hand of Another

N/I = Nickname/Initial PRI = Printed Signature

Other = Any ground for objection not listed above (specify the

exact nature of the objection in the "Describe Other" cell)

Note: This list of abbreviations for the various grounds to object to a signature is also referred to as the "challenge codes key."

- 3. The objection petition shall clearly state the number of signature lines challenged as well as the total number of completed signature lines on the face of the nomination petitions or papers.
- 4. Any other objections, <u>e.g.</u>, to circulator affidavits, candidate affidavits, etc., must be clearly and separately stated in the objection petition.
- 5. If filing the objection petition in paper format:
 - a. Objector shall attach to the objection petition as an exhibit a printed copy of the spreadsheet printed on 8 ½ x 14 inch paper, with all grid lines showing and column headings appearing on each printed sheet, and a printed copy of the challenge codes key.
 - b. In addition, Objector shall file two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheets on the each

digital media devices must be enabled for editing by the Court, and may <u>not</u> be read-only or password protected.

- 6. If filing the objection petition by PACFile:
 - a. Along with the electronically filed objection petition, Objector shall file as an exhibit an electronic (PDF) version of the spreadsheet with all grid lines showing and column headings appearing on each sheet, and an electronic (PDF) version of the challenge codes key.
 - b. Within two days of submission of filing the objection petition and spreadsheet, Objector shall submit to the Court two paper copies of the electronically filed objection petition and spreadsheet and two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheet on the each digital media device must be enabled for editing by the Court, and may not be read-only or password protected.
- 7. Regardless of the method of filing, in addition to the usual service requirements Objector shall serve upon Candidate one digital media device containing a read-only electronic version of the spreadsheet and challenge codes key.
