PETITION TO SET ASIDE THE NOMINATION PETITION OF JOE MAURIZI AS CANDIDATE FOR MEMBER OF THE DEMOCRATIC STATE COMMITTEE FOR THE 45TH SENATORIAL DISTRICT OF ALLEGHENY COUNTY (DISTRICT 245)

TO: THE HONORABLE JUDGES OF THE COMMONWEALTH COURT OF PENNSYLVANIA

AND NOW, come Petitioners, Darlene McCreary Schrello and Colleen McCreary Seiler ("Petitioners"), by and through their counsel, Michael G. McCabe, Esquire, Jacob T. Leyland, Esquire and GRB Law, and file this Petition to Set Aside the Nomination Petition filed to place the name of Joe Maurizi as a candidate for Member of the Democratic State Committee for the 45th Senatorial District of Allegheny County (District 245) on the Pennsylvania ballot in the Primary Election to be held on May 17, 2022, and in support thereof, states the following:

I. INTRODUCTION, PARTIES AND JURISDICTION

- 1. Petitioner, Darlene McCreary Schrello, resides at 3731 Willett Road, Pittsburgh, PA 15227 and is a registered and enrolled member of the Democratic Party in the County of Allegheny, Commonwealth of Pennsylvania with a direct and substantial interest in the 2022 primary election, and, therefore, in the success of this Petition.
- 2. Petitioner, Colleen McCreary Seiler resides at 3735 Willett Road, Pittsburgh, PA 15227 and is a registered and enrolled member of the Democratic Party in the County of Allegheny, Commonwealth of Pennsylvania with a direct and substantial interest in the 2022 primary election, and therefore, in the success of this Petition.

- 3. On May 17, 2022, a Primary Election will be held in the Commonwealth of Pennsylvania (the "Election").
- 4. On or about March 28, 2022, Joseph Maurizi (the "Candidate" or "Mr. Maurizi") filed various nomination petitions (the "Nomination Petitions") with the Allegheny County Board of Elections to have his name printed on the Pennsylvania Primary Ballot (the "May Primary Election Ballot") as a candidate for the Democratic State Committee for the Allegheny County 45th Senatorial District (District 245). True and correct copies of Candidate's Nomination Petitions are attached hereto as Exhibit "A".
- 5. The Nomination Petitions consist of seven (7) pages (14 pages when reproduced and included below in Exhibit "A"). The original Nomination Petitions are in the custody of the Pennsylvania Department of State and are incorporated herein by reference.
- 6. The Nomination Petitions purport to contain the signatures, addresses and dates of 106 qualified registered Democratic electors, as well as supporting affidavits of the circulators of each Nomination Petition.
- 7. As detailed below, there are at least 17 signatures that are defective due to the following reasons:
 - a. Page 1, Side 1, Line 12: Elector is registered as "No Party Affiliation" within the 45th Senatorial District. Pursuant to 25 P.S. § 2872.1, only signatures of registered and enrolled members of the candidate's party are valid. A true and correct copy of Elector's voter registration, which lists Elector's party as "No Affiliation", is attached hereto as Exhibit "B".

- b. Page 1, Side 2, Line 17: Elector signed the Nomination Petition on March 2, 2022, which is prior to the first allowable date to circulate Nomination Petitions for signature. Pursuant to the 2022 Elections Calendar, Nomination Petitions for State Committee Members are only permitted to be circulated from March 18, 2022 through March 28, 2022. A true and correct copy of the 2022 Elections Calendar is attached hereto as Exhibit "C".
- c. <u>Page 2, Side 1, Line 8</u>: The date of Elector's signature is out of sequence. Elector signed on March 22, 2022; subsequent signatures are dated March 21, 2022.
- d. <u>Page 2, Side 1, Line 9</u>: The date of Elector's signature is out of sequence. Elector signed on March 22, 2022; subsequent signatures are dated March 21, 2022.
- e. <u>Page 2, Side 1, Line 10</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- f. Page 2, Side 1, Line 11: Elector's registration status is listed as "inactive". Pursuant to Elector's voter registration, Elector's registration status was canceled after Elector failed to vote in two (2) federal general elections. Elector last voted on May 21, 1991. Pursuant to 25 P.S. § 2872.1, only signatures of registered and enrolled members of the candidate's party are valid. Lastly, the date of Elector's signature is out of sequence. Elector signed on March 22, 2022; subsequent signatures are dated March 21, 2022. A true and correct copy of Elector's voter registration, which lists Elector's registration status as "Inactive", is attached hereto as Exhibit "D".

- g. Page 2, Side 1, Line 12: Elector is registered as "No Party Affiliation" within the 45th Senatorial District. Pursuant to 25 P.S. § 2872.1, only signatures of *registered and enrolled members of the candidate's party* are valid. Elector's signature is also out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022. A true and correct copy of Elector's voter registration, which lists Elector's party as "No Affiliation" is attached hereto as Exhibit "E".
- h. Page 2, Side 1, Line 13: Elector is registered as "No Party Affiliation" within the 45th Senatorial District. Pursuant to 25 P.S. § 2872.1, only signatures of *registered and enrolled members of the candidate's party* are valid. Elector's signature is also out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022. A true and correct copy of Elector's voter registration, which lists Elector's party as "No Affiliation" is attached hereto as Exhibit "F".
- i. <u>Page 2, Side 1, Line 14</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- j. <u>Page 2, Side 1, Line 15</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- k. <u>Page 2, Side 1, Line 16</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- 1. <u>Page 2, Side 1, Line 17</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.

- m. <u>Page 2, Side 1, Line 18</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- n. <u>Page 2, Side 1, Line 19</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- o. <u>Page 2, Side 1, Line 20</u>: The date of Elector's signature is out of sequence. Elector signed on March 21, 2022; prior signatures are dated March 22, 2022.
- p. Page 3, Side 1, Line 4: Elector is registered as a "Republican" within the 45th Senatorial District. Pursuant to 25 P.S. § 2872.1, only signatures of *registered* and enrolled members of the candidate's party are valid. Elector is also not registered to vote at the address provided on the Nomination Petition; Elector is registered at 1329 Cavitt Road, Monroeville, PA 15146. A true and correct copy of Elector's voter registration, which lists Elector's party as "Republican" and lists Elector's registration status as "Inactive", is attached hereto as Exhibit "G".
- q. Page 3, Side 1, Line 7: Elector is registered as a "Libertarian" within the 45th Senatorial District. Pursuant to 25 P.S. § 2872.1, only signatures of *registered* and enrolled members of the candidate's party are valid. A true and correct copy of Elector's voter registration, which lists Elector's party as "Libertarian" is attached hereto as Exhibit "H".
- 8. As a result of the aforementioned defects, the Candidate's Nomination Petitions contain insufficient valid signatures to qualify the Candidate for inclusion in the May Primary Election Ballot.

9. This Court has jurisdiction over the matter pursuant to 25 P.S. § 2937 and 42 Pa.C.S.A. § 931.

II. THE REQUIRED PROCESS FOR MS. BROWN TO QUALIFY AS A REPUBLICAN CANDIDATE ON THE MAY PRIMARY ELECTION BALLOT

- 10. Under the Pennsylvania Election Code, 25 P.S. § 2600 *et seq.* (the "Election Code"), the name of the candidate for a party nomination may not be placed on a primary ballot unless the candidate has filed a nomination petition validly signed by a certain number of duly registered and enrolled members of the candidate's party. *See* 25 P.S. § 2867.
- 11. Pursuant to Section 2872.1 of the Election Code, a candidate for a member of a State Committee must submit a nomination petition containing at least 100 valid signatures of registered and enrolled members of such party in the Candidate's Senatorial District. *See* 25 P.S. § 2872.1.
- 12. Thus, in accordance with the aforementioned statutes, the name of Mr. Maurizi can only be printed as a candidate on the May Primary Election Ballot if he has obtained 100 valid signatures of registered and enrolled members of the Democratic Party.
- 13. However, upon review by Petitioners and their representatives, Petitioners believe and therefore aver that the Nomination Petitions do not contain 100 signatures of registered and enrolled members of the Democratic Party entitled to sign the same.
- 14. Specifically, Petitioners and their representatives checked the signature lines of each page of the Nomination Petitions and have raised objections to at least 17 of the signatures obtained by Mr. Maurizi. These objections are raised for signatures that do not comply with the 2022 Important Notice to Candidates for Senator in the General Assembly, Representative in the General Assembly, and Member of State Committee. A true and correct copy of the 2022 Important Notice to Candidates for Senator in the General Assembly, Representative in the

General Assembly, and Member of State Committee is attached hereto as Exhibit "I". A spreadsheet containing each specific challenge to the challenged signature lines in the Nomination Petitions is attached hereto as Exhibit "J".

15. Petitioners' challenges affect the validity of 17 of the 106 signatures contained in the Nomination Petitions. With these challenges, Mr. Maurizi only obtained 89 signatures, 11 less than the amount required to qualify for the Election.

WHEREFORE, Petitioners pray that this Honorable Court enter an Order: (i) setting aside the Nomination Petitions of Joseph Maurizi; (ii) declaring that Joseph Maurizi does not have the requisite valid number of signatures as required under the Election Code to have his name placed on the ballot as a candidate for the Democratic State Committee in the Primary Election to be held in the Commonwealth of Pennsylvania on May 17, 2022; (iii) sustaining the objections of Petitioners; (iv) directing the appropriate officers of the Commonwealth of Pennsylvania to strike and set aside the Nomination Petitions of Joseph Maurizi and further directing the officers not to place the name of Joseph Maurizi on the ballot for Member of the Democratic State Committee; (v) ordering Joseph Maurizi and/or his official campaign and/or his campaign committee to make payment for the costs of these proceedings, including witness fees and such other reasonable costs and attorney fees incurred by Petitioners in bringing forth this Petition pursuant to 25 P.S. § 3937; and (vi) granting such other and further relief as this Court deems necessary and just.







2022 Pennsylvania Elections Important Dates

The Supreme Court of Pennsylvania's (SCOPA) February 23, 2022 Order revised the dates for the circulation and filing of nomination petitions solely for congressional and statewide offices. Subsequently, SCOPA's March 16, 2022 Order revised the dates for the circulation and filing of nomination petitions solely for Senator in the General Assembly, Representative in the General Assembly, and State Party Committees. The high-level important dates for the 2022 election cycle are listed below. For clarity, we have color coded certain dates on the calendar applicable to candidates for particular offices.

- Dates pertaining to the circulation and filing of nomination petitions for candidates for United States Senator, Governor, Lieutenant Governor, and Representative in Congress (which were set by <u>Order</u> of SCOPA on February 23, 2022) are indicated in red.
- Dates pertaining to the circulation and filing of nomination petitions for candidates for Senator in the General Assembly, Representative in the General Assembly, and Member of State Committee (which were set by <u>Order</u> of SCOPA on March 16, 2022) are indicated in blue.
- Dates in black represent dates that apply to all offices.







IMPORTANT NOTICE TO CANDIDATES FOR SENATOR IN THE GENERAL ASSEMBLY, REPRESENTATIVE IN THE GENERAL ASSEMBLY, AND MEMBER OF STATE COMMITTEE:

The Supreme Court of Pennsylvania <u>ordered</u> on March 16, 2022 that the Final Reapportionment Plan of the Pennsylvania Legislative Reapportionment Commission, filed on Feb. 4, 2022, has the force of law, and shall be used in all forthcoming elections to the General Assembly until the next constitutionally mandated reapportionment is approved.

The Court modified the May 17 General Primary Election Calendar for seats in the General Assembly and for state party committees. The first day to circulate and file nomination petitions will be Friday, March 18, 2022, and the last day to circulate and file nomination petitions will be Monday, March 28, 2022.

NOTICE: You may duplicate these nomination petition pages **prior to circulation** if the duplicates are **exact** copies of the originals (8 1/2 x 11" paper, 2-sided, head to head). You may complete all blank spaces at the top of Side 1 of the nomination petition page (see 1i and 1ii below) prior to duplication to eliminate clerical error.

1. Prior to Circulation

 All blank spaces which appear at the top of Side 1 of each nomination pet must be completed before signatures are obtained



ii. Check to make sure the candidate's name on the nomination petition page appears **exactly** as the candidate wants it to be displayed on the ballot. A nickname is allowed only if it is a derivative of the legal name.

2. Signers

- Different nomination petition pages must be used for signers residing in different counties.
- ii. Each signer may sign nomination petitions only for as many candidates for each office as they are permitted to vote.
- iii. Each signer of a nomination petition must be a registered and enrolled elector of the political district and of the party referred to in the nomination petition. (Democratic electors must sign Democratic nomination petitions; Republican electors must sign Republican nomination petitions.)
- iv. Each signer must personally sign his or her name in the "Signature of Elector" column and print his or her name in the "Printed Name of Elector" column. Each signer must also insert in the "Address where Registered and Enrolled" column the information concerning residence listing his or her address exactly as it appears on his or her registration affidavit. In the case of an elector having a rural route number or R.D. numbers, the township should be listed. The elector must also insert the date of signing in the "Date of Signing" column, which may be expressed in words or numbers; e.g. February 25, 2022 or 2/25/22.

3. Statement of Circulator

- i. The "Statement of Circulator" on each nomination petition page must be filled-in and signed **after** each nomination petition page is circulated. Any person who circulates this nomination petition must be a qualified registered elector of the Commonwealth and of the party referred to in the petition.
- ii. Signatures can be gathered only during the nomination petition circulation and filing period.

4. Candidate's Affidavit and Ethics Statement

- Candidates must sign and submit one CANDIDATE'S AFFIDAVIT per set of nomination petitions. The CANDIDATE'S AFFIDAVIT is generated as part of the PDF petition packet.
- ii. Candidates for the following offices must submit with their nomination petitions, a copy of the Statement of Financial Interests. The original must be filed in the office of the State Ethics Commission by the deadline to file nomination petitions.
 - * Governor
 - * Lieutenant Governor
 - * Senator in the General Assembly
 - * Representative in the General Assembly

U.S. Senate, Representative in Congress, Member of Democratic State Committee, and Member of Republican State Committee are not required to complete a Statement of Financial Interests.

5. Filing Fees

i. No nomination petition will be accepted for filing in the Office of the Secretary of the Commonwealth unless it is accompanied by the proper filing fee paid by certified check or money order payable to the Commonwealth of Pennsylvania. ii. Filing fees will not be refunded for any reason (including candidate withdrawal).

6. Filing Your Petitions

- i. Please remove all staples from the nomination petition. All nomination petition pages must be bound together when filed. Please use binder clips.
- ii. Each nomination petition page should be numbered on Side 1 and Side 2. Example: Page 1, Front Side 1/Back Side 1: Page 2, Front Side 2/Back Side 2; Page 3, Front Side 3/Back Side 3 and so on.

Nomination petitions for the offices listed below must be filed with the Bureau of Elections and Notaries, Commonwealth Keystone Building, 400 North Street, Harrisburg, PA 17120 no later than 5:00 P.M. on the last day to circulate and file nomination petitions.
