PETITION TO SET ASIDE NOMINATION PETITION

AND NOW, comes the Petitioner, Matthew Kenney, by and through his attorney, Charles A. Pascal, Jr., Esquire, and, pursuant to the Pennsylvania Election Code at **25 P.S. § 2937**, files this Petition to Set Aside Nomination Petition, and represents as follows:

1. Petitioner is Matthew Kenney, an adult individual and registered Democratic elector within the 45th Senatorial District, residing at 2929 Clermont Avenue, Pittsburgh, PA 15227 (Brentwood Borough).
2. Respondent Nickole Nesby is an adult individual residing at 513 Cochran Avenue, Duquesne, PA 15110 (City of Duquesne).
3. Respondent Nesby timely filed a nomination petition for the Democratic Nomination for Senator in the General Assembly for the 45th District, on or before February 13, 2024.

4. In order to secure a position on the ballot for State Senator as a candidate for the Democratic nomination, five hundred (500) signatures of registered Democratic electors within the 45th Senatorial District are required on the nomination petition. **25 P.S. § 2872.1(13)**

5. Respondent filed nomination petitions totaling 24 pages purporting to contain 585 signatures, attached hereto as **Exhibit A**.

6. Petitioner challenges 396 individual signature lines, not including global challenges as further detailed herein.

7. This Court has jurisdiction to hear this Petition pursuant to **42 Pa.C.S. § 764**.

I. Individual Signature Challenges

8. Petitioners aver that Nesby's nomination petition does not contain sufficient valid signatures from Democratic electors within the 45th District.

9. The page and line numbers and bases of objection to each signature individually challenged are detailed on the attached spreadsheet (**Exhibit B**).

II. Global challenges

10. In addition to the individual line challenges referenced above, the Petitioner challenges the entirety of pages 3, 4, 5, 12, 15 because the person who signed the Statement of Circulator is not a registered Democratic elector.

11. Those petition pages are also challenged because the Statement of Circulator is materially false, and the person who signed the same signed a false statement under oath.

12. In addition, the entirety of pages 4, 7, 9, 11, 14, and 16 are challenged on the basis of the Statement of Circulator being materially false. That is, these pages contain deceased electors and/or electors who Petitioner will prove did not sign the nomination petition. Therefore, the Statement of Circulator is false, and the person who signed the same signed a false statement under oath.

13. As a result of the objections detailed herein, the Respondent does not have sufficient valid signatures on her nomination petition, and her nomination petition should be set aside.

WHEREFORE, Petitioner respectfully requests that this Honorable Court find that the Nomination Petition submitted by Nickole Nesby does not contain a sufficient number of valid signatures as required by law, and strike her from the ballot.

B. LINE BY LINE CHALLENGES

19. Additionally, Petitioner objects to and contests the validity of a total of individual signature lines contained on the nomination petition; specifically, the page and line numbers and bases of objection are detailed on the attached exhibit. **(Attached hereto as Exhibit 3)**

20. As a result of the objections detailed herein, the Respondent does not have sufficient valid signatures on his nomination petition, and his nomination petition should be stricken and set aside.

WHEREFORE, Petitioner/Objector respectfully requests that this Honorable Court find that the Nomination Petitions submitted by Anton Andrew do not contain a sufficient number of valid signatures as required by law, and strike him from the ballot.

5. In order to be placed on the ballot for State Representative as a candidate for the Democratic nomination, three hundred (300) signatures of registered Democratic electors within the 160th District are required on the nomination petition. **25 P.S. § 2872.1(14)**

6. Respondent Andrew filed nomination petitions total 46 pages purporting to contain 544 signatures.

7. Petitioners object to Andrews' filing on two bases—that Andrews' nominating petitions contain an unamendable defect, and that Andrews' petition does not contain sufficient valid signatures; as such, his nominating petition should be set aside.

I. ANDREW'S NOMINATION PETITION CONTAINS AN UNAMENDABLE MATERIAL DEFECT

8. On his nomination petition, Andrew identifies his occupation as "Attorney-Educator."

9. The statement of occupation made by Andrew on his nomination petition referring to his occupation as "Attorney" is materially false, in that Andrew is not licensed to practice law.

10. The term "attorney" has a specific meaning in the law; that is, an individual licensed to practice law before the courts. Further, it is a violation of the Pennsylvania Rules of Professional Conduct for a person not so licensed to hold himself out as someone licensed to practice.

11. The false statement of occupation is a knowing and material misrepresentation by Andrew, and has the potential effect of misleading electors signing his nomination petition.
