ORDER

NOW, this 16th day of November, 2017, it appearing to this Court that
the United States District Court, Eastern District of Pennsylvania (Philadelphia),

entered an order, docketed at 2:17-CV-05137, granting an emergency motion to withdraw the notice of removal of the above-captioned action and remanding the matter to the Pennsylvania Supreme Court, it is hereby ordered that:

1. A pre-trial conference is scheduled for Friday, November 17, 2017, at 2:00 p.m., in the President Judge's Conference Room, Suite 5204 of the Pennsylvania Judicial Center, Harrisburg, Pennsylvania, for the purposes of discussing all scheduling matters not addressed in the Court's order dated November 13, 2017, and any other procedural matters which the parties wish to bring to the Court's attention.

2. The brief of Respondents Joseph B. Scarnati, President Pro Tempore of the Pennsylvania Senate, Michael Turzai, Speaker of the Pennsylvania House of Representatives, and the General Assembly of Pennsylvania, previously due on November 15, 2017, pursuant to paragraph 2 of this Court's order, dated October 16, 2017, shall be due by Friday, November 17, 2017.

3. The deadline set forth in paragraph 3 of the Court's order, dated November 13, 2017, is revised to provide that Petitioners shall file their response to the brief filed pursuant to paragraph 2 of this Court's order, dated October 16, 2017, on or before Tuesday, November 21, 2017.

4. The deadlines and scheduling of matters set forth in this Court's order, dated November 13, 2017, relating to answers to the petition for review (paragraph 6), answers to new matter (paragraph 7), and hearings on motions in limine, remaining pretrial matters, and trial (paragraph 8) remain in effect.
