2. Lorraine Haw

Lorraine Haw is a Pennsylvania voter. She will testify about her experiences as both a victim and the accused in criminal proceedings in Pennsylvania. She will testify about her plans to vote in the November 2019 election and the dilemma she would face if forced to vote on the Marsy's Law ballot question in its current form, as she supports certain rights for victims in Marsy's Law to be included in the Pennsylvania Constitution but does not support all of the rights in the Marsy's Law amendment. She will also testify about her application for a pardon of her criminal convictions from the Governor and how her application may be affected if the Pennsylvania Constitution is amended to include Marsy's Law in its proposed form.

Petitioners reserve the right to call any individual identified or called as a witness in this action by Respondent or Intervenors, including each of the persons identified in Respondent's or Intervenors' witness lists. Petitioners further reserve the right to add additional witnesses necessary to rebut testimony by witnesses or exhibits presented by Respondent or Intervenors.
