ORDER OF COURT

AND NOW, this 30<sup>th</sup> day of September, 2020, it appearing that circumstances related to the COVID-19 pandemic have not yet dissipated, and in anticipation of continued compliance with CDC and Pennsylvania Department of Health Safety Guidelines for the foreseeable future, it is hereby Ordered:

1. Supervisory Order No. 2020-SO-40 (relating to judicial emergency) is extended through April 30, 2021 with the exception that paragraph 13 of that Order (relating to prison transports) is modified to reflect that the Adams County Sheriff's Department may transport prisoners to and from the Adams County Adult Correctional Complex as specifically directed by court order on a case-by-case basis. Transports shall not occur absent a specific order of court.

2. The 2020 and 2021 Court Calendars are amended as follows:

**November 5, 2020 Juvenile Court (ACCYS)** is rescheduled to November 9, 2020 in the Human Services Building Courtroom.

**January 4, 2021 Criminal Business Court** is rescheduled to January 7, 2021 in Courtrooms No. 1 & 2 of the Adams County Courthouse.

**January 7, 2021 DUI Court/Contempts** is rescheduled to January 4, 2021 in the Human Services Building Courtroom.

**February 11, 2021 Juvenile Court (DPS)** is rescheduled to February 12, 2021 in the Human Services Building Courtroom.

**February 18, 2021 Arraignment & Sentencing Court** is rescheduled to February 19, 2021 in the Human Services Building Courtroom.

**March 15, 2021 Criminal Business Court** is rescheduled to March 18, 2021 in Courtrooms No. 1 & 2 of the Adams County Courthouse.

**March 18, 2021 DUI Court** is rescheduled to March 15, 2021 in the Human Services Building Courtroom.

**April 8, 2021 Juvenile Court (ACCYS)** is rescheduled to April 1, 2021 in the Human Services Building Courtroom.

**April 15, 2021 Juvenile Court (DPS)** is rescheduled to April 8, 2021 in the Human Services Building Courtroom.

**April 22, 2021 Juvenile Court (ACCYS)** is rescheduled to April 15, 2021 in the Human Services Building Courtroom.

Attachment A of Supervisory Order No. 2020-SO-43 (relating to criminal court scheduling) is modified as set forth hereinabove.

3. Adams County Probation Officers and Management are designated as emergency responders, and as such, are exempt from the provisions of the Emergency Family Medical Leave Expansion Act and the Emergency Paid Sick Leave Act. This paragraph does not apply to support staff for the Department of Probation Services.

4. Attachment A of Supervisory Order No. 2020-SO-43 (relating to criminal court scheduling) is amended to reflect that cases listed for Central Court on September 30, 2020 shall be listed for arraignment on November 2, 2020 rather than October 23, 2020. All other scheduling for that date set forth in Attachment A shall remain in full force and effect.
