APPLICATION FOR RELIEF

COME NOW Petitioners, Friends of Danny DeVito, Kathy Gregory, B&J LAUNDRY, LLC, Blueberry Hill Public Golf Course & Lounge, and Caledonia Land Company, by and through their attorneys, Scaringi Law, pursuant to Rule 123 of the Pennsylvania Rules of Appellate Procedure, and respectfully represent:

1. On March 24, 2020, Petitioners filed their Emergency Application for Extraordinary Relief, challenging Governor Tom Wolf’s order barring most businesses in Pennsylvania from accessing their physical locations.

2. Also on March 24, 2020, the Prothonotary addressed a letter to counsel for the Governor and Secretary of Health, advising that an Answer is due by Thursday, March 26, 2020 at 4:00 p.m.

3. This Court's disposition of Petitioner's Emergency Application will have profound, far-reaching consequences for millions of the Commonwealth's citizens and for the economy of the Commonwealth, including businesses across Pennsylvania, large and small.

4. Petitioners submit that in these circumstances, it would be appropriate for the Court to permit briefing and argument of the momentous issues before the Court.

5. Undersigned counsel have requested concurrence of the Respondents in the instant Application. Respondents have declined to concur in the Application.

WHEREFORE, Petitioners respectfully request that the Court order an expedited schedule for briefing and oral argument in the instant matter.
