**PETITION TO SET ASIDE NOMINATION PETITION**

Petitioners Thomas R. Slavicek and Thomas M. Hrynda, by and through their attorney, Charles A. Pascal, Jr., Esquire, and, pursuant to **25 P.S. §2937**, files this Petition to Set Aside the Nomination Petition of Tony Moreno, and represents as follows:

**JURISDICTION**

1. Exclusive jurisdiction over the subject matter of this petition is vested in the Commonwealth Court of Pennsylvania pursuant to the Pennsylvania Election Code at **25 P.S. §2937**, and the Pennsylvania Judicial Code at **42 Pa.C.S.A. § 764**.

**PARTIES**

2. Petitioner/Objector Thomas R. Slavicek, an adult individual and registered Republican elector within the 20<sup>th</sup> Legislative District and the Borough of Bellevue, residing at 67 S. Bryant Avenue, Pittsburgh (Bellevue), Pennsylvania 15202.

3. Petitioner/Objector Thomas M. Hrynda is an adult individual and registered Republican elector within the 20<sup>th</sup> Legislative District and the Borough of Bellevue, residing at 523 Roosevelt Avenue, Pittsburgh (Bellevue), Pennsylvania 15202.

4. Respondent Tony Moreno is an adult individual residing at 3932 McClure Avenue, Pittsburgh, Pennsylvania 15212.

### **BACKGROUND**

5. Respondent Moreno timely filed a nomination petition as a candidate for the Republican Nomination for Representative in the General Assembly for the 20<sup>th</sup> District, consisting of a total of 34 pages purporting to contain 419 signatures (counting the last completed line on each page). **(Attached hereto as Exhibit A)**

6. In order to be placed on the ballot for State Representative as a candidate for the Republican nomination, three hundred (300) signatures of registered Republican electors within the 20<sup>th</sup> District are required on the nomination petition. **25 P.S. § 2872.1(14)**

### **COUNT I – GLOBAL PAGE CHALLENGES** **FALSE CIRCULATOR STATEMENTS**

7. The Petitioner avers that pages 1, 4, 11, 23, 26, 28, 29 and 31 of Moreno's nomination petition are invalid in that that the person who signed the "Statement of Circulator" was not the person who actually circulated that page of the petition, and these pages are challenge on that basis.

8. For the aforesaid reason, the circulators' statements on these pages are false, and, thus the aforementioned pages in their entirety, consisting of a total of 131 signatures, should be stricken, as follows:

Page 1 – 30 signatures  
Page 4 – 30 signatures  
Page 11 – 30 signatures  
Page 23 – 10 signatures  
Page 26 – 8 signatures  
Page 28 – 7 signatures  
Page 29 – 8 signatures  
Page 31 – 8 signatures

9. Should the Court strike the 131 signatures on this basis, Respondent would not have sufficient signatures, and his nomination petition should be stricken.

**COUNT II—LINE BY LINE CHALLENGES**

10. Additionally, Petitioner objects to and contests the validity of a total of 209 signature lines contained on the nomination petition (inclusive of the global challenges above); specifically, the page and line numbers and bases of objection are detailed on the attached exhibit. **(Attached hereto as Exhibit B)**

11. As a result of the objections detailed herein, the Respondent does not have sufficient valid signatures on his nomination petition, and his nomination petition should be stricken and set aside.

WHEREFORE, Petitioner/Objector respectfully requests that this Honorable Court find that the Nomination Petition submitted by Tony Moreno does not contain a sufficient number of valid signatures as required by law, and strike him from the ballot.


