**PETITION TO SET ASIDE NOMINATING PETITIONS
FOR THE POSITION OF DEMOCRATIC STATE COMMITTEE MEMBER**

AND NOW, COMES PETITIONER JACQUE WHAUMBUSH, A DULY QUALIFIED ELECTOR OF PHILADELPHIA COUNTY SEEKING TO SET ASIDE THE NOMINATING PETITIONS OF DAVID RODRIGUEZ.

1. EXCLUSIVE JURISDICTION OVER THE SUBJECT MATTER OF THIS PETITION IS VESTED IN THE COMMONWEALTH COURT OF PENNSYLVANIA BY THE PROVISIONS OF THE PENNSYLVANIA ELECETION CODE, 25P.S. 2937 AND THE PROVISIONS OF THE JUDICIAL CODE, 42 PA C.C.A. 764
2. PETITIONER JACQUE WHAUMBUSH RESIDES AT 967 CLYDE LANE PHILADELPHIA PA. 19128 IS DULY REGISTERED AND IS AN ENROLLED DEMOCRATIC ELECTOR OF THE COMMONEALTH OF PENNSYLVANIA.
3. RESPONDENT DAVID RODRIGUEZ, RESIDES AT 4544 PALETHORP STREET PHILADELPHIA PA IS A DULY REGISTERED AND ENROLLED DEMOCRATIC ELECTOR OF THE COMMONWEALTH OF PENNSYLVANIA.
4. ON OR ABOUT MARCH 28, 2022 NOMINATING PETITIONS WERE FILED WITH THE PENNSYLVANIA DEPARTMENT OF STATE, NOMINATING RESPONDENT DAVID RODRIGUEZAS A CANDIDATE OF PHILADEPHIA AS A CANDIDATE FOR THE DEMOCRATIC STATE COMMITTEE.
5. THE NOMINATING PETITIONS CONSIST OF 5 PAGES AND CONTAINED 119 SIGNATURES
6. THE NOMINATING PETITIONS ARE INVALID AND DEFECTIVE IN THAT THEY CONTAIN LESS THAN THE 100 VALID SIGNATURES REQUIRED FOR THIS NAME TO APPEAR ON THE BALLOT FOR THE POSITION STATE OF COMMITTEE.
7. THE NOMINATING PETITIONS CONTAIN A MULTITUDE OF DEFICIENCIES.
8. EXHIBIT A. ATTACHED HERETO, OUTLINES THE 55 CHALLENGES TO THE NOMINATING PETITIONS OF DAVID RODRIGUEZ.

WHEREFORE, PETITIONER JACQUE WHAUMBUSH RESPECTFULLY REQUEST THIS HONORABLE COURT TO SET ASIDE THE NOMINATING PETITIONS OF KYLE HANAHAN FOR FAILURE TO SUBMIT THE LEGAL REQUIRED NUMBER OF VALID QUALIFIED SIGNATURES OF ELECTORS.
