ELECTION MATTER

PETITION TO WITHDRAW CANDIDACY

Petitioner, Penelope J. Murphy, hereby petitions this Honorable Court to withdraw her candidacy for the Republican nomination for Representative in the General Assembly from the 107th Legislative District in the Republican Primary of May 17, 2022.

In support of this Petition, the following is averred:

- 1) Petitioner is the candidate, Penelope J. Murphy, an adult individual residing at 205 Johns Estate Road, Coal Township, PA 17866.
- 2) This Petition is brought pursuant to the Pennsylvania Election Code, at 25 P.S. § 2938.4.
- 3) This Court has original jurisdiction of this matter pursuant to 42 Pa. C.S. § 764.

- 4) On or about March 28, 2022, Petitioner filed a Nomination Petition and related documents to file as a candidate for the Republican nomination for Representative in the General Assembly from the 107th Legislative District in the Republican Primary of May 17, 2022.
- 5) Due to an objection filed in this Court concerning Petitioner's Nomination Petition, Petitioner now desires to withdraw her candidacy.
- 6) The Pennsylvania Election Code provides that "[u]pon petition to . . . the Commonwealth Court . . . by a candidate for nomination . . . , the court shall order the withdrawal of said candidate's name for nomination or election, except upon a showing of special circumstances." 25 Pa. Stat. Ann. § 2938.4
- 7) No special circumstances exist in the present case that would warrant the denial of this Petition.

WHEREFORE, Petitioner respectfully request that this Court grant her Petition to Withdraw Candidacy and enter an Order directing the Secretary of the Commonwealth to remove the name of Penelope J. Murphy as a candidate for the Republican nomination for the office of Representative in the General Assembly from the 107th Legislative District in the Republican Primary of May 17, 2022.
