PRE-TRIAL STATEMENT PURSUANT TO COURT OF JUDICIAL DISCIPLINE

The Respondent, Michael J. Cabry, III, by his counsel, Samuel C. Stretton, Esquire, respectfully submits the following information as part of his Pre-Trial Memorandum:

- 1) Names and addresses of all witnesses expected to testify at trial and the subject of the testimony of each witness:
  - a) Michael J. Cabry, III. He is the Respondent. His address is 1469 Hall Road, West Chester, Pennsylvania 19380. He would testify as to the circumstances and mitigation. He would further explain that during the pertinent times, his wife was dying of cancer. He was actually doing the treasury work for the campaign. He would explain how he did not properly maintain records and there was a fire in his house where some of the records were destroyed or lost in the cleanup. He would explain how his wife's death from cancer and long illness consumed him and also caused him to have severe depression. He would apologize for his criminal convictions and accept

responsibility. He would explain the gambling situation and how it was done infrequently for two or three hours each week to have a break from caring for his wife.

b) Mike Oleski, MA. His phone number is 717-859-8000. He is the treating therapist for Former Judge Cabry and has been seeing him for at least the last two years. His report is attached to this Pre-Trial Memorandum as Exhibit "A".

c) Reverend Matthew Guckin, Pastor of Our Lady of Mount Carmel Church. Attached is his July 12<sup>th</sup>, 2021 letter as Exhibit "B".

d) Former Detective Lieutenant, William Cahill. Detective Cahill is a close friend and his letter of June 25<sup>th</sup>, 2021 is attached as Exhibit "C".

e) Former Chester County Commissioner, Terrance Farrell. His letter of July 8<sup>th</sup>, 2021 is attached as Exhibit "D".

f) Chief Curt A. Martinez, Police Chief of West Caln Township Police Department. His letter of July 14<sup>th</sup>, 2021 is attached as Exhibit "E".

l) Attorney Dawson Muth, was the attorney for Former Judge Cabry in the related criminal case. He has known Former Judge Cabry for many years. He would testify what an excellent judge he was and as to his excellent character and the great difficulty he had during the time of his wife's illness. He will testify that Former Judge Cabry came to him to amend his campaign report before he was aware of any criminal investigation.

m) Attorney James McElree, with the phone number of 610-701-4404. He will be a character witness and confirm Former Judge Cabry sought advice to amend his campaign report before he was aware of any investigation.

n) Michael Matta, Head Football Coach for Downingtown East, with an address of 120 Glenside Drive, Exton, Pennsylvania 19341, will testify as a character witness.

o) John Sly, Chief of West Wood Fire and Ambulance and a friend of Former Judge Cabry, with an address of 140 LaRose Drive, Coatesville, Pennsylvania 19320, will testify as a character witness.



The second issue would be as to the nature of the sanction. Former Judge Cabry has resigned and retired from his position. He has agreed never to seek judicial office again. He is respectfully requesting that the sanction not be that of removal.





Dear Mr. Stretton:

I am writing this letter to you at the request of our mutual client, Michael Cabry. Mr. Cabry was referred to this organization for a level of care assessment through Judges Concerned for Judges on October 13, 2020. At that time, Mr. Cabry's clinical presentation was consistent with the diagnosis of Major Depressive Disorder, Single Episode- Sever (F32.2-ICD-10). Mr. Cabry exhibited severely depressed mood, anhedonia, social isolation, extremely poor concentration, significantly low energy and passive suicidal ideation. Mr. Cabry's ability to attend to activities of daily living had decompensated as well. Weekly outpatient psychotherapy sessions were recommended.

The onset of Mr. Cabry's symptoms appeared to be precipitated by a number of significant and long-term, life-changing stressors which occurred within a relatively short time of one another. Precipitants to Mr. Cabry's condition included his wife's 6-year battle with cancer resulting in her death in March, 2020; a house fire in September 2017 requiring that he and his wife live in a hotel for several months during her illness until their home was restored; and an ongoing investigation into the potential misuse of campaign funds in 2017-2018 which resulted in formal legal charges and the end of his career in September 2020.

Mr. Cabry has been following up with me consistently since that time. Our sessions have primarily focused on helping Mr. Cabry cope with the day to day challenges associated with his ongoing legal matters. Mr. Cabry's has attended our sessions consistently, and his participation in the treatment process has been very good. While Mr. Cabry has demonstrated relative progress overall, he continues to experience episodes of emotional decompensation which includes anxiety, panic, and depression while also experiencing as sense of being overwhelmed.

While Mr. Cabry has shown some improvement, Mr. Cabry faces a number of ambiguities, adjustments and challenges well into the future. I anticipate that Mr. Cabry will benefit from ongoing mental health services going forward into his future



My name is Bill Cahill, and I am a retired Detective/Lieutenant from the Westtown-East Goshen Regional Police Department in Chester County. Over my 34 years of service, I was continually active with the District Attorney's Municipal Drug Task Force and my last four years I was assigned to the Federal Bureau of Investigation as a Task Force Officer on the Violent Crime Task Force. I have known Judge Cabry for more than 20 years and soon after first meeting him we became close friends.

As long as I have known Judge Cabry he has devoted countless hours in the evening and weekends coaching high school football players. Judge Cabry also found time outside of coaching football to volunteer in his community on various projects and events both in Honey Brook and West Brandywine Township where he lives.

A few years ago, the Valor Bowl was held at the local high school in Westtown Township. Judge Cabry asked if Police Officers from my agency would volunteer to assist with traffic control and security for this important event. The annual Valor Bowl is an event where All-Star football players team up with local Special Olympics Athletes. I was honored to be invited to the sideline next to Judge Cabry to watch him in action with players and other coaches. It was so impressive to see the passion that Judge Cabry has with the students and Special Olympic athletes.

Judge Cabry is one of the most respected Judges in Chester County because of his professionalism and passion for his job. For law enforcement, Judge Cabry has always made himself available for law enforcement after hours even when he was not the on-call Judge for Chester County. I recall occasions when I would drive to his home for him to review and sign search warrants for time sensitive investigations.



I'm writing a character reference letter in support of Judge Michael Cabry III.

I have known "Mike" for more than 20 years, as we came up together in the political pipeline of one of the political parties in Chester County. I knew Mike when we were both starting out our political careers. I

Now he is a Judge, and I am a former three-term Chester County Commissioner, having finished my service in January 2020. (Before that I served two terms as the Recorder of Deeds.)

Having seen Mike up close and personal in many different situations, both professionally and personally, I can assert without reservation that he is a good person – a man of faith, a loving husband and father, an honest man who perhaps made a mistake, but a fundamentally decent person who cares for his family, was dedicated to doing a good job as Judge, and was invested in supporting the community in a number of ways.

I knew Judge Cabry when both his parents were still alive, and he was a great son to them, supportive and loving. He doted on his own son, never missing any of his (only) son's sporting events when he was growing up, even the away games. And he made sure to talk with his son EVERY day, in person or by phone. He was a loving and supportive husband to wife Donna, his college sweetheart. Of particular note, was how he supported her over the past several years, after she was diagnosed with cancer, went through numerous treatments, and ultimately died from the disease in March of 2020. Through his love, he basically willed her to live past the "expiration date" pronounced by her doctors. In all, they shared 34 years of marriage!

Mike took his role as Judge seriously. His court was notoriously well run, with good audits every year. He was well respected among law enforcement, and, as you know, he was elected by his peers to be President of the state-wide organization of Magisterial District Judges. At his invitation, I was privileged to speak at and bring a proclamation from the County at his installation. At the County level, he was the MDJ's liaison to the County's Prison Board, and he was the first and only MDJ to regularly come to those meetings.



He was involved in and gave back to the community in many ways, from being Chairman of the Caln Little League to his annual swearing in of new members and officers of the Honey Brook Fire company. I was privileged to attend one of those dinners (in 2019) and saw just how appreciative the entire fire company was that he took the time to attend, swear them in, personally thank them, and give each member a certificate of appreciation.

The final point I would like to convey is a story about his compassion for his fellow human beings. A couple of years back, when a longtime member of the Honey Brook Fire Company – who was the founding member of the Martin's Corner Fire Company – was terminal with cancer, Mike called me to arrange a proclamation from the County, recognizing this firefighter's longtime service. The Honey Brook Fire Company Chief, Judge Cabry, myself and a group of firefighters went to this firefighter's home, and surprised him with the presentation of the proclamation, and personally thanked him for his long service. We took pictures for a news article and posts. He was thrilled! Mike went out of his way to make this special day happen.

Your honor, as you can tell, I love Mike as a friend. I took the time to write this character reference letter because I believe he is a good and decent person. As you perhaps know better than most, we all make mistakes. I also believe we are all capable of redemption and worthy of understanding and forgiveness.



I have known Mike Cabry for over twenty years. Mike is a close friend to my husband, Mark, and myself. Mike was the judge that married us on our very special day. I know he is one of the few judges who are able to perform marriages in Chester County with all the new laws.

We suddenly lost my oldest step-son in 2014, and Mike was a true rock for all of my family especially for my husband during this awful time in our lives even with Donna's, Mike's wife, recent breast cancer diagnosis.

Being an oncology nurse for years, I know first-hand, how physically, emotionally, and mentally draining it is to be the primary caregiver. I witnessed what a great caregiver Mike was to Donna. He went with her to the doctor's appointments, the treatments, and the testing. He was her nurse at home after bilateral mastectomy surgery; which is extremely challenging on women physically and physiologically. Being an oncology nurse, for years I saw what great care Donna was getting from Mike. When Donna was put on hospice and after she passed, the outpouring for friends, family, and neighbors was astonishing. 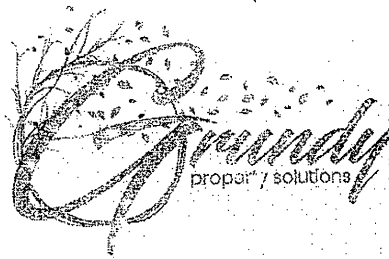

My name is Albert J Grundy, and I am writing to you today to discuss a dear colleague and friend, The Honorable Michael J Cabry, III. I reside in Morgantown, Pennsylvania with my wife and three sons. I am currently a real estate investor, however previously I have worked for the last eighteen years with adjudicated minors as a behavioral specialist for Delaware County Juvenile Detention Center, Chester County Intermediate Unit, and most recently for Abraxas Academy. It is with great privilege that I demonstrate to you my experience and relationship with Michael Cabry.

Eleven years ago, I met Michael coaching alongside him for the Downingtown East High School Football team. During our time coaching together I witnessed Michael's dedication and passion for the young players. He poured his heart and soul into them, giving back as best he could, and demonstrating to them how to be a strong leader and positive contributor to society. While I am no longer coaching for Downingtown, over the years Michael and I have remained in consistent contact. During his re-election campaign in 2017 Michael and his wife Donna experienced a devastating tragedy as their family home caught fire. This fire forced them to live in a hotel for several months. Simultaneously, Donna and Michael were given the dreadful news that Donna's cancer had returned. I can clearly remember the distress that Michael was in as he attempted to juggle so many intense things. Three short years later, Donna was gone. I was there for every phone call, text, and occasional lunch as he expressed his despair during those difficult years. In all the days of my knowing Michael, this was the worst I had seen him, and I was worried for him and his well-being. As a man who looks up to him, admires him, and deeply respects him, watching him be so broken was overwhelming. In time, he began to regain his light and zest for life, along with his passion for his community, beloved traits that were familiar to me and those close to him. It was a relief that words alone cannot express as I value him so very much.

Michael has always been an incredibly positive man and a devoted and committed community member. He has always shown his graciousness to my wife and I through the years. He has been a loyal friend and an important guidepost for me and the challenges I have faced in my own life. One thing that I have





We would like to convey to you in this letter, our support for Michael Cabry and provide a letter of reference for him as you consider his character in your legal proceedings.

I (Ron) first met Mike at the Coatesville Rotary Club 30 years ago. We became friends as we went to weekly meetings and volunteered in the community together. What attracted me to Mike was his passion for always trying to help the community. We did things like serving food together at the Rotary tent during the local Strawberry Festival and picked up trash along the roadways. His compassion for people was visible as we helped raise money and food for the less fortunate in the City of Coatesville.

Mike was also a coach and the President of our local Little League where my son and daughter, as well as Mike's son played ball. Mike was known to be friendly, fair and honest as Caln Little League's leader. Another area of community service where I encountered Mike was serving in our political process. Mike ran my campaign when I was elected to the schoolboard and we helped get good candidates elected to office from Supervisors to Common Pleas Judges. We shared a passion for finding the best candidates for office and helping them get elected. One more place I would see Mike was helping our township. We attended monthly West Brandywine Township meetings and both served on Boards and Commissions.

During these years together our wives became friends as well. We spent time at the Cabry's home and they visited our home as well. Mike and Donna, and Toni and I went to parades and picnics and became very good friends.

As Mike served on the bench for 21 years, he gained a reputation as a fair, very well respected judge. He was no longer allowed to participate in political events, but stayed active in the community by involvement in his church, in our township, and by leading the statewide District Judges as the President of the Pennsylvania Special Court Judges.

It was with great alarm and sadness that we learned that Donna became ill with cancer. We became even closer as we lent support to Mike, Donna and Michael during this 6 year battle which she ultimately lost. Mike was beside himself with pain and empathy for her and ran



himself ragged working, keeping his personal community commitments and giving Donna the very best care while trying everything to comfort her and look for treatment and cures. We saw this first hand as we brought food to them and helped with house maintenance.


As if this weren't enough the Cabry's experienced a fire at home which displaced them into a hotel for 10 weeks. This added to the stress and confusion to their daily life and during this time Mike did not keep his finances and election reporting up to speed. I know this because Mike personally expressed to me later his deep remorse, embarrassment and regret at not keeping his records in order at that time, which led to this trouble down the road. Mike buried Donna last March as the pandemic hit the world.

I also would like you to know the deep shame, regret and remorse Mike has for his temporary lapse in judgement that has brought embarrassment to him and his family. Mike came over to our house last summer and said he had some troubling news to share with Toni and me. He was at our house for 9 hours before he could summon the courage to tell us about his legal trouble. I just want you to understand how ashamed he is that his stellar career and reputation as an honest judge with the utmost integrity would be negatively impacted by this. He was the most concerned what this would do to his son, a police officer...and his niece who had helped him on his campaign. He had said to me at one point that he would rather plead guilty than to make his niece testify in court or have his son be embarrassed at work if this were to drag out in the papers.

My plea to you, Your Honor, is that you consider what a solid member of the community Mike has been as well as a very well respected judge locally and statewide for over 30 years before this oversight turned his and his family's world upside down. I know that he regrets it every day and would do anything to have done things differently.

**COMPLAINT**

AND NOW, this 9<sup>th</sup> day of December, 2021, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board) and files this Board Complaint against former Magisterial District Judge Michael J. Cabry, III, Magisterial District Court 15-3-06, Chester County, Pennsylvania, alleging that former Judge Cabry has violated the Constitution of the Commonwealth of Pennsylvania and the Rules Governing Standards of Conduct of Magisterial District Judges, as more specifically delineated herein.

**FACTUAL ALLEGATIONS**

1. Article V, § 18 of the Constitution of the Commonwealth of Pennsylvania grants to the Board the authority to determine whether probable cause exists to file formal charges against a judicial officer in this Court, and thereafter, to prosecute the case in support of such charges in this Court.
2. From approximately March 22, 2000, until his resignation on September 21, 2021, former Judge Cabry served continuously as the duly elected Magisterial District Judge of Magisterial District Court 15-3-06, Chester County.

3. Pursuant to Article V, § 18(a)(7) of the Constitution of the Commonwealth of Pennsylvania, the Board determined that probable cause exists to file formal charges against former Judge Cabry in this Court.
4. By criminal complaint filed October 6, 2020, at ***Commonwealth v. Michael J. Cabry, III***, MJ-15203-CR-181-2020, the Pennsylvania Office of Attorney General (OAG) filed criminal charges against former Judge Cabry stemming from Presentment No. 13 of the 45<sup>th</sup> Statewide Investigating Grand Jury.
5. The OAG charged former Judge Cabry with the following offenses: (1) theft by unlawful taking, 18 Pa.C.S.A. § 3921(a), a felony of the third degree; (2) perjury, 25 P.S. § 3249(b), a misdemeanor of the first degree; (3) reporting by candidate and political committee, 25 P.S. § 3246(a), an ungraded misdemeanor; (4) reporting by candidate and political committee, 25 P.S. § 3246(b)(2), an ungraded misdemeanor; (5) reporting by candidate and political committee, 25 P.S. § 3246(b)(4), an ungraded misdemeanor; and (6) lawful election expenditures, 25 P.S. § 3254.1(a)(3), an ungraded misdemeanor.
6. Former Judge Cabry waived his right to a preliminary hearing and the aforementioned charges were bound over for trial in the Court of Common Pleas.
7. On September 22, 2021, at ***Commonwealth v. Michael J. Cabry, III***, CP-15-CR-3380-2020, former Judge Cabry pleaded guilty to the following offenses: (1) theft by unlawful taking, 18 Pa.C.S.A. § 3921(a), a misdemeanor of the second degree; (2) reporting by candidate and political committees, 25 P.S. § 3246(a), an ungraded misdemeanor; (3) report must list each expenditure and person, 25 P.S. 3246(B)(4), an ungraded misdemeanor; and (4) lawful election expenses, 25 P.S. § 3254.1, an ungraded misdemeanor.

8. In his written guilty plea colloquy, executed September 22, 2021, former Judge Cabry admitted the following:

*On or about November 13, 2016[,] through January 31, 2018, the defendant, while a candidate for public office, failed to file appropriate and accurate campaign reports of expenditures and receipts; failed to provide full and accurate account of expenditures and withdrew funds from his campaign account for purposes unrelated to his campaign. Additionally, the defendant unlawfully took funds from the campaign account and used the funds for personal expenses unrelated to political activity.*

9. As a result of his guilty plea, the Honorable Stephen B. Liberman sentenced former Judge Cabry on September 22, 2021, to an aggregate sentence of one year of probation.
10. Former Judge Cabry has not appealed his judgment of sentence, and, consequently, it is final and factually binding for purposes of proceedings within this Honorable Court.

### **CHARGES**

#### **Count 1 – Violation of Canon 1, Rule 1.1**

11. By virtue of some or all of the conduct alleged in paragraphs 1 through 9, former Judge Cabry violated Canon 1, Rule 1.1 of the Rules Governing Standards of Conduct of Magisterial District Judges.
12. Canon 1, Rule 1.1 states the following:

Canon 1, Rule 1.1. Compliance with the Law.

A judge shall comply with the law, including the Rules Governing Standards of Conduct of Magisterial District Judges.
13. The definition of “Law” in the “Terminology” section of the Rules Governing Standards of Conduct of Magisterial District Judges includes, *inter alia*, statutes,



decisional law, and Supreme Court Rules and directives, including the Rules themselves.

14. By virtue of his conviction for the aforementioned criminal acts, which took place during his term of judicial office, former Judge Cabry violated Canon 1, Rule 1.1.

**Count 2 – Violation of Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania**

15. By virtue of some or all of the conduct set forth above, former Judge Cabry violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.
16. Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania states, in pertinent part, the following:

Article V, § 17(b) [Derivative Violation]

[Magisterial District Judges] shall be governed by rules or canons which shall be prescribed by the Supreme Court.

17. A violation of the Rules Governing Standards of Conduct of Magisterial District Judges constitutes an automatic, derivative violation of Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.
18. By virtue of some or all of the conduct set forth above, former Judge Cabry violated Canon 1, Rule 1.1, of the Rules Governing Standards of Conduct of Magisterial District Judges.
19. By violation of Canon 1, Rule 1.1, former Judge Cabry violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.

**Count 3 - Violation of Article V, § 18(d)(1) of the Constitution of the  
Commonwealth of Pennsylvania**

20. By virtue of some or all of the conduct set forth above, former Judge Cabry violated Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.

21. Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania states the following:

Article V, § 18(d)(1) [Disrepute]

A justice, judge or justice of the peace may be suspended, removed from office or otherwise disciplined for . . . conduct which . . . brings the judicial office into disrepute, whether or not the conduct occurred while acting in a judicial capacity[.]

22. By his conduct as described in paragraphs 1 through 9 above, former Judge Cabry engaged in conduct that was so extreme that it brought the judicial office itself into disrepute and thereby constitutes a violation of the Disrepute Clause of Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.



ANSWER AND NEW MATTER OF THE RESPONDENT, MICHAEL J. CABRY, III

The Respondent, Michael J. Cabry, III, by his counsel, Samuel C. Stretton, Esquire, hereby answers the complaint and respectfully requests a hearing for the reasons set forth below:

FACTUAL ALLEGATIONS

- 1) Admitted that the Judicial Conduct Board has the authority to file formal charges against former judicial officers in Pennsylvania.
- 2) Admitted that the Respondent, Michael J. Cabry, III, was an elected District Judge from March 22<sup>nd</sup>, 2000 until his resignation and retirement on September 21<sup>st</sup>, 2021. He served as the elected District Judge in Magisterial District Court 15-3-06.
- 3) Admitted that the Judicial Conduct Board apparently took a vote and decided there was probable cause. Neither Mr. Stretton nor Mr. Cabry were allowed to be present at that time.
- 4) Admitted that criminal charges were filed against former Judge Cabry as a result of an investigation by a state-

wide grand jury. Many of these charges were factually incorrect. For instance, the original presentments stated former Judge Cabry did not file certain campaign reports. That was just completely false. The day former Judge Cabry came to attorney Stretton, Mr. Stretton went over to Voter Services and pulled the reports that had been properly and timely filed when the Attorney General's Office said they hadn't been.

5) Admitted that the charges listed were filed against former Judge Cabry. Former Judge Cabry denied many of those charges and many of them, including all felonies, were withdrawn.

6) Admitted former Judge Cabry waived his preliminary hearing. Former Judge Cabry and his criminal attorney cooperated with the Attorney General's Office.

7) Admitted that on September 22<sup>nd</sup>, 2021, former Judge Cabry entered pleas to four misdemeanors as set forth.

8) Admitted that former Judge Cabry, as part of the written plea agreement, provided the statements set forth.

9) Admitted that on the same day as the guilty plea, Judge Liberman, a visiting Senior Judge from Berks Counts, sentenced Mr. Cabry to a total sentence of one year of probation. No fine or restitution was added.

10) Former Judge Cabry has not appealed the judgement of sentence. Further, whether it is factually binding for the



purposes of proceedings with the Court of Judicial Discipline is a legal issue to which no answer is required, but it is denied.

CHARGES

COUNT ONE - VIOLATION OF RULE 1.1

11) Former Judge Cabry agrees to violating Rule 1.1 based on the charges to which he pled guilty to, all of which were misdemeanors.

12) Admitted that Rule 1.1 has been quoted properly by the Judicial Conduct Board.

13) Admitted the definition section has been quoted properly by the Judicial Conduct Board.

14) Admitted that former Judge Cabry admitted to improperly handling some campaign funds. During this time, former Judge Cabry's wife was dying of cancer. He was running his campaign and doing the work his Treasurer should have been doing. Many of his campaign records were missing after a fire in his kitchen, which resulted in the house having to have extensive repair and many campaign documents were missing as a result or documents being removed, etc. Thus, he was not able to provide the supporting documentation. During this time period, he was gambling about once a week, this was the only time he left his house except for his judicial duties, and as an assistant coach on the football team for Downingtown East. The gambling was a release because of the stress of taking care of

his wife who was severely ill and ultimately died of cancer. Former Judge Cabry allowed his fiend, Frank, to use his casino card. Most of the time seen on casino logs was Frank's use. During the football season former Judge Cabry was at the games every Friday night and not at the casino.

**COUNT TWO - VIOLATION OF ARTICLE V, SECTION 17(b)**

15) Admitted that because former Judge Cabry violated Rule 1.1 of the Code of District Judges, he would have violated Article V Section 17(b).

16) Admitted that Article V Section 17(b) of the Pennsylvania Constitution is quoted correctly.

17) Admitted that a violation of the Code of Conduct for District Judges would be a derivative of violation of Article V Section 17(b).

18) Admitted that by violating some portions of Rule 1.1, former Judge Cabry violated Pennsylvania Constitution Article V Section 17(b).

19) Admitted that by violating some portions of Rule 1.1, former Judge Cabry violated Pennsylvania Constitution Article V Section 17(b).

**COUNT THREE -VIOLATION OF ARTICLE V, SECTION 18(d) (1) -**

**DISREPUTE**

20) Denied. It is emphatically denied that former Judge Cabry is in disrepute and violated this provision of the Pennsylvania Constitution.

21) Admitted that Article V Section 18(d)(1) is properly quoted.

22) Denied that former Judge Cabry involved or engaged in conduct so extreme that it brought the Judicial Office in disrepute. Denied this conduct violated the disrepute provision of the Pennsylvania Constitution Article V Section 18(d)(1). On the contrary, the misconduct to which he pled guilty to had nothing to do with his judicial duties. He served with distinction as a judge for 20 some years in Chester County. He was a former President of the Chester County District Justice Association and former President of the Special Court Judges Association of Pennsylvania. All who appeared before former Judge Cabry have high praise of him for his good judgement, excellent demeanor, and timely resolution of matters. He ran his courtroom with fairness and decorum for everyone who had the opportunity to properly present their case. His misconduct occurred during a very difficult time in his life. He and his wife were extremely close and she got a terminal diagnosis for cancer. She slowly died before his eyes during the time of his campaign. Further, his campaign treasurer did not fulfill the

campaign responsibilities, therefore it was Mr. Cabry's responsibility to do all the campaign work.

Further, many of his campaign receipts were lost as noted above, after a fire in his kitchen in September of the year of his election. The documents were lost during the home repair. In this time period, former Judge Cabry, usually went out for an hour or two to gamble once every week or two weeks. That was his way to relieve stress. Sometimes he would make mistakes of withdrawing funds, pay for meals or other matters that were related to campaign expenses while he was at the gambling establishments using their ATM machines. He did not maintain proper records as he should have. Many of the expenditures were legitimate and some were not. His plea was to misdemeanors and he was not required to make any restitution and was not fined. His criminal conviction was the result of sloppy campaign reports during a time of great personal stress. The Respondent had retained attorney Dawson Muth to assist on filing amended returns after his wife's death since he was trying to get his life back together. Unfortunately, he was charged before the changes.

WHEREFORE, the Respondent, Michael J. Cabry, III, by his counsel, Samuel C. Stretton, Esquire, respectfully requests this Honorable Court have a hearing on the issue of disrepute and also have a hearing on the nature of the appropriate sanction.

Former Judge Cabry has retired from his judicial position as of September 21<sup>st</sup>, 2021.

NEW MATTER

The Respondent, Michael J. Cabry, III, hereby raises the following as new matter in the captioned matter.

23) Answers to 1 through 22 are incorporated by reference into this new matter.

24) During all pertinent times former Judge Cabry raises the mitigation that he was operating under extreme mental and emotional distress since he was the primary caretaker of his wife of many years and she was dying before his very eyes of cancer, finally passing away on March 16<sup>th</sup>, 2020. Her cancer began in 2014 and continued during the time of the judicial campaign which was December 2016 to January 2018. The Respondent and his wife, due to the fire, lived in a hotel for 10 weeks from mid-September of 2017 until mid-December of 2017.

25) Former Judge Cabry during that time suffered from severe emotional and mental stress and will present testimony on that. He was greatly suffering because of the illness of his wife and the closeness in their relationship. Also, by way of mitigation, he was handling the treasurer's job for his campaign committee for reelection himself. That was a foolish thing by him and he did not necessarily keep all records. Many of the records that were kept were lost after the fire in his kitchen

and during the removal of the documents. The fire occurred in September of 2017.

26) The misconduct occurred approximately in the year of 2017, over four years ago. There has been no misconduct since. In those years former Judge Cabry had performed his judicial duties in an excellent fashion without complaint until his interim suspension and retirement.

27) The violations of the campaign statute, much of the allegations involved sloppy campaign reporting and sloppy maintaining campaign records. Obviously, that is unacceptable but these allegations and charges have to be put into proper perspective.

28) Former Judge Cabry has been seeing a therapist through Judges Concerned for Judges. At the hearing, testimony will be presented on that issue. Further, a number of character witnesses will be presented on the issue of nature of discipline.


29) Former Judge Cabry raises mitigation that he resigned from his judicial office as of September 21<sup>st</sup>, 2021 and is now retired from any judicial duties. He has agreed never to serve again as a Magisterial District Judge.

30) Former Judge Cabry specifically raises the defense that he did not violate the constitutional section on disrepute. This was not a matter of universal disrepute. What happened here

involved a very personal matter, involving former Judge Cabry facing an extremely difficult time in his life when his wife was dying of cancer, and records were not properly maintained. That is hardly something that should be considered a basis for subject of judicial disrepute.

WHEREFORE, the Respondent, Michael J. Cabry, III, by his counsel, Samuel C. Stretton, Esquire, respectfully requests this Honorable Court provide a hearing on the issue of disrepute and then a hearing on the issue of nature of discipline.






