### PETITION TO SET ASIDE NOMINATING PETITIONS

AND NOW, come Petitioners, by their counsel, Lawrence M. Otter, Esquire, and file the within Petition and, in support thereof avers as follows:

- 1. Exclusive jurisdiction over the subject matter of this Petition is vested in the Commonwealth Court of Pennsylvania by the provisions of the Pennsylvania Election Code, 25 P. S. § 2937, and the provisions of the Judicial Code, 42 Pa. C. S. A. § 764.
- 2. One Petitioner is William Krohn who resides at 2014 Housels Run Rd.. Milton, PA 17842 and is a duly registered and enrolled Republican elector of the Commonwealth of Pennsylvania who votes and resides in the 108th Legislative District.
- 3. One Petitioner is Robert Boyer, who resides at 340 Vine St., Sunbury, PA 17801 and is a duly registered and enrolled Republican elector of the Commonwealth of Pennsylvania who votes and resides in the 108th Legislative District.

- One Respondent is Tom Webb, a candidate for State Representative in
   108th Legislative District who as of February 13, 2024, allegedly resides
   at 105 Carroll Rd., Sunbury, PA 17801
- One Respondent is Al Schmidt, the Secretary of the Commonwealth, whose office is located at 305 North Office Building, Harrisburg, Pennsylvania.
- 6. On or about February 13, 2024, Nominating Petitions were filed with the Pennsylvania Department of State, Bureau of Elections, nominating Respondent, Tom Webb, as a Republican candidate for State Representative in the 108th Legislative District.
- 7. The nominating Petitions are purported to consist of 31 petition pages and allegedly containing 360 lines of signatures of electors supporting the nomination of Respondent Tom Webb.
- 8. Three Hundred (300) valid signatures of qualified electors who reside within the 108th Legislative District are required by statute, 25 P. S.
  §2872.1 (14) to support the Nominating Petitions of Tom Webb in the Primary Election scheduled for April 23, 2024.
- 9. The Nominating Petitions of Respondent Tom Webb are invalid and inadequate in that they contain less than 300 valid signatures and because

- of various inadequacies and deficiencies as outlined in a spreadsheet attached hereto and incorporated as **Exhibit A**.
- 10. In addition, there are various circulators deficiencies found in the circulator's affidavits on pages 1, 3, 4, 5, 6, 7,13, 14,15, 16 and 17. The circulator is not registered Republican at the Address listed in her affidavit, the county does not match the county of the electors,
- 11. Service upon the candidate was effectuated pursuant to the Order of this Court by the positing of this petition on the Commonwealth Court Docket.

WHEREFORE, Petitioner prays this Honorable Court to set aside the Nominating Petitions of Respondent Bobby Jeffries since he lacks the minimum number of valid signatures (300) for the office of State Representative and to order that his name not appear on the ballot for nomination as the Republican Party candidate for State Representative in the 106<sup>th</sup> Legislative District.
