**PETITION TO SET ASIDE THE NOMINATION PETITION OF LAURICE  
MACDONALD AS A CANDIDATE FOR THE DEMOCRATIC NONINATION FOR  
REPRESENTATIVE IN THE CONGRESS FOR THE 12<sup>TH</sup> CONGRESSIONAL  
DISTRICT IN THE PRIMARY ELECTION OF APRIL 23, 2024**

AND NOW, comes OBJECTORS, by and through their attorney, James J. Walsh, Esquire, and files this petition to set aside the Nomination Petition of Laurice MacDonald as a Candidate for the Democratic Nomination for Representative in Congress for the 12<sup>th</sup> Congressional District, averring the following:

**INTRODUCTION, PARTIES, AND JURISDICTION**

- 1) On April 23, 2024, a Primary Election will be held in the Commonwealth of Pennsylvania (the “Election”) with certain candidates listed on the ballot for their respective party’s nomination for a variety of offices, including the office of Representative in Congress for the 12<sup>th</sup> Congressional District.
- 2) Petitioner-Objector, Greg Katz is an adult individual, citizen, qualified elector, and a registered and enrolled Democratic Party voter in the Commonwealth of Pennsylvania who has a direct and substantial interest in

the Democratic Party nomination for Representative in Congress for the 12<sup>th</sup> Congressional District, and, therefore, in the success of this Petition. See generally In re Barlip, 428 A.2d 1058, 1060 (Pa. Cmwlth. Ct. 1981).

- 3) Greg Katz currently resides at 6364 Forward Avenue, Pittsburgh, PA 15217.
- 4) Petitioner-Objector, Cheryl S. Weisberg is an adult individual, citizen, qualified elector, and a registered and enrolled Democratic Party voter in the Commonwealth of Pennsylvania who has a direct and substantial interest in the Democratic Party nomination for Representative Congress for the 12<sup>th</sup> Congressional District, and, therefore, in the success of this Petition. See generally In re Barlip, 428 A.2d 1058, 1060 (Pa. Cmwlth. Ct. 1981).
- 5) Cheryl S. Weisberg currently resides at 315 Leroi Road., Pittsburgh, PA 15208.
- 6) Petitioner-Objector, Judith Frankle Bardack is an adult individual, citizen, qualified elector, and a registered and enrolled Democratic Party voter in the Commonwealth of Pennsylvania who has a direct and substantial interest in the Democratic Party nomination for Representative Congress for the 12<sup>th</sup> Congressional District, and, therefore, in the success of this Petition. See generally In re Barlip, 428 A.2d 1058, 1060 (Pa. Cmwlth. Ct. 1981).
- 7) Judith Bardack currently resides at 6315 Forbes Avenue., Apt. 1203, Pittsburgh, PA 15217.
- 8) Petitioner-Objector, Jonathon Nadle is an adult individual, citizen, qualified elector, and a registered and enrolled Democratic Party voter in the

Commonwealth of Pennsylvania who has a direct and substantial interest in the Democratic Party nomination for Representative Congress for the 12<sup>th</sup> Congressional District, and, therefore, in the success of this Petition. See generally In re Barlip, 428 A.2d 1058, 1060 (Pa. Cmwlth. Ct. 1981).

- 9) Jonathon Nadle currently resides at 858 Gladys Avenue, Pittsburgh, PA 15216.
- 10) Respondent is Laurice MacDonald (hereafter, “MacDonald” or “Candidate” or “Respondent”), a candidate for the Democratic Nomination for Representative in Congress for the 12<sup>th</sup> Legislative District, with an address listed on her candidates affidavit as 1000 Grand view Avenue, Apt. 105 Pittsburgh, PA 15211.
- 11) Circulator India Washington lists her address (on the petitions that she claims to have circulated) as 911 Adelaide Street, Pittsburgh, PA 15219 there is no registered voter, of any party, listed at that address in the SURE system.
- 12) Based upon information and belief, Ms. Washington was not the circulator for the petitions that she signed as the circulator.
- 13) Circulator Owen Cauley lists his address (on the petitions that he claims to have circulated) as 5424 Second Avenue Pittsburgh, PA 15207.
- 14) A Google search reveals that 5424 Second Avenue is a business named Rebo House, which is a drug and alcohol treatment facility for men.

- 15) There is no individual by the name of Owen Cauley who is registered to vote at 5424 Second Avenue.
- 16) Based upon information and belief Mr. Cauley was not the circulator for the petitions that he signed as the circulator.
- 17) Circulator David Moscov lists his address as 100 Deniston Avenue.
- 18) There is no David Moscov listed as a registered voter, nor as a registered democrat at that address.
- 19) The Pennsylvania Election Code, Act of June 3, 1937, P.L. 1333, 25 P.S. §§2600 *et seq.*, (the “Election Code,” herein cited only to Purdon’s Statutes) and cases decided thereunder govern the matters covered by this Petition.
- 20) This Court has original Jurisdiction over this matter pursuant to 42 Pa. Cons. Stat. §391.

**REQUIREMENTS FOR QUALIFICATION TO APPEAR ON THE APRIL 23, 2024  
PRIMARY BALLOT AS A CANDIDATE FOR THE DEMOCRATIC NOMINATION  
FOR REPRESENTATIVE IN CONGRESS FOR THE 12<sup>TH</sup> CONGRESSIONAL  
DISTRICT**

- 21) Paragraphs 1 - 20 are incorporated by reference.
- 22) Any candidate for office shall file a statement of financial interests for the preceding calendar year with the governing authority of the political subdivision in which he is a candidate on or before the last day for filing a petition to appear on the ballot for election. A copy of the statement of financial interests shall also be appended to such petition.

- 23) Such nomination petitions were required to be filed with the Pennsylvania Secretary of State, along with the required ethics and financial disclosure statement.
- 24) Each individual and numbered page of a nomination petition (“Signature Page”) is comprised of two sides containing thirty (30) designated lines requiring: valid signatures to include a signature of the elector; printed name of the elector; place of residence of the elector; (i.e., house number, street or road, city, borough or township), and date of signing by the elector. See 25 P.S. §2868.
- 25) Each Signature Page requires information identifying the year of the primary election concerned; the office sought by the candidate; the name, occupation and residence of the candidate; the county of the signers; and the political party of the signers.
- 26) Each page of the Nomination Petitions must be signed by the qualified elector that circulated the petition, the qualified elector must provide their name, the address that they are registered to vote at, and must be an enrolled member of the party that the candidate is seeking ballot access for.
- 27) Each Signature Page also includes an affidavit supporting the aforementioned signatures and information provided by electors.
- 28) Accordingly, unless the Nomination Petition submitted by MacDonald has been validly signed, in strict accordance with the requirements of the Election Code, by 1,000 registered, qualified electors for in the 12<sup>th</sup>

Congressional District, MacDonald's name may not be printed as a candidate on the April 23, 2024 Primary Ballot.

29) Furthermore, the circulator of each nomination petition must be a registered and enrolled member of the Democratic Party, and must be registered to vote at the address listed on the petitions.

**MACDONALD'S FILING AS A CANDIDATE FOR THE DEMOCRATIC  
NONINATION FOR REPRESENTATIVE CONGRESS FOR THE 12<sup>TH</sup>  
LEGISLATIVE DISTRICT IN THE PRIMARY ELECTION OF APRIL 23, 2024**

30) Paragraphs 1 – 29 are incorporated by reference.

31) On or about February 12, 2024 MacDonald filed a Nomination Petition with The Secretary of State seeking to have her name printed on the Pennsylvania Election Ballot as a candidate for the Democratic Nomination for Representative Congress for the 12<sup>th</sup> Legislative District.

32) The Nomination Petition consists of one hundred thirty-two (132) pages, accompanied by the Candidates affidavit; pages are to be numbered consecutively. See 25 P.S. §909. The original Nomination Petitions are in the custody of The Secretary of State, and are incorporated herein by reference.

33) The Nomination Petition contains two thousand three hundred twenty seven (2327) entries that purport to contain signatures, addresses and date of signing of qualified, registered electors (the "Signers") as well as notarized supporting affidavits of the circulators of each page of the Nomination Petition.

34)As detailed below, in the Nomination Petition, there are numerous defective signatures, illegible signatures, signatures of unregistered voters, duplicate signatures, signatures of voters not registered in the Democratic Party, and signatures of individuals not registered at the address listed.

35)As a result of the defects, other irregularities, and outright pattern of impropriety in the signatures, addresses and dates of the Signers, as well as the signatures and statements of the Circulators, the Nomination Petition contains an insufficient number of valid signatures to qualify MacDonald for inclusion on the April 23, 2024 Primary Ballot in the Commonwealth of Pennsylvania.

36)Accordingly, the Nomination Petition should be set aside and MacDonald's name should not appear on the Primary Election Ballot.

**SPECIFIC CHALLENGES TO NOMINATION PETITION: SIGNATURE DEFECTS, DATE DEFECTS AND OTHER DEFECTS**

37)Paragraphs 1-36 are incorporated by reference.

38)The Election Code specifies the requirements for the circulation and signing of the Nomination Petition for a Democratic Primary Nomination Candidate. See 25 P.S. §2861, et seq.

39)The Election Code also sets forth the procedure by which a Nomination Petition may be set aside. See 25 P.S. §2937.

40)Petitioner and their representatives have reviewed the Nomination Petition and based upon such review believe, and therefore aver, that the Nomination

Petition is defective, does not contain a sufficient number of genuine signatures of qualified electors entitled to sign the same under the Election Code, and otherwise fails to comply with the Election Code.

- 41) The Nomination Petition should, therefore, be set aside and MacDonald's name may not be printed as a candidate on the Primary Election Ballot. *See* 25 P.S. §2937.
- 42) The Petitioner, his representatives, and/or volunteers examined each signed line on each page of the Nomination Petition. The name of each purported Signer was checked against the database of registered Pennsylvania voters maintained by the Commonwealth of Pennsylvania Secretary of State.
- 43) Each of the purported Signers' entries on the Nomination Petition was also examined with respect to the signature, printed name, address, city and date, to determine if any line or part of line was missing, unreadable, forged or inaccurate.
- 44) In the case of signatures and printed names, volunteers supporting the efforts for the Petitioners also examined each of the entries to determine if initials or nicknames appear in any signature or printed name.
- 45) The entries on the individual lines of the Nomination Petition were examined and any defects were identified in the "Individual Line Challenges" attached hereto as Exhibit 1 according to the following criteria:

NACP = Not registered in candidate's party  
NRD = Not registered in the district  
NR = Not registered  
NRA = Not registered at address  
NRDS = Not Registered on Date signed  
LIO = Line information omitted  
ILL = Illegible  
IHA = In the hand of another  
DUP = Duplicate  
DCS (Global/Circulator) = Defective Circulator Statement  
Global (Circulator) = No circulator signed the Petition

- 46) Each challenge as to each item entered by each Signer to the Nomination Petition is set forth with particularity in the Individual Line Challenges, which is incorporated by reference as if fully set forth herein. See Exhibit 1.
- 47) The Petitioner's challenges to the signature lines identified in the Individual Line Challenges on Exhibit 1 totals one thousand six hundred seventy-five (1675) Signatures.
- 48) The Petitioner's identified zero (0) signatures that are believed to be valid, when the Global circulator challenges and the individual line challenges are combined.
- 49) None of the page and line entries challenged in the Individual Line Challenges may be counted in support of the nomination, and without them, the Nomination Petition does not contain the requisite number of signatures and must be set aside.
- 50) Therefore, MacDonald's Nomination Petition must be set aside and her name must not appear on the ballot as a candidate for the Democratic Party

Nomination for Representative in Congress for the 12<sup>th</sup> Congressional District.

**GLOBAL CHANGES TO THE NOMINATION PETITIONS – IS NOT A REGISTERED AND ENROLLED MEMBER OF THE DEMOCRATIC PARTY AT THE ADDRESS LISTED ON THE PETITION**

51) Paragraphs 1-50 are incorporated by reference.

52) The Election Code permits that Nomination Petitions may be on one or several sheets, however if more than one sheet is used, they shall be bound together when offered for filing if they are intended to constitute one petition, and each sheet shall be numbered consecutively beginning with the number one, and each page shall contain a signature of the circulator. *See* 25 P.S. §909.

53) Petitioner and/or his representatives and/or volunteers have examined the Nomination Petitions to determine whether the Nomination Petitions conform to the legal requirements.

54) Pages 8-52, 56, 58-77, 79-98, 100-132 of MacDonald's Nomination Petitions were signed by India Washington as the circulator.

55) As stated above no individual is registered to vote at the address Ms. Washington listed as her address on the pages she purports to have circulated, therefore all pages circulated by Ms. Washington do not conform to the Election Code and must be stricken.

- 56) Further, based upon information and belief, Ms. Washington was not the circulator for these petitions, but the petitions were in fact circulated by other paid circulators, not under the supervision of Ms. Washington.
- 57) Pages 1-7, 53, 54, 55, 57, and 99 were signed by Owen Cauley as the circulator.
- 58) As stated above Mr. Cauley listed his address as a drug and alcohol rehabilitation center, and Mr. Cauley is not registered at that address, nor he is registered as an enrolled member of the democratic party at that address.
- 59) Further, based upon information and belief, Mr. Cauley was not the circulator for these petitions, but the petitions were in fact circulated by other paid circulators, not under the supervision of Mr. Cauley.
- 60) Page 78 was signed by David Moscov as the circulator.
- 61) As stated above, Mr. Moscov listed his address as 100 Denniston Avenue, Mr. Moscov is not a registered and enrolled member of the democratic party at 100 Denniston Avenue.
- 62) Based upon information and belief, Mr. Moscov was not the circulator for this petition, but the petition was in fact circulated by other paid circulators not under the supervision of Mr. Cauley.
- 63) The Petitioner's global challenges to the Nomination Petitions set for herein totals two thousand three hundred twenty seven (2327).
- 64) None of the individual entries on the Individual Line Challenges by Petitioner as set forth herein, and none of the entries on any of the pages to

which Petitioner made Global Challenges herein, may be counted in support of MacDonald's nomination, and without them, MacDonald has well below the one thousand (1,000) signatures required to be placed on the Ballot.

Therefore, MacDonald's Nomination Petition must be set aside, and her name must not appear on the ballot as a candidate for the Democratic Party Nomination for Representative in Congress for the 12<sup>th</sup> Congressional District on the April 23, 2024 Primary ballot.

WHEREFORE, the Petitioner prays that this Honorable Court enter an Order as follows:

1. Setting aside the Nomination Petition of Laurice MacDonald;
2. Sustaining the objections of the Petitioners to the Nomination Petition;
3. Declaring that Laurice MacDonald did not submit, and has not obtained, at least the minimum number of valid signatures required by the Election Code to have her name placed on the April 23, 2024 ballot for the Democratic Party Nomination for Representative in Congress for the 12<sup>th</sup> Congressional District;
4. Directing the appropriate officers of the Commonwealth of Pennsylvania and its political subdivisions to strike and set aside the Nomination Petition and further direct them not to place the name of Laurice MacDonald on the April 23, 2024 ballot for the Democratic Party

Nomination for Representative in Congress for the 12<sup>th</sup> Congressional District;

5. Order MacDonald and/or his official campaign and/or campaign committee to make payment for the costs of these proceedings, including witness fees and such other reasonable costs and attorneys' fees incurred by the Petitioner in bringing forth this Petition. See the Pennsylvania Election Code at 25 P.S. §2937; and
6. Granting such other and further relief as this Court deems necessary and just.


