**PETITION TO SET ASIDE NOMINATION PETITION**

Marykathryn Best and Jennifer Shukaitis, Petitioner-Objectors, by and through undersigned counsel, respectfully aver that:

**Jurisdiction**

1. This Court has original jurisdiction in cases relating to election challenges for candidate for State Representative. See 42 Pa. C.S. § 764(1); 25 P.S. § 2937.

**Objectors**

2. Marykathryn Best and Jennifer Shukaitis are each registered Democrats residing in the 115th Legislative District at 1005 Fox Hollow Road and 935 Marshall Drive in Stroud Township, Pennsylvania.

### **Lopez’s Filed Petition and Documents**

3. On or about February 1, 2024, Anna Lopez (“Candidate”) filed a nomination petition seeking the Democratic nomination for State Representative from the 115<sup>th</sup> Legislative District.
4. The initial filing contained 21 pages of signatures, an affidavit with unsworn declaration, and a statement of financial interests (or a copy thereof).
5. On or before February 13, 2024, Candidate filed three supplemental pages of signatures, bringing the total number of pages to 32.
6. A copy of Candidate’s nominating petition (the “Nominating Petition”) is attached hereto as Exhibit A. The Nominating Petition contains information on 518 lines across 32 pages as follows:

### **Insufficient Nominating Petition**


7. Candidates for State Representative are required to file nominating petitions with 300 valid signature lines. 25 P.S. § 2872.1(14).
8. However, the Candidate's Nominating Petition contains only 271 valid lines.
9. The remaining 247 lines are invalid, for the reasons set forth on the spreadsheet attached hereto as Exhibit B.

10. Petitioner respectfully reserves the right to add such additional objections as are appropriate under applicable law at the time of the hearing.
11. Additionally, upon information and belief, a number of these signatures were written and/or forged by persons other than those whose name appears as a signer.
12. As a result, the Statement of Circulator for the relevant pages was signed knowing that these purported signers did not actually sign the petition.
13. Any page containing a false Statement of Circulator should be stricken.
14. Because it does not contain the required 300 valid signature lines, the Nomination Petition fails to conform to the requirements of the Election Code, 25 P.S. § 2867 et seq., and must be set aside and the Candidate's name should not be placed upon the ballot.

WHEREFORE, Petitioners pray this Honorable Court to set aside the Nomination Petition and order that Anna Lopez's name not appear on the 2024 ballot for nomination in the 115th Legislative District.
