**PETITION OBJECTING TO NOMINATING PETITIONS OF  
JOHN K. REBER FOR DELEGATE TO THE 2024 REPUBLICAN NATIONAL  
CONVENTION PURSUANT TO 25 P.S. § 2937**

Petitioners (sometimes referred to as “Objector(s)”), by and through their undersigned counsel, respectfully submits this Petition Objecting to the Nominating Petitions of John K. Reber, Sr., for Delegate to the Republican National Convention Pursuant to 25 P.S. § 2937, along with the petitions subject to this objection and an Excel spreadsheet showing the signature lines objected to as required by the Order of this Honorable Court dated July 19, 2023.

**I. PARTIES, JURISDICTION AND VENUE**

1. Objector, Stanley A. Casacio, 624 Creek Lane, Flourtown, Montgomery County, PA 19031, is an adult individual, citizen, qualified Pennsylvania elector and registered Republican voter in Montgomery County and the 4<sup>th</sup> Congressional District of Pennsylvania who has a direct and substantial interest in the 2024 Primary Election and, therefore, in the success of this Petition. See generally, *In re Duncan*, 516 A.2d 776, 778 (Pa. Cmmw. 1982).

2. Objector, Barbara Soga, 215 Adams Road, Greenwich Township (Kutztown), Berks County, PA 18950, is an adult individual, citizen, qualified Pennsylvania elector and registered Republican voter in Berks County and the 4<sup>th</sup> Congressional District of Pennsylvania

who has a direct and substantial interest in the 2024 Primary Election and, therefore, in the success of this Petition. See generally, *In re Duncan*, 516 A.2d 776, 778 (Pa. Cmmw. 1982).

3. Respondent, John K. Reber, Sr., has filed nomination petitions seeking a ballot position for himself in the 2024 Republican primary to vie for election as a candidate for Delegate to the Republican National convention (the “Reber Petitions,” true and correct copies of which are attached hereto as Exhibit 1).

4. Challenges to such nomination petitions may be filed by any qualified elector under 25 P.S. § 2937, which governs the procedures for such challenges. Both Objectors are qualified electors under 25 P.S. § 2937.

5. Pursuant to 42 P.S. § 764, the Commonwealth Court of Pennsylvania is the proper venue for a challenge to the nomination petitions of a candidate for a delegate to a national party convention.

## **II. FACTUAL AND LEGAL BACKGROUND**

6. Petitioners hereby incorporate the foregoing averments as though set forth at length herein.

7. The office of Delegate to the Republican National Convention for the 4<sup>th</sup> Congressional District of Pennsylvania requires nominating petitions containing at least 250 valid signatures in compliance with 25 P.S. § 2872.1(29), number of signatures, and 25 P.S. § 2868, setting forth the requirements of signors of a Nomination Petitions.

8. On February 12, 2024, Respondent submitted to the PA BOE nominating petitions seeking to be nominated to the 2024 Republican primary ballot for the office of Delegate to the 2024 Republican National Convention for the 4<sup>th</sup> Congressional District of Pennsylvania, containing a total of 273 signatures, where 73 of those signatures did not comply

with 25 P.S. § 2868, leaving Respondent with only 200 potentially valid signatures, less than the 250 minimum required valid signatures.

9. Reber's nomination petitions contain 24 pages divided amongst 12 two-sided petition forms; the original Reber Nomination Petition and Candidate's affidavits remain in the custody of the Secretary of the Commonwealth and are incorporated herein by reference and are included as Exhibit 1-A. Exhibit 1 hereto are true and correct copies of said Reber Nomination Petition.

**REBER DID NOT SUBMIT 250 VALID SIGNATURES ON HIS NOMINATING PETITIONS, AND MUST BE REMOVED FROM THE BALLOT**

10. Section 908 of the Election Code, 25 P.S. §2868, lists the requirements for each signer of a Nomination Petition. Each signer must:

- a. sign but one such petition for each office to be filled;
- b. declare therein that he is a registered and enrolled member of the party designated in such petition;
- c. declare therein that he is a qualified elector of the county therein named, and in case the nomination is not to be made or candidates are not to be elected by the electors of the State at large, of the political district therein named, in which the nomination is to be made or the election is to be held; and
- d. add his residence, giving city, borough or township, with street and number, if any, and shall legibly print his name and add the date of signing, expressed in words or numbers: Provided, however, that if the said political district named in the petition lies within any city, borough or township, or is coextensive with same, it shall not be necessary for any signer of a nomination petition to state therein the city, borough or township of his residence.

11. Having thoroughly reviewed the Petitions attached as Exhibits 1 and 1-A, Objectors assert that Reber has failed to meet the requirement of presenting 250 valid signatures of qualified Pennsylvania elector and registered Republican voters in the 4<sup>th</sup> Congressional District

of Pennsylvania, covering most of Montgomery County and parts of Berks County, collected by circulators who themselves were not legally qualified to do so.

12. While Reber submitted 273 signatures, only 200 of those signatures appear to meet the legal requirements to be counted towards the 250 signatures required by statute for Reber to have his name placed on the ballot as a candidate for the office of Delegate to the 2024 Republican National Convention for the 4<sup>th</sup> Congressional District of Pennsylvania. Fully 73 of the signatures Reber collected are defective in at least one way, and often in multiple ways.

13. Exhibit 2 to this Petition is a spreadsheet prepared pursuant to this Court’s July 13, 2023, Order in In re Objections to Nomination Petitions/Papers of Candidates for Statewide and State-level Office, No. 126 Misc. Dkt. No. 3, listing by line and number the specific signatures being objected to, applying the following codes:

**Indisputably Defective Signatures**

14. Many of the signatures gathered are defective on grounds that are easily assessed by the Court, being either facially defective or which can be confirmed through verification with the Commonwealth's SURE system. These signatures fall into one or more of the following categories:<sup>1</sup>

A. **Signer Not Registered.** Upon information and belief, the 14 signatures in Exhibit 2 with code NR represent signers who are not registered to vote or not registered to vote as Republicans and who thus are not qualified to sign nomination petitions pursuant to 25 P.S. § 2937 and must be stricken.

B. **Not Registered at Address.** Upon information and belief, the 6 signatures in Exhibit 2 with code NRA represent signers who have been found to be registered Republicans in Montgomery or Berks Counties, as the case may be, but not at the address provided on the petition. Given that residence is not clearly provided by these voters, these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

C. **Not Registered in Candidate's Party.** Upon information and belief, the 20 signatures in Exhibit 2 with code NRCP represent signers who have been found not to be registered Republicans in Montgomery or Berks Counties. Given that these persons are not Republicans, they are ineligible to sign Republican nominating petitions and these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

D. **Not Registered in District.** Upon information and belief, the 32 signatures in Exhibit 2 with code NRD represent signers who have been found not to be registered Republicans in the district applicable to the office sought in the Reber Nominating petition. Given that these persons are not registered in the district applicable to the office sought, they are

ineligible to sign the Reber Nominating Petitions and these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

E. **Not Registered on Date Signed.** Upon information and belief, the 13 signatures in Exhibit 2 with code NRDS represent signers who have been found not to be registered Republicans in the district applicable to the office sought in the Reber Nominating petition on the date they signed the petition. Given that these persons are not registered district applicable to the office sought on the date they signed the petition, they are ineligible to sign the Reber Nominating Petitions and these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

F. **Illegible Entry.** Upon information and belief, the 3 signatures in Exhibit 2 with code ILL represent signers whose signatures and/or identifying information is illegible on the Reber Nominating petition. Given that these persons' signatures and identifying information cannot be verified these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

G. **Duplicate Signatures.** Upon information and belief, the 2 signatures in Exhibit 2 with code DUP represent signers whose signatures are duplicates on the Reber Nominating petition. Given that these persons' signatures cannot be duplicates these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

H. **Line Information in Hand of Another.** Upon information and belief, the 4 signatures in Exhibit 2 with code IHA represent signers whose signatures and line information are in differing hands (line information in hand of another). Given that the signatures and line information cannot be in differing hands, these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

I. **Nickname/Initial.** Upon information and belief, the 2 signatures in Exhibit 2 with code N/I represent signers whose signatures and/or identifying information is either a nickname

or initial and not the elector's full name on the Reber Nominating petition. Given that these persons' using a nickname of initial instead of a full signature is inappropriate under the law, these signatures must be struck as invalid pursuant to 25 P.S. § 2937.

15. In all, 73 signatures must be stricken as invalid on all the aforementioned bases.

16. Having presented only 200 potentially valid signatures, and needing 250 valid signatures, Reber has not qualified under the terms of the Election Code to appear on the April 23, 2024, Republican Primary ballot as a candidate for the Delegate to the 2024 Republican National Convention.

## RELIEF REQUESTED

17. Pursuant to 25 P.S. § 2937, Objectors:
- A. Hereby object to the nomination petitions of JohnK. Reber, Sr.;
  - B. Are prepared to substantiate these objections via testimony and evidence at a prompt hearing as mandated by 25 P.S. § 2937:
  - C. Asks this Court to set aside the Reber Nomination Petitions in accordance with applicable law; and,
  - D. Asks this Court to remove Reber from the April 23, 2024, ballot as a candidate for Delegate to the 2024 Republican National Convention.

WHEREFORE, it is respectfully requested that the Court enter an order consistent with the foregoing request for relief and such other relief as the Court deems just and equitable under the circumstances.



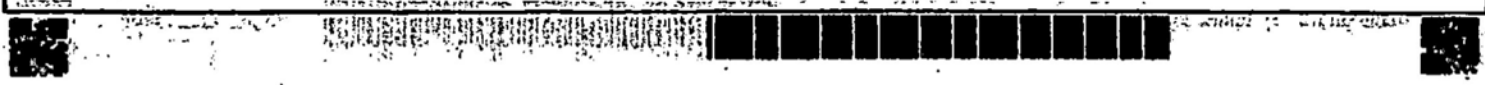
