
ADMINISTRATIVE ORDER

AND NOW, **March 17, 2020**, it is hereby ORDERED, ADJUDGED, and
DECREED that public access to judicial facilities in the Thirtieth Judicial District
shall be limited as follows, effective immediately:

1. Court and County employees, officials, and people with badge keycard credentials;
2. Attorneys, litigants, witnesses, victims, and participants in judicial proceedings before the Court of Common Pleas or a Magisterial District Court;
3. Individuals with a business need before a court or court-related office as set forth in the guidelines attached hereto;
4. Attorneys, litigants, or their representatives filing papers or pleadings, or making monetary payments, with the Offices of the Prothonotary, Clerk of Courts, or Domestic Relations; and
5. Members of the media.

It is further ORDERED that the Sheriff and his designees are authorized to enforce this Order, and bar individuals from the judicial facilities.

DOMESTIC RELATIONS

SCHEDULED MATTERS

Conference and hearings will take place by encouraging clients to use phone appearance.
Contempt conferences will remain scheduled unless the court schedule changes.

PAYMENTS

Payments made at the office for purges will continue to be accepted. However encouragement to pay via telephone or use on line services when possible.

FILING OF ESTABLISHMENT and MODIFICATION PETITIONS

1. Petitioners will be referred to e-services.
2. Intake appointments will continue to be scheduled as needed.
3. Clients unable to file on line (establishment or modification) will be given the four page questionnaire for intake or the petition for modification to be completed in waiting room when they appear in office or emailed if calling for an appointment.
4. Caseworkers will be contacting all clients scheduled for conferences until April 6th to request the use of telephonic appearance and paperwork sent via email.
5. Work Search and DMP will be contacting all clients to request call in's instead of appearing in the office effective immediately and until April 6th.
6. Travel to Titusville will cease until April 6th.

Notwithstanding the foregoing, each commissioned Common Pleas Court Judge may *sua sponte* continue hearings and otherwise modify that Judge's assigned cases as deemed necessary.
