Administrative Order Rescheduling Criminal Matters

NOW THIS 20th day of March, 2020, in accordance with the Order of the Supreme Court of Pennsylvania dated March 18, 2020, directing that all Pennsylvania Courts are generally closed to the public beginning at the close of business on March 19, 2020, and lasting through, at least April 3, 2020; and in accordance with the Supplemental Emergency Judicial Order issued by President Judge Shawn D. Meyers on March 19, 2020, adopting and incorporating the Order of the Supreme Court of Pennsylvania and confirming that the Courts of the 39th Judicial District are generally closed to the public beginning at the close of business on March 19, 2020, and lasting through, at least April 3, 2020; and in recognition of the need to reset the Court's schedule to carry out its essential functions:

IT IS HEREBY ORDERED that criminal matters involving incarcerated defendants scheduled for Wednesday, March 25, 2020, shall be rescheduled to be heard on Thursday, March 26, 2020. Criminal matters involving incarcerated defendants scheduled for Wednesday, April 1, 2020 shall be rescheduled to be heard on Thursday, April 2, 2020.

IT IS FURTHER ORDERED that the above-described criminal matters involving incarcerated defendants shall be held via video conference with the Franklin County Jail. The incarcerated defendant shall appear via video conference.


