JUDICIAL ORDER

AND NOW, this 6th day of May, 2020, IT IS HEREBY ORDERED, ADJUDGED and DECREED, that the June Jury Trial Term scheduled for the Sixth Judicial District of the Court of Common Pleas of Erie County, Pennsylvania shall be CANCELLED due to the COVID-19 pandemic. This cancellation shall be considered a Court postponement and shall constitute excludable time for purposes of the application of Pa. R. Crim. P. 600, subject to constitutional limitations.

All other matters shall resume in the Erie County Court of Common Pleas on Monday, June 1, 2020. Of course, the Court emphasizes that the safety practices regarding COVID-19, such as safe distancing, hand washing and wearing masks, will be undertaken to assure public safety.

Further, this Court amends Paragraph 5(g)(iii) of the Court's Emergency Judicial Order dated March 17, 2020, which issued a stay on all landlord/tenant proceedings, as follows:

Any landlord/tenant proceeding for Order of Possession which was adjudicated or ruled upon by a Magisterial District Justice or by a Judge of the Court of Common Pleas of Erie County, prior to the issuance of this Court's March 17, 2020 Order, may now proceed effective May 11, 2020. However, certain filings, charges and acts relating to dispossession will remain subject to temporary restraints due to other directives, including provisions of the federal Coronavirus Aid, Relief and Economic Security (CARES) Act. See also 15 U.S.C. § 9058, et al, and/or any other applicable law or Order of Court.

Landlord/tenant matters not subject to the terms of the above amendment may be resumed on June 1, 2020, of course, subject to any limitations or directives that may be applicable through the federal CARES Act and/or any other applicable law or Order of Court.
