Given this, former Congressman Costello will further testify that he has an interest in ensuring a prompt adoption of an appropriate congressional district plan.

3. Guy Reschenthaler, United States Representative in Pennsylvania's 14th Congressional District.

Congressman Reschenthaler will testify, via affidavit, that he is a sitting Congressman participating in the 2022 midterm elections and represents Pennsylvania's current 14th Congressional District.

Congressman Reschenthaler will further testify that he must begin circulating nominating petitions for the upcoming election beginning on February 15, 2022, and has an interest in ensuring a prompt adoption of an appropriate congressional district plan.
