STIPULATION OF FACTS

Solely for purposes of the intervention hearing in the above matter to be held on January 6, 2022 (the Carter Petitioners expressly reserve the right to contest these facts at a future time), the Carter Petitioners and the Proposed Congressional Intervenors do hereby stipulate and agree as follows:

1. Proposed Intervenor United States Representative Guy Reschenthaler is the Representative in Pennsylvania’s 14th Congressional District.
2. Proposed Intervenor Reschenthaler is scheduled to begin circulating nominating petitions on February 15, 2022.
3. Proposed Intervenor Jeffrey Varner is a registered voter and resident of Swatara Township, Dauphin County in the 10th Congressional District.
4. Proposed Intervenor Varner is a duly elected member of the Swatara Township Board of Commissioners and has served in that capacity since 2012.

5. Acting through its Board of Commissioners, Swatara Township often engages with its member of Congress in various initiatives, including obtaining funding from the Federal government for essential services Swatara Township provides to constituents.

6. Proposed Intervenor Varner participated in efforts to implement a new districting scheme in Swatara Township following the 2010 decennial census.

7. Proposed Intervenor Tom Marino is a former United States Representative who represented Pennsylvania's 10th Congressional District from 2011-2019, and Pennsylvania's 12th Congressional District in 2019.

8. Proposed Intervenor Ryan Costello is a former United States Representative who represented Pennsylvania's 6th Congressional District from 2015-2019. Costello is also a former Chester County Commissioner, serving from 2011-2014.

9. Proposed Intervenor Bud Shuster is a former United States Representative who represented Pennsylvania's 9th Congressional District from 1973-2001.

10. Proposed Intervenors Marino, Costello, and Shuster all have participated in the redistricting process as former Congressmen.

11. In light of the foregoing stipulations, the Proposed Intervenors will not be calling witnesses at the January 6, 2022 hearing.
