**JOINT STIPULATION OF FACTS FROM CARTER PETITIONERS AND
PROPOSED SENATE DEMOCRATIC CAUCUS INTERVENORS AND
PROPOSED DEMOCRATIC SENATOR INTERVENORS**

Solely for the purposes of the intervention hearing in the above matter to be held on January 6, 2022 (the *Carter* Petitioners expressly reserve the right to contest these facts at a future time), the *Carter* Petitioners, Proposed Senate Democratic Caucus Intervenors, and the Proposed Democratic Senator Intervenors do hereby stipulate and agree as follows:

1. Proposed Intervenor Jay Costa is a State Senator from the 43rd Senatorial District including Allegheny County. Senator Costa serves as a Leader of the Senate Democratic Caucus. Senator Costa is also a resident and registered voter

in the 18th Congressional District. He is a prospective candidate for reelection in the fall of 2024.

2. Proposed Intervenor Vincent J. Hughes is a State Senator from the 7th Senatorial District including Philadelphia and Montgomery Counties. Senator Hughes serves as the Democratic Chair of the Senate Appropriations Committee. Senator Hughes is also a resident and registered voter in the 3rd Congressional District. He is a prospective candidate for reelection in the fall of 2024.

3. Proposed Intervenor Wayne D. Fontana is State Senator from the 42nd Senatorial District including Allegheny County. Senator Fontana serves as Chair of the Senate Democratic Caucus. Senator Fontana is also a resident and registered voter in the 18th Congressional District. He is a prospective candidate for reelection in the fall of 2022.

4. Proposed Intervenor Judy Schwank is a State Senator from the 11th Senatorial District including Berks County. Senator Schwank serves as the Administrator of the Senate Democratic Caucus. Senator Schwank is also a resident and registered voter in the 9th Congressional District. She is a prospective candidate for reelection in the fall of 2024.

5. Proposed Intervenor Senator Boscola is a State Senator from the 18th Senatorial District in Lehigh and Northampton Counties. Senator Boscola is also a

resident and registered voter in the 7th Congressional District. She is a prospective candidate for reelection in the fall of 2022.

6. Proposed Intervenor James Brewster is a State Senator from the 45th Senatorial District including Allegheny and Westmoreland Counties. Senator Brewster is also a resident and registered voter in the 18th Congressional District. He is a prospective candidate for reelection in the fall of 2024.

7. Proposed Intervenor Amanda M. Cappelletti is a State Senator from the 17th Senatorial District including Delaware and Montgomery Counties. Senator Cappelletti is also a resident and registered voter in the 4th Congressional District. She is a prospective candidate for reelection in the fall of 2024.

8. Proposed Intervenor Carolyn Comitta is a State Senator from the 19th Senatorial District including Chester County. Senator Comitta is also a resident and registered voter in the 6th Congressional District. She is a prospective candidate for reelection in the fall of 2024.

9. Proposed Intervenor Marty Flynn is a State Senator from the 22nd Senatorial District including Lackawanna, Luzerne, and Monroe Counties. Senator Flynn is also a resident and registered voter in the 8th Congressional District. He is a prospective candidate for reelection in the fall of 2022.

10. Proposed Intervenor Arthur Haywood is a State Senator from the 4th Senatorial District including Montgomery and Philadelphia Counties. Senator

Haywood is also a resident and registered voter in the 4th Congressional District. He is a prospective candidate for reelection in the fall of 2022.

11. Proposed Intervenor John Kane is a State Senator from the 9th Senatorial District including Chester and Delaware Counties. Senator Kane is also a resident and registered voter in the 6th Congressional District. He is a prospective candidate for reelection in the fall of 2024.

12. Proposed Intervenor Timothy Kearney is a State Senator from the 26th Senatorial District including Chester and Delaware Counties. Senator Kearney is also a resident and registered voter in the 5th Congressional District. He is a prospective candidate for reelection in the fall of 2022.

13. Proposed Intervenor Stephen Santarsiero is a State Senator from the 10th Senatorial District including Bucks County. Senator Santarsiero is also a resident and registered voter in the 1st Congressional District. He is a prospective candidate for reelection in the fall of 2022.

14. Proposed Intervenor Nikil Saval is a State Senator from the 1st Senatorial District including Philadelphia County. Senator Saval is also a resident and registered voter in the 3rd Congressional District. He is a prospective candidate for reelection in the fall of 2024.

15. Proposed Intervenor Christine Tartaglione is a State Senator from the 2nd Senatorial District including Philadelphia County. Senator Tartaglione is also a

resident and registered voter in the 2nd Congressional District. She is a prospective candidate for reelection in the fall of 2022.

16. Proposed Intervenor Lindsey Williams is a State Senator from the 38th Senatorial District including Allegheny County. Senator Williams is also a resident and registered voter in the 17th Congressional District. She is a prospective candidate for reelection in the fall of 2022.

17. Proposed Intervenor Maria Collett is a State Senator from the 12th Senatorial District including Montgomery and Bucks Counties. She is also a resident and registered voter in Montgomery County in the 4th Congressional District. She is a prospective candidate for reelection in 2022.

18. Proposed Intervenor Katie J. Muth is a State Senator from the 44th Senatorial District including Chester, Montgomery, and Berks Counties. Senator Muth is also a resident and registered voter in Montgomery County in the 4th Congressional District. She is a prospective candidate for reelection in 2022.

19. Proposed Intervenor Sharif Street is a State Senator from the 3rd Senatorial District including Philadelphia County. Senator Street is a resident and registered voter in Philadelphia in the 3rd Congressional District.

20. Proposed Intervenor Anthony H. Williams is a State Senator from the 8th Senatorial District including Philadelphia and Delaware Counties. Senator

Williams is a resident and registered voter in Philadelphia County in the 3rd Congressional District. He is a prospective candidate for reelection in 2022.

21. Proposed Intervenors Senators Collett, Muth, Street, and Williams are all of the members of the Democratic Party on the State Government Committee of the Pennsylvania Senate.

22. August 2021, the United State Secretary of Commerce delivered census-block results of the 2020 Census to the Pennsylvania Governor and legislative leaders. The census data confirmed that Pennsylvania will be allocated only 17 Members in the next Congress, one fewer than currently allotted.

23. Under the current election schedule, the 2022 primary will occur on May 17, 2022.

24. For a May 17 election, the first day to circulate and file nomination petitions will be February 15, 2022.

25. On December 15, 2021, the House State Government Committee approved House Bill 2146.
