- 7. THE NOMINATING PETITIONS CONTAIN A MULTITUDE OF DEFICIENCIES.
- 8. EXHIBIT A. ATTACHED HERETO, OUTLINES THE CHALLENGES TO THE NOMINATING PETITIONS OF AISSIA RICHARDSON.
