**PETITION TO SET ASIDE NOMINATION PETITION**

The Petitioners, by and through counsel, respectfully aver that:


1. The Petitioners, Lindsey Conan, Lucien Kane, Daniel Kane, John Child, and Austin Hepburn are duly qualified electors who reside in the 168<sup>th</sup> Legislative District.
2. The Respondent is seeking to be the Libertarian Candidate for State Representative of the 168<sup>th</sup> Legislative District in Pennsylvania.
3. On or before August 1, 2022, the above Candidate filed Libertarian Nomination Petitions with the Department of State. A copy is attached hereto and marked as Exhibit "A".
4. For the reasons set forth in greater detail in the attached spreadsheet, the Candidate's Nomination Petition fails to contain the required number of properly ascribed signatures. A copy is attached hereto and marked as Exhibit "B".
5. The Candidate has submitted 362 signature lines; 113 of these lines are challenged and believed to be invalid.
6. The Nomination Petition therefore fails to conform to the requirements of the Election Code, 25 P.S. §2867 et seq., and must be set aside and the Candidate's name not be placed on or stricken from the ballot.
7. Section 977 of the Election Code, 25 P.S. §2937, provides that a court shall set aside nomination petitions that are defective.
8. Because the Candidate has failed to submit the required 300 valid signatures, his nomination petitions must be set aside, and the Candidate's name can not be placed on or must be stricken from the ballot.

9. Petitioners respectfully reserve the right to add such additional objections as are appropriate at the time of hearing.

**WHEREFORE**, the Petitioners pray that this Honorable Court enter an Order:

1. Striking and setting aside the Nomination Petition of James Free Mitchell, V.
2. Declaring that James Free Mitchell, V., does not have the requisite valid number of signatures as required under the Election Code to have his name placed on the ballot as a Candidate for the District in the General Election.
3. Sustaining the objections of the Petitioners to the Nomination Petition;
4. Directing the appropriate officers of the Commonwealth of Pennsylvania to strike and set aside the Nomination Petition of James Free Mitchell, V., and further directing them not to place his name on the ballot for the November 8, 2022, General Election for the office of State Representative of the 168<sup>th</sup> Legislative District; and
5. Granting such other and further relief as this Court deems necessary and just.

4. Any other objections, e.g., to circulator affidavits, candidate affidavits, etc., must be clearly and separately stated in the objection petition.
5. If filing the objection petition in paper format:
  - a. Objector shall attach to the objection petition as an exhibit a printed copy of the spreadsheet printed on 8 ½ x 14 inch paper, with all grid lines showing and column headings appearing on each printed sheet, and a printed copy of the challenge codes key.
  - b. In addition, Objector shall file two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheets on the each digital media

devices must be enabled for editing by the Court, and may **not** be read-only or password protected.

6. If filing the objection petition by PACFile:
  - a. Along with the electronically filed objection petition, Objector shall file as an exhibit an electronic (PDF) version of the spreadsheet with all grid lines showing and column headings appearing on each sheet, and an electronic (PDF) version of the challenge codes key.
  - b. **Within two days** of submission of filing the objection petition and spreadsheet, Objector shall submit to the Court two paper copies of the electronically filed objection petition and spreadsheet **and** two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheet on the each digital media device must be enabled for editing by the Court, and may **not** be read-only or password protected.
7. Regardless of the method of filing, in addition to the usual service requirements Objector shall serve upon Candidate one digital media device containing a read-only electronic version of the spreadsheet and challenge codes key.
