# RESPONSE OF JUDICIAL CONDUCT BOARD TO THE MOTION OF THE RESPONDENT, JUDGE MARK B. COHEN, FOR DISCOVERY PURSUANT TO RULE 401

AND NOW, this 15<sup>th</sup> day March, 2023, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board), by and through undersigned counsel, and files this Response to the Motion of the Respondent, Judge Mark B. Cohen, for Discovery Pursuant to Rule 401, and in support thereof, avers the following:

- 1. The Board filed a Board Complaint against Judge Cohen in this Court on February 23, 2023, and served same to Judge Cohen through counsel on that date.
- 2. Court of Judicial Discipline Rule of Procedure 401, regarding discovery, states, in relevant part, the following:
  - (A) All discovery shall be completed within 60 days of the service of Board Complaint, unless extended by the Conference Judge for good cause shown.

(E) Disclosure by the Board. Upon filing of the Board Complaint, the Board shall provide the Judicial Officer with any exculpatory evidence relevant to the charges contained in the Board Complaint.

3. Upon the filing of the Board Complaint, Board counsel informed Judge Cohen's counsel that there was, in counsel's judgment, no exculpatory evidence within the Board's possession to provide to him.

- 4. By its terms, Rule 401's 60-day period will conclude on Monday, April 24, 2023.
- 5. Consistent with its responsibility under Rule 401, the Board will provide relevant discovery to Judge Cohen by April 24, 2023.
- 6. Judge Cohen's present discovery motion is patently premature under the explicit terms of Rule 401.

WHEREFORE, it is respectfully requested that this Honorable Court deny Respondent's Motion for Discovery.
