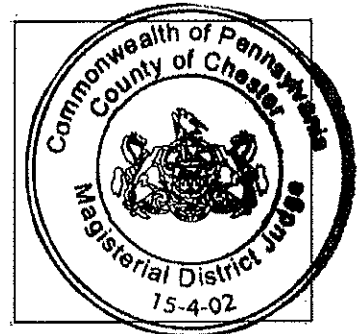

AFFIDAVIT of PROBABLE CAUSE

Your Affiant is a member of the Pennsylvania State Police and is currently assigned to the Patrol Section of Troop J at the Avondale Barracks. On April 23, 2023, your Affiant was working 0600-1400 hours shift in a marked Pennsylvania State Police vehicle, J2-10, while in full uniform.

On April 23, 2023, at approximately 1054 hours, I was dispatched to 435 Hickory Hill Road, Pocopson Township, Chester County, Pennsylvania for a reported "Domestic-In Progress". The Complainant, Michelle JABLONSKI, related there was a physical altercation occurring between Jesse MARGERA and Brendon Cole MARGERA. Jesse MARGERA will hereafter be referred to as VICTIM #1. Brendon Cole MARGERA will hereafter be referred to as the DEFENDANT.

Upon Troopers arrival on scene, I observed multiple people outside the residence standing in the driveway. VICTIM #1 and Phillip J. MARGERA Jr., related the DEFENDANT fled the residence on foot to the rear of the property through a dense wooded area. Phillip J. MARGERA Jr. will hereafter be referred to as VICTIM #2. VICTIM #1 and VICTIM #2 related multiple other Troopers were canvassing the wooded area for the DEFENDANT. The DEFENDANT was not located on scene.

I interviewed VICTIM #1 on scene. VICTIM #1 related on 04/23/2023 at approximately 0800 hours, he awoke to the DEFENDANT banging and kicking his locked bedroom door. VICTIM #1 related as he exited his bedroom, he observed a handwritten note stating, "If you even fucking think of calling the police on me I will officially fuck you up" signed "Bam". "Bam" is the nickname of the DEFENDANT. VICTIM #1 related he later went into the kitchen of the residence and observed the DEFENDANT urinating in the sink. VICTIM #1 related the DEFENDANT started screaming at him and became aggressive. VICTIM #1 related the DEFENDANT began punching him, striking him in the right eye/nose and left ear. I observed a red abrasion/laceration on the right side of VICTIM #1 nose. I observed a red abrasion/laceration on VICTIM #1 left ear. VICTIM #1 related at some point during the physical altercation the DEFENDANT grabbed his right arm. I observed a red abrasion to VICTIM #1 right bicep.

I, TPR. JOHN WENDLING BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

VICTIM #1 related after the physical altercation ended, the DEFENDANT stated "I'll kill you. I'll put a bullet in your head." VICTIM #1 related the DEFENDANT threatened to kill everyone in the house. Occupants of the house at the time of these threats were later identified as Phillip J. MARGERA Jr (VICTIM #2), Jessica DIETZLER (VICTIM #3), and Michelle JABLONSKI (VICTIM #4). Photos were taken of VICTIM #1 injuries. VICTIM #1 provided a written statement of the incident.

Based on the information set forth above, your Affiant respectfully requests the DEFENDANT be made to answer to the above charges.
