### **SUMMARY OF ARGUMENT**

On January 5, 2023, the Commonwealth Court entered an order denying Appellant's Nunc Pro Tunc Petition to Intervene ("Petition") on the grounds that it had previously directed that Applications to Intervene be filed by December 12, 2022, at 3:00 p.m., and that Appellant's Petition was filed after that date and time with no allegations that would warrant *nunc pro tunc* relief, and, in any event, that it failed to establish a basis for intervention. Appellant timely appealed, raising several challenges to the January 5, 2023 order. Intervenor Senator Jay Costa takes no position with respect to Appellant's issues, and, accordingly, requests that this Honorable Court enter an order as it deems just and proper.

#### **ARGUMENT**

This matter arises initially from District Attorney Larry Krasner's December 2, 2022 Petition for Review in the Commonwealth Court, which sought a declaration that extant impeachment proceedings against him were unconstitutional. On December 6, 2022, the court entered a case management order directing, *inter alia*, that:

Applications for Leave to Intervene, complete with proposed filings and a memorandum of law in support thereof (3 copies), shall be filed and served no later than December 12, 2022, 3:03 p.m.

Order, 12/6/22, at 1-2. The petition for review was litigated, and, on December 30, 2022, the Commonwealth Court entered an order declaring that the proceedings were unconstitutional. *See generally* Order, 12/30/6.

On January 3, 2023, Appellant filed a Nunc Pro Tunc Petition to Intervene ("Petition"), seeking intervention. *See generally* Petition, 1/3/23. On January 5, 2023, the Commonwealth Court entered and order denying the Petition on the grounds that it had previously directed that applications to intervene be filed by December 12, 2022, at 3:00 p.m., and that Appellant's Petition was filed after that date and time with no allegations that would warrant *nunc pro tunc* relief, and in any event, that the Petition failed to establish a basis for intervention. *See* Order, 1/5/23, at 1-2.

Appellant appealed to this Honorable Court, and now raises several issues related to the Commonwealth Court's denial of his Petition.

Intervenor Senator Jay Costa takes no position with respect to Appellant's issues.

## **CONCLUSION**

Accordingly, in light of the foregoing, Senator Costa respectfully requests that this Honorable Court enter an order as it deems just and proper.
