FIRST PRE-TRIAL MEMORANDUM OF THE RESPONDENT, JUDGE MARK B. COHEN

The Respondent, Judge Mark B. Cohen, by his counsel, Samuel C. Stretton, Esquire, hereby submits his Pre-Trial Memorandum as follows:

A. TRIAL WITNESSES

- 2) The Respondent will agree to the stipulations of the Judicial Conduct Board except for No. 14(i). Judge Cohen is no longer on leave and is presently sitting on the Bench hearing cases.
- 3) In addition to the stipulations of the Judicial Conduct Board, Judge Cohen will present other recent examples of Facebook posts that he has made. See Exhibit "R-4".
- 4) The Judicial Conduct Board agrees that Judge Cohen has an excellent reputation of being a peaceful and law-abiding citizen and for his truthfulness and honesty.
