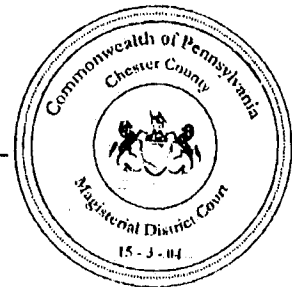

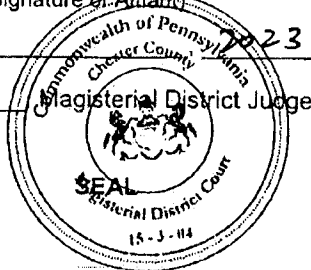

Notice To Defendant

A complaint has been filed charging you with the offense(s) set forth above and on the attached copy of the complaint.
