The District Attorney of Lebanon County by this Information charges that the Defendant did commit the following crimes on or between JANUARY 8, 2023 through JANUARY 13, 2023 at Building 17-104 Essayons Road, Keystone Conference Center and/or 7-5 Wiley Road, East Hanover Township, Lebanon County, Pennsylvania:

Count 1: **Interception, Disclosure of Use of Wire, Electronic or Oral Communication – (F3)**
18 § 5703 §§ 1 **\$15,000 – 7 years**

in that the Defendant did intentionally intercept, endeavor to intercept, or procure any other person to intercept or endeavor to intercept any wire, electronic or oral communication, *to wit/inter alia*, the Defendant did record oral communications of Fahad Pervez without his knowledge or consent.

Count 2: **Interception, Disclosure of Use of Wire, Electronic or Oral Communication – (F3)**
18 § 5703 §§ 2 **\$15,000 – 7 years**

in that the Defendant did intentionally disclose or endeavor to disclose to any other person the contents of any wire, electronic or oral communication, or evidence derived therefrom, knowing or having reason to know that the information was obtained through the interception of a wire, electronic or oral communication, *to wit/inter alia*, the Defendant did record oral communications of Fahad Pervez without his knowledge or consent and/or did disseminate portions of said oral communications to others.

Count 3: **False Reports to Law Enforcement Authorities – (M2)**
18 § 4906 §§ A **\$5,000 – 2 years**

in that the Defendant knowingly did give false information to a law enforcement officer with the intent to implicate another, *to wit/inter alia*, the Defendant did knowingly falsely report that Fahad Pervez had sexually assaulted her.
