CHIEF JUSTICE CASTILLE: Good afternoon, everyone. We would like to welcome everyone here for this ceremonial session for the retirement of one of our good friends, Lorraine Janicki.

Lorraine is in the audience today, as are many of your friends and co-workers that you worked with over the years. Zygmont Pines; Nikki DiPasquale; who else, Kathy Radwanski, I saw her earlier; Cathy Kelly, Valerie Kohler. We have Mr. Minner and Mr. Johns.

Who else is there? William Smith.

JUSTICE TODD: David Szewczak.

CHIEF JUSTICE CASTILLE: I see our executive administrator Gary Shovlin. We have in the audience our Chief Clerks, John Witherow, Peter Gardner, Irene Lambrou, Betsy Ceraso, Chuck Vohs, Donna Baker is filling in Kimberly Collins.

I would note the presence of John Person, and your sister, if I have a piece of paper — we'll get to that part later.

Now, if Lorraine, could you please step to the bar —

JUSTICE TODD: This is so much more pleasurable than a public censure.

MS. JANICKI: It doesn't feel like that to me.

CHIEF JUSTICE CASTILLE: This is both a happy occasion and a sad occasion.

It is a happy occasion because you are retiring and you are retiring at a very young age.

And after 32 years of service to the Citizens of Pennsylvania, in both the Superior Court and the Supreme Court, your retirement is certainly well deserved.

But for us it is a sad occasion because we are here losing a good and loyal employee. You were always a great worker and a person who has been totally dedicated to her work in the Superior Court and the Supreme Court.

You began in 1974 as a clerk stenographer with Chief Justice Benjamin Jones. Until 1978, when you resigned to attend Temple University full-time.

You earned your Bachelor of Arts Degree in Criminal Justice in 1981, graduating cum laude.

Not leaving well enough alone, you returned to the Superior Court as an Appellate Court Clerk and from 1986 to 1989 you served as the Chief Clerk of the Superior Court.

Our Court took you away from the drudgery of the Superior Court in 1989. And you have now served this Court for over 20 years as an Assistant to the Executive Administrator of our Court and Acting Executive Administrator of our Court.

Your service in the Supreme Court stands in administrations of six Chief Justices. You truly have been a friend of all of those Justices and all of this Court. Chief Justice Benjamin Jones, Chief Justice Robert Nix, Chief Justice John Flaherty, Chief Justice Stephen Zappala, Chief Justice Ralph Cappy and myself.

You might be able to pen quite a story given all your years of serving under those Chiefs with all those different styles and individual personalities and all the things that you've seen through those years.

But please wait until I am retired in Florida.

In the last year and a half since I've been the Chief Justice, since I've been honored as being the Chief Justice, my staff and I have worked closely with you. We have personally observed your dedication to your job, your outstanding work, and most importantly, your constant concern for the Supreme Court as an institution.

You might have thought some of us might be institutionalized, or should be institutionalized, but you have always had respect for the Supreme Court as an institution. And I have always admired your insistence in protecting the daily

operations, and be respected for what it does in the Judicial Branch, the Third Branch of our government.

Your friends and family are here today. Like many of us whose parents have passed, we are sorry that your parents could not be present on this occasion to share your accomplishments. They would be proud.

We wish you good health and a wonderful future in whatever you choose to do and the satisfaction of knowing that what you have done for our Courts you have done it well.
