Summary

This annual report is an overview of the various dockets and filings of the Supreme Court of Pennsylvania in 2024. Highlighted in this report are the following dockets or filings:


- ❖ Appeal Docket (Pages 4-7): This docket includes direct appeals filed to this Court and granted allocaturs. In 2024, the Court disposed of 202 appeals, an increase from 153 in 2023.
- Allocatur Docket (Pages 8-11): This docket concerns petitions seeking discretionary review of the decisions of the intermediate appellate courts. In 2024, the Court disposed of 1,457 allocaturs, an increase from 1,315 in 2023.
- ❖ Miscellaneous Docket (Pages 12-17): This docket includes original jurisdiction matters before this Court pursuant to 42 Pa.C.S. § 721, King's Bench review or applications for extraordinary jurisdiction, and petitions for review. In 2024, the Court disposed of 351 Miscellaneous Docket petitions, an increase from 281 in 2023.
- ❖ Ancillary Filings (Pages 18-19): Ancillary filings are petitions filed on an active docket seeking relief separate from the requested relief on the merits (e.g., an extension of time to file a brief). In 2024, the Court disposed of 2,417 ancillary petitions, an increase from 1,844 in 2023.
- ❖ Disciplinary Docket (Page 20): Includes disciplinary matters adjudicated by this Court.






Appeals Filed by District in 2024





Total Appeals Adjudicated Per Year






Comparison of Appeals Filed and Appeals Adjudicated Yearly







Total Allocaturs Filed by Year






Allocaturs Filed by District in 2024










Allocatur Dispositions in 2024





Comparison of Allocaturs Filed and Adjudicated



Total of Miscellaneous Docket Petitions Filed by Year


















Comparison of Miscellaneous Docket Petitions Filed and Adjudicated in 2024






Ancillary Filings by Docket in 2024








