**Whereas**, The Honorable Sandra Schultz Newman, a former Justice of the Supreme Court of Pennsylvania, is being recognized with the dedication of the Supreme Court courtroom in Philadelphia in her honor during an event, which will be held on September 9, 2025; and

**The perents**, A graduate of Drexel University, Ms. Newman earned a master's degree from Temple University and a Juris Doctor degree from the Villanova University School of Law. She served Montgomery County as Assistant District Attorney for two years and worked in private practice from 1972 to 1979. Ms. Newman then served as a Senior Parter with Astor, Weiss & Newman until 1993. She is lauded as the first woman to be elected as a Judge of the Commonwealth Court, a position she held from 1994 to 1995, and as a Justice of the Supreme Court of Pennsylvania, serving from 1996 to 2006. During her tenure, Ms. Newman heard a broad range of cases, certified numerous Third Circuit and United States Supreme Court cases and served on the Judicial Council and as the liaison to the First Judicial District; and

**Whereas**, An attorney for Cozen O'Connor from 2006 to 2008, Ms. Newman worked as an Arbitrator and Mediator for ADR Options, Inc., from 2008 to 2011 and has served in the same capacity with Newman ADR since 2012. The author of several publications, she has lectured at many law schools and has held numerous appointments over the years. Ms. Newman served the American Academy of Matrimonial Lawyers as a member of the Board of Managers from 1978 until 1994, and she has served the organization's Pennsylvania chapter as Treasurer, Secretary, Vice President and President. A Fellow of the International Academy of Matrimonial Lawyers and the American and Pennsylvania Bar Foundations, she is a member of the American Judicature Society, The American Law Institute, the National Association of Women Judges and the Philadelphia, Montgomery, Pennsylvania and American Bar Associations.

### Resolution Recognizing the Honorable Sandra Schultz Newman on the Occasion of the Dedication of the Madame Justice Sandra Schultz Newman Supreme Court Courtroom

Whereas, the Honorable Sandra Schultz Newman is worthy of honor and recognition for her distinguished service to the people of the Commonwealth of Pennsylvania, the Commonwealth Court of Pennsylvania, and the Supreme Court of Pennsylvania; and

Whereas, Justice Newman was admitted to the Pennsylvania Bar in 1972 and began her legal career in public service as an Assistant District Attorney in Montgomery County, making history as the first woman to hold that position in the County, and following her time in the District Attorney's Office, entered private practice, eventually becoming a senior partner with Astor, Weiss & Newman during a successful two-decade legal career; and

Whereas, a trailblazer for women, in 1993, Justice Newman was elected to the Commonwealth Court – becoming only the fifth woman to serve on the Court – and two years later, she ran successfully for the Supreme Court of Pennsylvania, becoming the first woman elected to the Commonwealth's highest court and only the third to serve as a Justice on that court; and

Whereas, dedicated to the importance of educating and creating opportunities for future generations of students entering the legal profession, Justice Newman helped found the Drexel University Thomas R. Kline School of Law; and

Whereas, Justice Newman retired from the bench in 2006, leaving a distinguished legacy which has become a guiding force and inspiration for young lawyers, especially women;

Now therefore, the Commonwealth Court of Pennsylvania recognizes Justice Newman for her extraordinary contributions to the Pennsylvania judicial system, thanks her for her unwavering devotion to public service, and congratulates her on the occasion of the dedication of Supreme Court's historic Philadelphia courtroom as the Madame Justice Sandra Schultz Newman Supreme Court Courtroom.
