She will further testify that after several minutes of conversation she was asked by Judge DiClaudio to leave the room such that the two judges could continue their conversation privately.

2. The Honorable Zachary Shaffer Judge, First Judicial District Court 327 City Hall Philadelphia, PA 19107

Judge Shaffer is expected to testify that on June 12, 2025, he and Ms.

Vernacchio met with Judge DiClaudio in his robing room to complete the purchase of several Shay's Steaks t-shirts. Following Ms. Vernacchio's departure, Judge DiClaudio showed Judge Shaffer a piece of paper with identifying information regarding an upcoming sentencing before Judge Shaffer, telling him "I've heard you might do the right thing anyway," before ripping this paper up and discarding it. Judge Shaffer is expected to further testify that he promptly reported this interaction to his superiors and recused from hearing the case at issue.
