SENTENCING ORDER

AND NOW, this 14th day of October, 2025, based on the plea as well as the information that's been provided here this morning as well as the videotapes and the negotiation, at Count 1, attempted murder, Defendant is sentenced to 17 to 34 years in state prison, a fine of \$25 plus costs.

Order no drugs, no alcohol, full-time employment. Order that he successfully attend and complete counselling and follow all recommended treatment concerning mental health, not to possess any firearms or other dangerous weapons nor may one be kept in the approved residence, make full restitution as ordered.

Order restitution at this point of \$100,000.

Must notify the assigned probation and parole

office of any change in address or employment within 72 hours of said change, must report as directed to meetings with the assigned probation and parole office. No contact, direct or indirect, with any of the named victims or the victims' families. Must pay on his fines and costs, receive an ORAS assessment and attend all recommended sessions. Must only reside at an approved residence.

Count 2, no further sentence.

Count 3, aggravated arson, Defendant is sentenced to 8 to 16 years in a state prison, a fine of \$50 plus costs running consecutive to Count 1.

Count 4, arson, Defendant is sentenced to 8 to 16 years concurrent with Count 3. No further fine or costs.

Count 5, arson, Defendant is sentenced to 8 to 16 years concurrent with Count 3.

Count 6, arson, 8 to 16 years concurrent with Count 3.

Count 7, arson, 8 to 16 years concurrent with Count 3.

Counts 8, 9, 10, and 11 will all be 8 to 16 years concurrent with Count 3.

Count 12 through Count 21 will all be 8 to 16 years concurrent with Count 3.

Count 22 through 25 will be 8 to 16 years concurrent with Count 3.

Count 26, burglary, will be 4 to 8 years concurrent with Count 3.

Count 27 will merge with Count 1 on the attempted murder on Governor Shapiro.

Count 28, recklessly endangering the First
Lady; Count 29, recklessly endangering Sophia Shapiro; Count
30, recklessly endangering a child at the age of 16; 31,
recklessly endangering a child listed at the age of 14; Count
32, recklessly endangering Adam Shapiro; Count 33, recklessly
endangering Rena Shapiro; Count 34, recklessly endangering a
victim age 16; Count 35, recklessly endangering a child
listed at age 14; Count 36, recklessly endangering a child
listed at age 10, all sentences will be 1 to 2 years
concurrent with Count 1.

Count 29 will be consecutive with Count 28.

Count 30 is consecutive with Count 29.

Count 31 is consecutive with Count 30.

Counts 32, 33, 34, and 35 and 36 will all be consecutive to Count 31, 32, 33, 34, 35.

Count 37, recklessly endangering Rebecca Steinburg, 1 to 2 years consecutive with Count 36.

Count 38, recklessly endangering John Steinberg, 1 to 2 years consecutive with Count 37.

Count 39, recklessly endangering a child age 16, 1 to 2 years consecutive with Count 38.

Count 40, recklessly endangering a child listed at the age of 13, 1 to 2 years consecutive with Count 39.

Count 41, recklessly endangering a child age 8, 1 to 2 years consecutive with Count 40.

Count 42, recklessly endangering Ilan Gordon, 1 to 2 years consecutive with Count 41.

Count 43, recklessly endangering Nissa Newman,

1 to 2 years consecutive with Count 42.

Count 44, recklessly endangering Cameron Sniderman, 1 to 2 years consecutive with Count 43.

Count 45, Victoria Kotlyar, 1 to 2 years consecutive with Count 44.

Count 46, recklessly endangering Brandon Bowman, 1 to 2 years consecutive with Count 45.

Count 47, recklessly endangering Trooper

Jessica Vybiral, 1 to 2 years consecutive with Count 46.

Count 48, recklessly endangering Trooper Kody Reichart, 1 to 2 years consecutive with Count 47.

Count 49, loitering and prowling at night, no further costs or sentence.

Counts 28 through 48 resulted in an aggregate sentence of 21 to 42 years of imprisonment concurrent to the aggregate sentence of 25 to 50 years.

Defendant is given time credit from April 14 to

today towards his sentence.
